To the Trustee and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Jacko Logistics, LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements (“financial statements”).

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 - Description of Plan

The following description of the Jacko Logistics, LLC 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan established January 1, 2018. The Plan covers eligible employees of Jacko Logistics, LLC (“the Company”). The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

Employees are eligible to participate in the Plan once they have completed 3 months of service and provided, they are at least 21 years of age.

Contributions

Participants may contribute up to 90% of their compensation (as defined in the Plan Document), subject to the maximum dollar amounts allowed by law. Contributions from participants can be either pre-tax contributions or Roth contributions. Unless an employee has voluntarily enrolled in the Plan or has declined to participate in the Plan, all newly eligible participants are automatically enrolled in the Plan, and contributions equal to 1% of their eligible compensation are withheld and contributed to the Plan as pre-tax contributions. Participants may elect to adjust, cease, or resume their contributions at any time.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollover contributions from other qualified plans”).

The Company may make discretionary matching or profit sharing contributions (“employer contributions”) to the Plan, subject to regulatory limitations. No employer contributions were made to the Plan for the year ended December 31, 2023.

Vesting

Participant contributions and related earnings are 100% vested at all times. Employer discretionary matching and profit sharing contributions and related earnings become 100% vested to the participant or the participant’s beneficiary upon death, disability or termination of the Plan. Otherwise, Company discretionary matching and profit sharing contributions and related net earnings become vested to the participant based on the following schedule of years of service:

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's matching and profit sharing discretionary contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants have full discretion to direct their proportionate share (vested and non-vested) of Plan assets to a variety of investment funds.

Benefit Payments

Upon termination of employment, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump-sum, partial or installment distributions. The Plan allows for in-service distributions if a participant reaches age 59 ½, as well as hardship distributions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's accounts and bear interest at a rate determined by the Plan administrator on the date of the loan. Loan terms cannot exceed five years, except for the purchase of a primary residence, and payments are required at least quarterly through payroll deductions. Each participant may not have more than one loan outstanding at any time. There are three loans outstanding as of December 31, 2023.

Forfeited Accounts

The use of forfeited nonvested accounts is based on the discretion of the Plan. Forfeited nonvested accounts may be used to reduce administrative expenses or used to reduce future employer contributions. At December 31, 2023 and 2022, there were no forfeitures included with net assets available for benefits to reduce future administrative expenses or employer discretionary matching contributions.

Plan Changes

The Company has the right to amend or terminate the Plan at any time. However, no such amendment or termination shall deprive any participant of any vested interest in the Plan. In the event of Plan termination, participants will become fully vested in their accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Discretionary match or profit sharing contributions from the Company are recorded in the period in which the related participant contributions are recorded.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

Administrative Expenses

The Plan provides that certain expenses of the Plan may be paid by the Plan or the Company. Certain expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2024, the date the audited financial statements were available to be issued.

Note 3 - Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be used to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodology used at December 31, 2023 and 2022.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Reported at fair value using the NAV, which is determined by the administrators of the funds and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the collective trust fund (primarily fully benefit responsive investment contracts), less any liabilities, and then divided by the number of units outstanding. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options, require 12 months advance written notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to these investments.

Accordingly, Reliance Trust Company, a qualified institution, has certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the statement of changes in net assets available for benefits for the year ended December 31, 2023, and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2023.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Tax Status

The Plan adopted a volume submitter plan developed by the volume submitted sponsor. Based in part on a favorable opinion letter received for the volume submitter plan dated October 6, 2020, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
