To the Administrative Committee of
The Farms 401(k) Plan, sponsored by Kelena Farms, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Farms 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Farms 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Farms 40(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE A – PLAN DESCRIPTION

The following brief description of The Farms 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan, established effective January 1, 2001, as a result of an amendment of *The Farms Profit-Sharing Plan (001)* effective January 1, 2000, is a defined contribution plan with a deferred option covering all defined eligible employees of Kelena Farms, Inc., Akea Farms, Inc., Central Oahu Farmers Association, Larry Jefts Farms LLC, SJ Farms, Inc., Sugarland Farms, Inc., Sugarland Growers, Inc., Pu'uloa Farms, Inc., and Waikele Farms, Inc. (Company), who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Currently, Kelena Farms, Inc. is the trustee and plan sponsor.

Contributions – Each year, eligible participants may contribute (Elective Deferrals) up to the lesser of 100% of their pretax annual defined compensation or the contribution limits set forth by the Internal Revenue Service. Participants who have attained age 50 by the end of the plan year are eligible to make catch-up contributions, subject to federal limits. The Company shall make matching contributions to the Plan out of its own funds equal to 100% of the Elective Deferrals up to the limit of not more than 4% of defined compensation and may elect to make an additional 2% (discretionary matching contributions) of defined compensation. The Company, in its sole discretion, may also make profit-sharing contributions. The Company's aggregate matching and profit-sharing contributions shall not exceed 25% of the defined compensation of all eligible participants for each plan year.

For the year 2024, the Company's 4% safe-harbor matching contributions totaled \$321,997. No discretionary matching or profit-sharing contributions will be made for plan year 2024.

Participant Accounts – Each participant's Elective Deferral and the 4% base matching account is credited with the respective contributions and allocations of Plan earnings or losses and charged with an allocation of administrative expenses, if any. The profit-sharing and discretionary matching contributions are maintained in separate accounts for each respective participant. These accounts include allocation of Plan earnings or losses, forfeitures attributable to these contribution amounts, and any allocated administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account(s).

NOTES TO FINANCIAL STATEMENTS

NOTE A – PLAN DESCRIPTION (CONTINUED)

Custodian - John Hancock Life Insurance Company (U.S.A.) (John Hancock) provides investment accounting and recordkeeping services and maintains custody of retirement assets.

Participant-Directed Investment Options – Participants may invest in one or more of the 34 John Hancock Sub-Accounts investment options offered by the Plan.

Related party transactions - The above investment activities and administrative expenses charged by the contract administration fees of \$15,886 and third-party administrator of \$1,800, are party-in-interest transactions for 2024. Each fund's net asset value per unit is also affected by John Hancock's administrative maintenance charges and sales and service fees. The Company pays directly other expenses related to the plan's operation as described in Note B.

Distribution of Benefits – In the event of a participant's retirement, death, disability, or other termination of service, a participant (or, in the event of the participant's death, the participant's beneficiary) will receive a lump-sum amount equal to the value of the participant's vested interest in his/her accounts.

Vesting – A participant is, at all times, fully vested in amounts credited to his/her Elective Deferral and safe-harbor matching contribution accounts. A participant's profit-sharing and discretionary matching accounts become fully vested upon his/her normal retirement, death, or permanent disability while still an employee. In all other circumstances, vesting in the Company profit-sharing and discretionary matching accounts is based on years of service, as defined. A participant is 100% vested after six years of credited service.

Loans – A Plan loan to any participant or beneficiary is not permitted.

NOTES TO FINANCIAL STATEMENTS

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation – John Hancock Sub-Account Funds (classified as pooled separate accounts) are carried at fair value, which is determined by multiplying the closing net asset value as adjusted (for administrative maintenance charges and other fees) per unit by the number of units held by the Plan at year end. A fund's net asset value is based on the number of shares of the respective underlying fund (series issued by John Hancock Funds II, John Hancock Investment Trust, or other mutual funds) multiplied by the closing asset value per share quoted by that fund.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. Net appreciation or depreciation of the fair value of investments includes the Plan's realized gains and losses from redemptions of sub-account fund investments as well as held during the year.

Forfeitures – When certain termination of a participant in the Plan occurs, the non-vested portion of a participant's accounts, as defined by the Plan, represents forfeitures. Forfeitures are used to (1) restore participants' accounts if the terminated participants are rehired and fulfill certain defined requirements, (2) reduce employer contributions (or allocate as employer contributions) or (3) to pay reasonable Plan expenses.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company, in its discretion, and are excluded from these financial statements.

Use of Estimates – The preparation of financial statements based on generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Benefits paid to participants - Benefit payments are recorded when paid.

NOTE C – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a single definition of fair value for accounting purposes, establishes a consistent framework for measuring fair value, and expands disclosure requirements about fair value measurements.

The fair value hierarchy gives the highest priority to quoted prices (unadjusted) in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

Investments measured and reported at fair value are classified and disclosed in one of the following levels defined by ASC 820:

- Level 1 – Fair value measurements that reflect unadjusted, quoted prices in active markets for identical assets and liabilities that can be accessed at the measurement date.
- Level 2 – Fair value measurements using inputs other than quoted prices included within Level 1 that are observable, either directly or indirectly.
- Level 3 – Fair value measurements using significant non-market observable inputs.

Based on the above definition, the pooled separate accounts (sub-account funds) have been classified as Level 1 investments, as fair values of the sub-account funds are based upon daily reported net asset values which represent the values at which the sub-accounts can be redeemed (readily determinable fair values).

NOTE D – PLAN TERMINATION

The Company has adopted the Plan with the expectation that it shall be continued indefinitely, but the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is partially or fully terminated, the affected participants shall be fully vested in their accounts.

NOTE E – FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated February 27, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Certain amendments and restatement to February 2010 have received a favorable determination by an IRS letter dated July 1, 2011. Other amendments are subject to IRS approval; however, the Plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE F – RISKS AND UNCERTAINTIES

The John Hancock Sub-Account Funds invest in a variety of investment securities that, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the *Statements of Net Assets Available for Benefits*.
