We have performed audits of the accompanying financial statements of Franklin Bookkeeping Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of Franklin Bookkeeping Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- (a) General – The Plan is a defined contribution plan covering all employees of Frankling Bookkeeping Services, Inc., and related companies (the “Company”) as determined by the provisions of the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees of the Company become eligible to participate in the Plan after completing three months of service. The custodian for the Plan is Reliance Trust Company (“Reliance”) and the recordkeeper for the Plan is ADP Retirement Services (“ADP”). The Plan Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings, and monitors investment performance.
- (b) Contributions – The Plan is funded through participant and company contributions. Participants may elect to defer up to eighty-eight percent (88%) of eligible compensation on a pretax basis up to the maximum amount allowed by IRS limitations each Plan year. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company will make discretionary matching contributions equal to one hundred percent (100%) of the participant contributions up to two percent (2%) of base compensation. The Company may make annual discretionary nonelective contributions in an amount to be determined at plan year end by the Board of Directors. The Company did not make any discretionary nonelective contributions for the year ended December 31, 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.
- (c) Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching contribution and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

- (d) Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of service as defined by the Plan as follows:

- (e) Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates that range from five-point two five percent (5.25%) to ten-point five percent (10.5%), which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.
- (f) Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account or installments over a certain period. The Plan also contains provisions for distributions in cases of hardship and early retirement.
- (g) Forfeited Accounts – The Plan provides that amounts credited to a participant’s account in which the participant does not have a vested interest will be forfeited to the Plan upon termination. These forfeitures, as defined by the Plan, are to be

used to pay plan expenses or to reduce future Company contributions. Forfeited non-vested accounts totaled \$12,141 and \$11,562 as of December 31, 2024 and 2023, respectively. Forfeitures used to reduce the Company's contributions totaled \$9,521 and \$8,740 for the years ended December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

- (a) Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.
- (b) Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (c) Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (d) Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
- (e) Excess Contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024

and 2023 excess contributions to the applicable participants in the subsequent year.

- (f) Payment of Benefits – Benefits are recorded when paid.

- (g) Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses while expenses for items such as recordkeeping are allocated to participants. Investment-related expenses are included in the net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB-ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measure at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Common Collective Trusts

The funds are valued at the net asset value based on the unit values of the underlying securities held by the Plan. The practical expedient would not be used if it is determined to be probable that the funds will sell the investments for amounts different from the reported net asset values. As of December 31, 2024 and 2023, there are no unfunded commitments related to these investments, and the investor may redeem these assets daily.

Note 5 – Income Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated October 6, 2020, stating that the Plan is qualified under the Internal Revenue Code (“IRC”) and therefore the related trust is exempt from taxation. The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s returns remain open for three (3) years for federal examination.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent (100%) vested in employer contributions.

Note 7 – Mutual Fund Fees

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12B-1 fees. 12B-1 fees are ongoing fees allowable under Section 12B-1 of the Investment Company Act of 1940. These annual fees are used to pay for the marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan’s investment earnings activity, and thus not separately identifiable as an expense.

Note 8 – Related Party and Party-In-Interest Transactions

The Plan's investments are managed by Reliance Trust Company. Reliance Trust Company is a qualified institution as defined by ERISA for the Plan and therefore transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Fees paid to ADP Retirement Services for various administrative services totaled \$5,166 and \$6,654, fees paid to other service providers totaled zero and \$7,500, for the year ended December 31, 2024 and 2023 respectively, which are included in the statement of changes in net assets available for benefits.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits. Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 and 2023 may not necessarily be indicative amounts that could be realized in a current market exchange.

Note 10 – Information Prepared and Certified by the Qualified Institution

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
