INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
B & M Precision, Inc., formerly known as B&M Precision, Inc. 401(k) & Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of B & M Precision, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at Year-End) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF PLAN

The following description of B & M Precision, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan and trust covering all full-time employees who have one year of service, at least 1,000 hours of service beginning on the date of hire or any plan year beginning after date of hire and are age eighteen years or older. The investment committee oversees governance of the Plan’s investments, monitors investment performance, and reports to the Plan’s Board of Trustees. The Plan was amended as of January 1, 2023 and changed its name from B&M Precision, Inc. 401(k) & Profit Sharing Plan to B & M Precision, Inc.

2. Contributions

Each year, participants may elect to defer a percentage of their compensation instead of receiving that amount in cash. The Plan has an automatic deferral feature. If participants do not specifically elect an alternative deferral amount (including zero), the employer will automatically withhold 3% of the employee’s compensation. The total deferrals may not exceed the maximum allowed by Internal Revenue Service limits. In addition, participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common/collective trusts, and an insurance investment contract as investment options for participants.

The Plan sponsor, B&M Precision, Inc. (the “Company”), may make a discretionary matching contribution equal to a uniformed percentage of participant salary deferrals. The Company match is limited to 6% of the participant’s compensation. In order to qualify for the Company match, the participant must be employed on the last day of the Plan year, in addition to the other Plan entry requirements. The matching contributions are invested in funds directly by the eligible participants in the Plan. Additional discretionary profit-sharing amounts may be contributed at the option of the Company’s board of directors which are also invested in funds as directed by the participants of the Plan.

3. Participant Accounts

The participant accounts are participant directed investment options. The participants are allowed to change the percentage contributed to the Plan through payroll deductions on a weekly basis. Participants can also move individual accounts from one investment fund to another or change how the funds are allocated among investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A - DESCRIPTION OF PLAN - Continued

Each participant in the Plan has a separate account that is credited with the annual allocation of (a) the Company's contributions, (b) the employee's elective contributions, (c) the Plan's earnings or losses, and (d) forfeitures, if any. Allocations are based on the prorated earnings of the employee compared to the total earnings of all participants.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portions of their accounts is based on years of continuous service. Participants in the Plan vest in employer contributions at a rate of 20% annually after 2 years. A participant is 100% vested after six years of credited service. One hundred percent vesting occurs, regardless of the number of years of service, when a participant reaches normal retirement age (65), dies, becomes totally and permanently disabled, or upon termination of the Plan.

5. Payment of Benefits

On termination of service due to disability, retirement, or passing, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments over a period of time not more than the participant's (or beneficiary's) assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, or through installments over a period of time not more than the participant's assumed life expectancy. If the participant's vested account balance is less than \$5,000, then a lump sum distribution is required.

6. Forfeitures

Forfeitures of non-elective and matching contributions are used to reduce employer contributions or pay administrative expenses. Forfeited non-vested accounts totaled approximately \$135,670 and \$123,284 at December 31, 2024 and 2023, respectively. No forfeitures were used to pay administrative expenses during the year ended December 31, 2024. Forfeitures of \$182,000 were used to reduce the Company's contributions during the year ended December 31, 2024.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants become 100% vested in their accounts in the event of Plan termination.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. Investment Valuation

Investments are stated at fair value as follows:

- Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to provide their daily net asset value ("NAV") (fair value) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common collective trusts are valued at the net asset value of the specific financial instruments using the practical expedient method. Purchases and sales of securities are recorded on a trade-date basis.
- Fixed annuity contracts are valued daily based on the valuation method disclosed in the annuity content, as calculated by the annuity provider.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

4. Benefit Payments

Benefits are recorded when paid.

5. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE C - INVESTMENTS

The Plan's investments consist of mutual funds, common collective trusts, and an insurance investment contract that is held by a trust company at December 31, 2024 and 2023. The value of these investments was \$22,473,026 and \$19,320,840 at December 31, 2024 and 2023, respectively.

The net appreciation or depreciation includes realized and unrealized gains and losses on investments that were bought and sold during the respective year. The net appreciation in fair value of the investment accounts were \$2,006,247 for the year ended December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*, establishes a framework for using fair value to measure assets and liabilities and defines fair value as the price that would be received to sell an asset or paid to transfer a liability (an exit price) as opposed to the price that would be paid to acquire the asset or received to assume the liability (an entry price).

Under FASB ASC 820, a fair value measure should reflect the assumptions that market participants would use in pricing the asset or liability, including the assumptions about the risk inherent in a particular valuation technique, the effect of a restriction on the sale or use of an asset and the risk of nonperformance.

FASB ASC 820 requires disclosures that stratify the statement of net assets available for benefits amounts measured at fair value based on inputs the Plan used to derive fair value measurements. These strata include:

- Level 1 inputs, where the valuation is based on quoted market prices for identical assets or liabilities traded in active markets (which include exchanges and over-the-counter markets with sufficient volume),

- Level 2 inputs, where the valuation is based on quoted market prices for similar instruments traded in active markets, quoted prices for identical or similar instruments in markets that are not active and model-based valuation techniques for which all significant assumptions are observable in the market, and
- Level 3 inputs, where the valuation is generated from model-based techniques that use significant assumptions not observable in the market, but observable based on fund-specific data. These unobservable assumptions reflect estimates or assumptions that market participants would use in pricing the asset or liability. Valuation techniques typically include option pricing models, discounted cash flow models and similar techniques, but may also include the use of market prices of assets or liabilities that are not directly comparable to the subject asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques that are used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the net asset value of shares held by the Plan at year end investments in certain restricted mutual funds are valued at quoted market prices of the issuer. (Level 1)

Common/collective trust: Valued by the issuer of the common/collective trust fund based on the net asset value per share of the underlying investments. Common/collective trust funds with underlying investments in investment contracts are valued at net asset value of the underlying investments using the practical expedient method and are not leveled in the fair value hierarchy.

NOTE E - FIXED ANNUITY CONTRACTS

The Plan has an insurance contract with Reliance Trust Company as of and for the years ended December 31, 2024 and 2023. Reliance Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed insurance contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023, was \$2,867,731 and \$2,810,344, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed monthly for resetting on a quarterly basis.

Certain events limit the Plan's ability to transact at contract value with Reliance Trust Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition in competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed insurance contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

Record keeping fees and investment management fees amounted to \$50,072 and \$35,215 for the year ended December 31, 2024, respectively.

NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

NOTE H - ADMINISTRATION OF PLAN ASSETS

The investments of the Plan are held and administered by Reliance Trust Company as of and for the years ended December 31, 2024 and 2023. As Plan trustee, Reliance Trust Company invests cash received, interest and dividend income, and makes distributions to participants. Officers or employees of the Company also perform administrative functions; however, no officer or employee received compensation from the Plan.

NOTE I - FINANCIAL DATA CERTIFIED BY THE TRUSTEE (UNAUDITED)

Reliance Trust Company has certified the Plan's investments, and the investment income and losses as being complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Some Plan participants have terminated employment with the Company but had vested balances in the Plan at December 31, 2024 and 2023. There were no amounts allocated to accounts that have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.
