NOTE 1 - DESCRIPTION OF THE PLAN

The Office and Professional Employees Welfare Fund (the "Plan") was organized in 1956 as a result of collective bargaining agreements between the Office and Professional Employees, Local 29 and various employers to provide welfare benefits for eligible employees and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Initial eligibility for Plan benefits occurs as of the first day of the month following the month in which the employee completes the hours required under the collective bargaining agreement to have a contribution made on his/her behalf and the employer makes the required monthly contribution. A contribution by the employer for hours worked in any given month provides coverage for the following calendar month.

The Plan provides medical benefits with independent insurance carriers and health maintenance organizations (HMOs). The Plan also provides for life, accidental death and dismemberment, accident and sickness, vision, and dental coverage for eligible members.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Plan.

THE PLAN DOCUMENTS, INCLUDING CONTRACTS WITH INSURANCE COMPANIES AND HMOs, INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN DOCUMENTS AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Contributions

Employer contributions as reported are contributions made for hours worked during the year. Employer contributions receivable are estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

Participant contributions which vary according to the levels of participation elected and dependent status are accounted for and reported in accordance with the rules of the Plan.

D. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of the employers' payroll records. The Plan's system of internal control provides for examination of employers' records under a separate payroll compliance program.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

E. Investment Valuation

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 2 investments consist of certificates of deposit with maturity dates greater than 6 months that are valued at cost which approximates fair value.

The following tables summarize the Plan’s investments in the fair value hierarchy at December 31 based on the inputs used to value them:

F. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Plan Termination

The Plan may be terminated only by joint agreement between the trustees representing both employers and the union, subject to the provisions of ERISA. In the event of termination of the Plan, the trust agreement requires that the trustees, after providing for all liabilities, shall use the balance of the Plan’s assets, if any, to provide continuing benefits. However, neither the Plan nor the trustees individually, have any obligation to continue benefits if there are insufficient funds to do so.

NOTE 3 - CONCENTRATION OF CREDIT RISK

During the years ended December 31, 2024 and 2023, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limits was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 4 - POSTRETIREMENT BENEFIT OBLIGATIONS

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to certain participants' service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) certain currently retired or terminated participants and their beneficiaries and dependents, and (2) certain active participants and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

There is no requirement for the Plan to fund this obligation. The only requirement is for the Plan to compute the obligation and disclose this amount in the financial statements.

The actuarial present value of the expected postretirement benefit obligation as of December 31, 2024 and 2023 was determined by the Plan's actuary. The amount that results from applying actuarial assumptions to historical health cost data to estimate future annual incurred health costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and probability of payment (by means of decrements such as those for death, disability, withdrawals, or retirement) between the valuation date and the expected date of payment.

The following are significant assumptions used in the valuations as of December 31, 2024:

Interest	5.5% per annum
Retirement Rates	Assumed retirement of 5% at 55 years old, scaling up to 100% at 67 years old.
Mortality	The PRI-2012 Private Retirement Mortality Tables with Blue Collar adjustment. Projected fully generationally using Scale MP-2021.
Expenses	Included in assumed cost of benefits.

Changes in actuarial assumptions from December 31, 2023 to December 31, 2024 were as follows: (a) Interest rate decreased from 6.00% to 5.50% per annum, (b) expenses changed from 5% of liability to being included in the assumed cost of benefit, (c) mortality, disability and termination assumptions were updated to match assumptions used for plans of similar sizes.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

A 1% increase in health care cost trend for each future year will increase the postretirement benefit obligation by \$16,802 and \$27,021 as of December 31, 2024 and 2023, respectively.
