INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants
Brehob Corporation
Employees' Profit Sharing and Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 PLAN DESCRIPTION

The following description of the Brehob Corporation Employees' Profit Sharing and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to provide for the retirement of Brehob Corporation (the "Company") employees. The Plan is a defined contribution plan. The Plan entrance dates are January 1, April 1, July 1, and October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees covered under the Plan are eligible to participate when they reach age eighteen and have completed six consecutive months of service (at least 500 hours). Employees are eligible to receive matching contributions after completing six consecutive months of service (at least 500 hours). Employees are eligible to receive profit sharing contributions after completing one year of service (at least 1,000 hours) and reaching the age eighteen. Additionally, to be eligible to receive matching and profit sharing contributions the participants are required to be employed by the plan sponsor on the last day of the plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contribution, allocations of investment earnings and allocations of the administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant-directed.

Vesting

A participant is 100% vested in the value of his or her accumulated voluntary contributions at all times. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Contributions

Participants may elect to contribute to the Plan subject to limits imposed by Federal tax law. If no election or opt out is made, participants are enrolled via the automatic enrollment provision at 3% of eligible earnings. The plan also has an automatic increase provision which will increase the participant's deferral rate by 1% annually until the participant reaches the maximum rate of 5%. The maximum deferral amount under the Plan is the lesser of 100% of a participant's eligible compensation or statutory deferral limits. The Company's matching contribution is 25% of the participant's elective deferrals, limited to \$500. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and stable value funds as investment options for participants. In addition, the Company, at its discretion, may make a profit sharing contribution. Company contributions are subject to certain conditions. The Company may also at its discretion make qualified matching contributions and qualified nonelective (profit sharing) contributions.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, or other reasons the participant may receive a lump sum distribution as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable. Participants may request a hardship withdrawal of a portion of their vested account balance. Any hardship withdrawal is limited to the amount necessary to meet the financial need.

As of December 31, 2024 and 2023, there were no suspended account balances that had not been paid.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts total \$48,644 and \$16,120, respectively. These accounts will be used to pay for Plan expenses, investment fees, and reduce future Company contributions. Plan expenses for 2024 and 2023 of \$0 has been paid using forfeited nonvested account balances. The Company applied \$0 and \$95,000 of forfeitures to reduce employer contributions during the years ending December 31, 2024 and 2023, respectively.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Concentration of Credit Risk

The Plan invests primarily in mutual funds, collective investment funds or stable value funds. Mutual funds consist of equity, fixed income, and cash equivalent investments. Mutual fund investments are not insured. Valuations of mutual funds with equity and fixed income securities are affected by market fluctuations in the underlying stocks and bonds in which the fund managers have invested.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. The Plan's interest in stable value funds is valued based on information reported by the investment advisor and the available financial statements of the fund at year-end.

Security transactions are accounted for on the date securities are purchased or sold (trade date). Dividend income is recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Capital gain distributions are included in dividend income. Net appreciation and depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year and the realized gain or loss on investments sold during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassification

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform with the presentation in the current year financial statement.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds : Valued at the net asset value ("NAV") of share held by the Plan at year end.

Collective investment and stable value funds : Valued based on the fair value of the underlying investments comprising the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTIES IN INTEREST

There were no known prohibited transactions with known parties in interest as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in ERISA Sections 406 and 407(a) and Internal Revenue Code Section 4975(c).

Certain Plan investments are shares of mutual funds and units of stable value funds. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

NOTE 6 INCOME TAX STATUS

The Company adopted a Volume Submitter Profit Sharing Plan, sponsored by Transamerica Retirement Solutions Corporation, with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020. The plan document has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 7 PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right, by action of its Directors, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, amounts credited to participants' accounts will become fully vested and nonforfeitable.

NOTE 8 RECONCILIATION OF FINANCIAL STATEMENT TO FORM 5500

There were no reconciling items between the financial statements and Form 5500.
