We have performed audits of the financial statements of R and R Express 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Plan Merger***

As further discussed in Note 1 to the financial statements, on May 1, 2024, the RFX, LLC 401(k) Plan was merged into the Plan. Total assets transferred as a result of the merger were \$641,363. Our opinion is not modified with respect to this matter.

### 1. Plan Description

The following description of the R and R Express Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a participant-directed defined contribution plan covering substantially all non-union employees of R&R Express Holdco, Inc. and the following subsidiaries: R&R Express, Inc.; GT Worldwide Logistics LLC; Paradigm Transportation Management Group LLC; Final Mile Solutions Group LLC; RXG&A LLC; R&R Express Logistics, Inc.; R&R Drivers Solutions Inc; TLogistics, LLC; Border Connect Logistics, Inc; One Stop Freightway, LLC and Load to Ride Transportation, LLC; and New Taylor Transportation, LLC (collectively, the Company or Plan Sponsor). Effective January 1, 2024, RFX, LLC and Pioneer Transfer, LLC were added as participating employers in the Plan, respectively. The Company is the plan administrator that controls and manages the operation and administration of the Plan. Principal Trust Company (Principal), the custodian, holds the plan investments and participant loans.

A non-union employee becomes eligible to participate in the Plan after 30 days of service, and the Plan includes an automatic enrollment policy for all newly eligible employees. Under this policy, if an employee does not submit a waiver, the employee is automatically enrolled in the Plan at a 3% deferral rate.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Entry dates are the first day of each month during the year.

Effective May 1, 2024, the RFX, LLC 401(k) Plan was merged into the plan. Net assets totaling \$641,363 were transferred into the Plan as a result of the merger.

#### *Contributions*

Participants may contribute up to 100% of their annual eligible compensation to the Plan, subject to certain Internal Revenue Code (IRC) limitations.

In any calendar year in which a participant is age 50 or older, an additional "catch-up contribution" (limited to \$7,500 in 2024) may be made. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make a discretionary contribution to the Plan. There were no discretionary contributions to the Plan during 2024.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant vests ratably over six years of credited service. Participants automatically become fully vested with respect to employer contributions upon attaining age 65, death, or permanent disability.

### ***Benefits***

Upon termination of service due to death, disability, retirement, or age 59½, a participant's vested benefit is to be distributed in a manner, as defined in the Plan document, chosen by the participant or beneficiary. If a participant's account balance is less than or equal to \$5,000 at the time of termination, the participant or beneficiary will automatically receive a lump-sum payment.

At December 31, 2024, there were no significant amounts allocated to accounts of individuals who have withdrawn from the Plan but have not been paid.

### ***Notes Receivable from Participants***

Participants may borrow up to the lesser of 50% of their individual vested account balance or \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 months. The minimum amount a participant may borrow is \$1,000. A participant may not have more than two loans outstanding at any time. Loan repayment terms may not exceed 60 months unless the loan is granted for the purpose of acquiring the participant's principal residence. In such instances, repayment can be over a reasonable time period that may not exceed 120 months. The loans are collateralized by the vested interest in the participant's accounts and bear interest at a rate commensurate with local market rates for similar loans. Participant loans currently bear interest varying from 8.25% to 10.50%.

### ***Forfeitures***

Forfeited balances of terminated participants' nonvested accounts may be used to reduce plan expenses or used to reduce the Company's contributions to the Plan. There were no forfeited balances during the year ended December 31, 2024.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are maintained on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

*Level 1* - This level consists of quoted prices in active markets for identical assets or liabilities.

*Level 2* - This level consists of observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* - This level consists of inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds* - Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year-end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

*Collective Investment Trusts (CITs)* - CITs invest in domestic and international equity securities, fixed-income investments, and/or cash equivalents. The NAV of the CITs is calculated in a manner consistent with GAAP for investment companies and represents the price at which the Plan would be able to initiate a transaction. The fair value of the underlying funds and securities is used to determine the NAV of the CITs. The CITs are classified within Level 2 of the fair value hierarchy.

*Pooled Separate Accounts* - Pooled separate accounts consist of various investment options (i.e., domestic stock, mutual funds, and real estate securities). The fair value of the underlying funds and securities is used to determine the NAV. While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted. The pooled separate accounts are classified within Level 2 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Risks and Uncertainties***

The Plan's investments are exposed to various risks and uncertainties, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Investment Management Fees and Operating Expenses***

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair values of investments.

### ***Administrative Expenses***

Administrative expenses are paid by the Company or the Plan, as provided by the Plan document.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Consideration of Subsequent Events***

The Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025, the day the financial statements were approved and authorized for issue.

### 4. Guaranteed Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract (GIC) with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The GIC does not have specific underlying assets assigned, thus is considered a traditional investment contract. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The GIC is included in the financial statements at contract value. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The GIC does have a surrender charge of 10% that may be charged if the Plan terminates its interest in the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer. The crediting rate is currently reset on a semi-annual basis and will not be less than the guaranteed minimum interest rate. In no case will the guaranteed minimum interest rate be less than 1% or greater than 3%.

Certain events limit the ability of the Plan to transact at contract value with Principal Life Insurance Company. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's

prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The GIC does not permit Principal Life Insurance Company to terminate the agreement prior to the scheduled maturity dates without additional termination charges.

### 5. Certification of Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and Principal Life Insurance Company (Principal Life), qualified institutions.

### 6. Related Parties and Exempt Party-in-interest Transactions

Certain Plan assets are managed by the custodian. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for custodian and recordkeeping services were not significant for the year ended December 31, 2024.

The Plan has notes receivable from participants subject to specific guidelines as defined in the Plan document (Note 1).

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

### 7. Tax Status

The Plan Sponsor has adopted a prototype plan of Principal Life. Principal Life obtained a letter dated June 30, 2020, in which the IRS stated its opinion that the form of the prototype plan of Principal Life Insurance Company is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has since been amended. The Plan administrator and the trustee believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
