INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Penrith Home Loans LLC 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Basis of Accounting

As described in Note 1 to the financial statements, the Trustee of the Plan approved the termination of the Plan effective March 31, 2024. In accordance with accounting principles generally accepted in the United States, the Plan has changed its basis of accounting used to determine the amounts at which assets and liabilities are stated, from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

Supplemental Information Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Penrith Home Loans LLC 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General and Plan Termination

The Plan is a defined contribution Plan established on January 1, 2000. The Plan covers eligible employees of Penrith Home Loans LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Trustee of the Plan approved the termination of the Plan effective March 31, 2024. Upon the decision to terminate the Plan, unvested balances of all participants became 100% vested. Additionally, contributions to the Plan ceased and no new participants were allowed into the Plan after the effective termination date. The distribution of all account balances to participants is in the process of being completed.

Eligibility

Prior to the effective date of the termination of the Plan, employees are eligible to participate in the Plan upon hire, provided they are at least 18 years old. To be eligible for employer contributions, employees must be at least 18 years of age and complete one year of service.

Contributions

Prior to the effective date of the termination of the Plan, participants could make deferrals (pre-tax or Roth) up to 65% of eligible compensation, subject to the applicable limits of the Internal Revenue Code (IRC). Participants could also contribute amounts representing distributions from other qualified plans (rollovers from other qualified plans). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Prior to the effective date of the termination of the Plan, the Company may, at its discretion, elect to make matching contributions equal to 50% of the participant's contributions up to 6% of eligible compensation, subject to statutory limitations. The Company also makes safe harbor matching contributions equal to 3% of each participant's eligible compensation. In addition, the Company may make other discretionary contributions. No other discretionary contributions were made by the Company for 2024.

Vesting

Participants are immediately vested in their own contributions and the safe harbor matching contributions, plus actual earnings thereon. Prior to the decision to terminate the Plan, vesting in the Company matching and discretionary contributions, plus actual earnings thereon, was based on years of credited service. A participant ratably vested 100% over five years of credited service. A participant was fully vested upon reaching normal retirement age, death, or permanent disability.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, and Plan earnings or losses, and is charged an allocation of administrative expenses. Allocations are based on participant compensation, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investments of both their contributions and their allocation of employer contributions into various investment options offered by the Plan.

Notes Receivable from Participants

Prior to the effective date of the termination of the Plan, Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. There were no notes receivable outstanding at December 31, 2024.

Benefit Payments

Upon retirement, death, disability or other termination of service, a participant or beneficiary may elect to receive an amount equal to his or her vested balance in a lump-sum payment, as described in the Plan document. Under certain hardship circumstances or attainment of age 59½, a participant may receive the value of his or her vested account balance as a lump-sum distribution during their employment at the Company.

Forfeited Accounts

Upon termination of service, participant's non-vested account balances are forfeited. Forfeitures are first used to reduce future Company contributions and are then used to reduce administrative expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 were zero and \$3,442, respectively. Forfeitures for 2024 amounted to zero and \$3,504 of forfeitures were used to reduce Company contributions and administrative expenses.

Administrative Expenses

The Plan provides that certain expenses of the Plan may be paid by the Plan or the Company. Certain administrative expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balance, and the amounts reported in the financial statements.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting and Payment of Benefits

As the decision to terminate the Plan was made, the liquidation basis of accounting was used for the preparation of the financial statements for the year ended December 31, 2024. The financial statements are prepared on the accrual basis of accounting as of December 31, 2023. Based on the nature of the Plan's assets and liabilities, there was no significant difference in these account bases.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Matching and safe harbor contributions from the Company are recorded in the period in which the related participant contributions or compensation, respectively, are recorded.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value (see below). Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments consists of both realized gains and losses and unrealized appreciation and depreciation of those investments.

Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical asset or liabilities;
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly;
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for investments at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: The collective trust fund is valued daily at the NAV. The NAV is determined by the administrator of the fund and is used as a practical expedient to estimate the fair value of the units held by the Plan. The NAV is based on the fair value of the underlying investments (primarily investment contracts and cash equivalents), less any liabilities, and then divided by the number of units outstanding. The objective of the collective trust fund is to preserve principal while maximizing current income over the short-term. The fund has no restrictions and no unfunded commitments.

The following tables present information about the Plan's assets that have been measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the classification by level of input within the fair value hierarchy described above:

Note 3 – Tax Status

The Plan has received a favorable determination letter from the IRS dated May 22, 2013, stating that the Plan is qualified under Section 401(a) of the IRC and therefore entitled to favorable tax treatment. Although the Plan has been amended since receiving the determination letter, the Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank (CSB), a qualified institution, has certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5 – Party-In-Interest Transactions

Charles Schwab served as the trustee during the years ended December 31, 2024 and 2023, and also manages some of the funds in which the Plan invests. As a result, transactions involving Charles Schwab qualify as party-in-interest transactions.

Note 6 – Non-Exempt Prohibited Transactions

During the plan year ended December 31, 2024, the Company did not remit certain employee contributions to the Plan within the time frame required by the Department of Labor's regulations. Employee contributions totaling \$1,616 relating to one payroll were remitted to the Plan late. In addition, employee contributions totaling \$4,388 were withheld from employees' paychecks but had not yet been remitted to the Plan as of year end. These amounts represent nonexempt prohibited transactions under ERISA. The Company has not corrected these late remittances under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) and, accordingly, these amounts are reported in the supplemental schedule as delinquent participant contributions.
