Report of Independent Auditors

To the Board of Trustees The Adena Corporation 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of the Adena Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets as of December 31, 2024 and 2023, and the related statement of changes in net assets for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Adena Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Adena Corporation 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Other Matter- Change in Plan Custodian

As described in Note 11 to the financial statements, effective November 4, 2024, the Plan changed its custodian. For the period from January 1, 2024 through November 3, 2024, investments were held by Empower Trust Company, LLC, and for the period from November 4, 2024 through December 31, 2024, investments were held by Fidelity Management Trust Company. Management has obtained certifications from each qualified institution for their respective periods, stating that the certified investment information is complete and accurate. Our audits include procedures performed on the certified investment information provided by both custodians for the periods during which they served as custodian. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Adena Corporation 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Adena Corporation (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, available at their employer's office, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who meet the hour and age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants are able to contribute to the Plan during each plan year a percentage of their compensation, not to exceed \$23,000 and \$22,500 for 2024 and 2023, respectively (\$30,500 and \$30,000 and for employees age 50 or older). The Company has elected to match contributions made by participants by 100% up to 4% of total compensation. Other contributions made to the Plan are employer prevailing wage contributions. Prevailing wage contributions are based on hourly prevailing wages paid to participants for projects which require prevailing wage compensation structure.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of any employer contribution and Plan earnings and losses and charged with an allocation of administrative expenses.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Safe Harbor contributions and earnings thereon are 100% vested immediately. Vesting in the Company's discretionary matching or profit sharing contribution portion of their accounts, plus actual earnings, is based on continuous years of service according to the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. Loans are accounted for at cost, which approximates market value.

Forfeitures

Forfeitures of terminated participant's non-vested accounts are used to restore previously forfeited account balances and then pay administrative expenses of the Plan. Any remaining forfeitures are used to reduce the employer matching contribution. At December 31, 2024 and 2023, unused forfeited nonvested accounts totaled \$0 and \$1,338, respectively.

Note 1. Description of Plan (Continued)

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investments

The Plan investments are held in a Trust fund invested in mutual funds managed by Everhart Financial Group Inc. The Plan provides for participant directed investments up to the extent of allocated account balances. Fair market values of investments as determined by the Custodian are presented in Note 4.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan issues its financial statements on the accrual basis of accounting.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses charged by service providers for providing certain accounting and investment services are paid by the plan participants. The Company pays for the Plan audit fees.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Annuity Contracts

The MetLife annuities are life insurance annuities valued using the Net Asset Value (NAV) provided by the underlying mutual funds of the contract less the surrender charge of the policy and the related surrender charge fees. The NAV of the underlying mutual funds is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is quoted in an active market. Prudential Annuity Contracts are recorded at contract value.

Note 3. Information Certified by Custodian

The following table is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements that was prepared by the Custodian and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Custodian that such information is complete and accurate:

Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10 are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the new asset value (“NAV”) of shares held by the plan at year end, which equals fair value.

Collective trust funds: Valued at the new asset value (“NAV”) of shares held by the plan at year end, which is used as a practical expedient, and therefore not considered a level 1, 2, or 3 asset.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Reclassifications

Certain minor reclassifications were made to 2023 to conform to the 2024 presentation.

Note 11. Change in Plan Custodian

Effective November 4, 2024, the Plan changed custodian's. The transition was completed on that date, and all Plan assets were transferred from the former custodian to the new custodian at fair value. The total amount of assets transferred was \$29,018,640.

Both the former and new custodians are qualified institutions under Department of Labor regulations and provided certifications of the completeness and accuracy of the investment information for their respective periods of service during the year ended December 31, 2024. The Plan's operations, controls, and reporting were not materially affected by the change in custodian.

There were no related party or party-in-interest transactions associated with the change in custodian, other than the transfer of Plan assets as described above. There are no differences between the amounts reported in these financial statements and those reported on Form 5500 as a result of the custodian change.

Note 12. Subsequent Events

Events subsequent to December 31, 2024 have been evaluated through October 14, 2025, the date these financial statements were available to be issued, to determine whether additional disclosures should be made to keep the financial statements from being misleading. Management found no subsequent events that should be disclosed.
