Note 1 Description of Plan

The following brief description of the Rajant Corporation 401(k) Plan Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Rajant Corporation (the “Company”), who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to Plan management.

Eligibility Requirements

Employees who are age twenty-one or older, are eligible to participate in the Plan on their first day of employment.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, limited to the annual maximum dollar limitation prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Roth elected deferrals are also permitted under the Plan. Participants direct the investments of their contributions into various investment options offered by the Plan. Participants are allowed to enroll into the Plan upon hire or any time thereafter. There are no specified open enrollment dates, enrollments are processed during the next available payroll period. Participants may stop an election to contribute at any time. The Company may elect to make a discretionary matching contribution equal to a discretionary amount as determined by the Company of the participant’s elective deferrals. There were no employer contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's elective and rollover contributions, the Company’s contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may change their self-directed investment options anytime.

Vesting

Participants are immediately vested in their contributions, including voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution is based on years of continuous service. The Plan's vesting schedule is as follows:

Forfeited Accounts

Forfeitures of non-vested employer discretionary contributions, resulting from a participant's break in service, are used to offset administrative expenses of the Plan and/or the Company's annual contribution to the Plan (if applicable). Employee forfeitures were approximately \$0 for the years ended December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, less any outstanding loans. Note receivable terms extend to a period not to exceed five years, or more if used for the purchase of a principal residence. The notes receivable are secured by the balance in the participant's account and earn interest at a rate commensurate with prevailing rates for similar notes receivable as determined by the plan administrator. At December 31, 2024, interest rates ranged from 4.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants who are still employed may make hardship withdrawals (after all loan options have been maximized) as defined by the IRS from their salary deferral account balance. Employees age 59 ½ may withdraw any portion of their vested account balance. Benefits are recorded when paid.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit responsive investment contracts which are required to be reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement. See Note 4 for discussion of fair value measurement. Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The net returns from investment activity include realized and unrealized gains and losses from investment activity of the plans assets. Unrealized gains and losses are calculated as the difference between the current value of investments as of the end of the Plan year and either the current value at the end of the preceding year or the actual cost if such investments were purchased during the current year. Realized gains or losses on sales of investments are calculated as the difference between sales proceeds and the current value of the investments at the beginning of the year or the actual cost of such investments were purchased during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant notes receivable that are delinquent have been reclassified as distributions based upon the terms of the plan document.

Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses paid by the Plan totaled \$8,183 for the year ended December 31, 2024.

Note 3 ERISA Section 103(a)(3)(C) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from AdvisorTrust, Inc for the year ended December 31, 2024, in which they certified that the statements furnished for the specified period, pursuant to 29 CFR 2520.103-5(c) are complete and accurate. The information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024 was obtained or derived from information supplied from and certified by AdvisorTrust, Inc., the custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets as of the reporting date.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable or significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds and ETFs – valued at the daily closing price as reported by the fund. Mutual funds and ETFs held by the Plan are funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds and ETFs held by the Plan are deemed to be actively traded and level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminated, participants will become one hundred percent vested in their accounts.

Note 6 Related Party and Parties-in-Interest Transactions

During the course of the year, the Plan entered into certain party-in-interest transactions with PCS, who serves as fund custodians. The Plan also has several other service providers in which administrative fees (Note 2) are paid for services provided. As such, transactions in these investments and for services provided qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for the services provide are included in administrative expenses.

In addition, notes receivable from participants, as disclosed in the statements of net assets available for benefits, qualify as party-in-interest transactions.

Note 7 Tax Status

The Internal Revenue Service has determined and informed the Company by letter, that the Plan was qualified and was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the plan administrator and the Plan's tax counsel believe that the plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

Investments are subject to market volatility, which could have a material effect on participant accounts. The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment options and the level of uncertainty related to changes in the value of investment options, it is reasonably possible that changes in risks in the near term could materially affect participant's accounts balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.
