To the Plan Management of

Opinion

We have performed audits of the accompanying financial statements of Zeco Systems, Inc. Employee Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 (liquidation basis) and 2023 (ongoing basis), and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024 (liquidation basis), and the related notes to the financial statements.

As a result liquidated all assets of the Plan subsequent to year end. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 – Description of the Plan

The following description of the Zeco Systems, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a health and welfare benefit plan that provided medical and prescription drug benefits to substantially all full-time employees and covered beneficiaries and dependents of Zeco Systems, Inc. dba Shell Recharge Solutions (the Company) who worked 30 hours or more per week and completed a 60-day waiting period. Effective January 1, 2024, the waiting period was changed to 30 days. Part-time, temporary, leased or seasonal employees, independent contractors, and union employees were excluded from the Plan. The Plan also provided continuation of certain benefits for certain qualifying events through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Plan assets were held by the Zeco Systems Inc. dba Shell Recharge Solutions Health Benefit Trust (the Trust). The Plan was established on December 1, 2022 and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

The Plan was terminated effective December 31, 2024, in accordance with action taken by the Company. Following the termination, the Plan ceased providing health and welfare benefits to participants.

To pay claims incurred prior to the termination date but processed afterward (the "run-out period"), the Company established a separate account in January 2025 and moved all the assets out of the trust into the new account by June 2025. These funds were used to satisfy outstanding participant claims and administrative expenses related to the termination of the Plan.

As of the report date, there are no remaining liabilities or assets associated with the Plan.

NOTE 1 – Description of the Plan (Continued)

Self-Insured Benefits

The Plan was self-insured for all benefits provided under the Plan. The claims for self-insured benefits were processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors paid directly to or on behalf of participants and were then reimbursed by the Trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants was retained by the Plan. The participants paid the participant portion of plan premiums for their coverage.

The Plan utilized a pharmacy benefit manager (PBM) which periodically made refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

In addition to deductibles and copayments, participants contributed specified amounts based on applicable monthly premiums for their respective benefit elections. Participants paid between 10%-20% of estimated costs and the employer paid between 75%-90% of estimated costs based on the participants' enrollment election.

The Company made contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations was funded by the Company on a pay-as-you-go basis.

Stop-Loss Coverage

The Plan had entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan was responsible for individual claims up to \$55,000 per year, not to exceed an overall aggregate limit that varied with the number of active participants.

NOTE 2 – Summary of Accounting Policies

Basis of Accounting

As described in Note 1 to the financial statements, the Company elected to terminate the Plan effective December 31, 2024. As a result, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan used the liquidation basis of accounting. The use of the liquidation basis of accounting did not have a significant impact on the accompanying financial statements.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP required management to make estimates and assumptions that affected the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments were recorded when paid by third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan were recorded as claims payable in the accompanying statements of net assets available for benefits.

Claims Incurred but Not Reported

The Plan's benefit obligations were estimated by the Plan's third-party actuary in accordance with commonly accepted actuarial principles. Such estimated amounts were reported in the accompanying statements of benefit obligations. The actuary applied a reserve factor to a credible best estimate volume measurement of paid claims to calculate the claims incurred but not reported reserve. This estimate included unreported claims, reported but unprocessed claims, and processed but unpaid claims; however, it did not include claim settlement expense liabilities. As of December 31, 2024 (liquidation basis) and 2023 (ongoing basis), claims incurred but not yet reported totaled \$249,983 and \$169,264, respectively.

NOTE 2 – Summary of Accounting Policies (Continued)

Stop-Loss

Premiums for stop-loss insurance were included in claims paid on the accompanying statement of changes in net assets available for benefits (liquidation basis). For the year ended December 31, 2024 (liquidation basis) stop-loss refunds totaled approximately \$759,868 and were netted with claims paid in the accompanying statements of changes in net assets available for benefits (liquidation basis).

Pharmacy Refunds

Refunds due from the Plan's PBM were recorded when earned. Refunds due as of December 31, 2024 were reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$61,333 were netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 (liquidation basis).

Administrative Expenses

Administrative expenses incurred in the administration of the Plan that were paid by the Plan include medical claim administrative fees, third-party administrator management fees, and broker fees. These expenses were recorded as deductions in the accompanying statement of changes in net assets available for benefits (liquidation basis).

Subsequent Events

Pursuant to the termination of the Plan, all outstanding claims incurred prior to termination were paid by June 2025, and there were no remaining assets or liabilities related to the Plan.

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy were based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Interest-bearing cash: Valued at cost plus accrued interest, which approximates fair value.

NOTE 4 – Related-Party Transactions and Party-in-Interest Transactions

Administrative expenses included fees paid to the Benecon Group, LLC, a third-party administrative and management provider, EPIC, a third-party insurance broker and consultant, and Meritain Health, Inc., a third-party claims processor. Therefore, transactions entered into with these service providers qualified as party-in-interest transactions, which were exempt from the prohibited transaction rules of ERISA.

NOTE 5 – Risks and Uncertainties

The value of benefit obligations was reported based on certain assumptions pertaining to election patterns and demographic profile, which were subject to change. Due to uncertainties inherent in the estimations and assumptions process, it was at least reasonably possible that changes in the estimates and assumptions in the near term would be material to the financial statements.

NOTE 6 – Tax Status

The Trust, established under the Plan to hold the Plan's assets, was not tax exempt under the applicable Internal Revenue Code and, accordingly, the Trust's net investment income was taxable to the Plan. The plan administrator believed that, as of the date of the financial statements, the Plan was not liable for any income taxes and, therefore, no tax provision was made in the accompanying financial statements.

U.S. GAAP required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the Internal Revenue Service. The plan administrator concluded that there were no uncertain tax positions as of and for the years ended December 31, 2024 (liquidation basis) and 2023 (ongoing basis). The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress. The statute of limitations for federal purposes was generally three years and for state purposes was generally four years.

NOTE 7 – Plan Termination

As described in Note 1, the Plan was terminated effective December 31, 2024.
