Independent Auditor's Report

To the Administrative Committee of the
First Medical Health Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of First Medical Health Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of First Medical Health Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of First Medical Health Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about First Medical Health Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

A. Description of Plan

The following description of the FIRST MEDICAL HEALTH RETIREMENT SAVINGS PLAN (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan covering all full-time employees of the Company who have three months of service and are age eighteen or older. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was created for the purpose of providing retirement benefits to employees and to encourage and assist them in adopting a regular savings plan that qualifies under the applicable laws of the Commonwealth of Puerto Rico.

2. Contributions

Participants are permitted to contribute up to an amount not to exceed the maximum deferral amount specified by the Internal Revenue Code for a New Puerto Rico (“PR Code”) of \$15,000 for the tax year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty mutual funds and one money market as investment options for participants. The Company matches 50 percent of the participant’s contribution not to exceed \$7,500 for the year ended December 31, 2024. Participants who are 50 years or older can contribute an additional pre-tax contribution of \$1,500.

3. Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

5. Participant Loans

The Plan does not allow participants to take loans from their accounts.

6. Payment of Benefits

Participants or their beneficiaries may receive distributions of their account balances upon the retirement, disability, death or termination of service, as defined in the plan. Further, the Plan Administrator may permit a participant who experiences a qualified financial hardship, as defined in the Plan agreement, to receive a distribution or a portion of the participant's account balance.

All distributions from the Plan will be made in a single lump-sum payment. If the value of the vested account is more than \$5,000, the participant may elect to defer any benefit payable under the Plan until a specified future date.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Administrative Expenses

Direct Expenses, some professional fees and certain administrative expenses are paid by the Company. Other administrative expenses classified as 12b-1 fees are paid by the Plan.

9. Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,816 and \$5,283, respectively. These accounts will be used to reduce future employer contributions and/or costs of plan administration. Forfeiture amounts used to pay administrative expenses were \$14,245 during 2024.

B. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. Revenue is recognized when earned and expenses are recognized when incurred.

The Fund's expenses are paid by the Fund, as provided by the Plan document. Expenses incurred in connection with the general administration of the Fund that are paid by the Fund are recorded as deductions in the accompanying statements of the changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of investments presented in the accompanying statements of changes in net assets available for benefits.

In February 2016, the Financial Accounting Standards Board (FASB) approved Accounting Standards Codification (ASC) 2016-02, Leases (Topic 842). The ASC is designed to increase transparency and comparability among organizations by recognizing lease assets and liabilities on the statement of financial condition and disclosing key information about leasing arrangements. The Fund does not have any leases in effect as of the date of adoption of ASC No. 842. As such, the adoption of ASC No. 842 does not have an impact on the Fund's financial statements.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

The Plan presents in the statement of changes in net assets the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded under the accrual basis and credited to each participant's account, as defined.

The Plan determines the fair values of its investments based on the fair value framework established in the Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) 820 “Fair Value Measurements and Disclosures,” which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Fair value is defined under ASC 820 as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurements date. The standard describes three levels of inputs that may be used to measure fair value which are: (1) quoted market prices for identical assets or liabilities in active markets, (2) observable market-based inputs or unobservable inputs that are corroborated by market data, and (3) unobservable inputs that are not corroborated by market data. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Refer to Note D to these financial statements for the ASC 820 disclosures required as of December 31, 2024 and 2023.

Contributions

Employee and employer matching contributions are recorded in the period in which the Companies make the payroll deduction.

Transfers of assets to other plans

Terminated employees or retirees may elect to transfer their savings to other plans qualified by the Puerto Rico Department of the Treasury.

Payment of Benefits

Benefits are recorded when paid.

General

Certain comparative figures have been reclassified to conform to current year presentation.

C. Certified Financial Data

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provide the framework for measuring fair value. ASC 820 established three levels of inputs that may be used to measure fair value.

Level 1 — Inputs are quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 — Inputs other than quoted prices included in Level 1 that are observable either directly or indirectly. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or that can be corroborated by observable market data for substantially the full term of the financial instrument.

Level 3 — Inputs are unobservable and significant to the fair value measurement. Unobservable inputs reflect the Plan’s own assumptions about assumptions that market participants would use in pricing the asset or liability.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. These Levels are not an indication of risk associated with the investments.

The plan’s assets consist of Mutual Funds and a Money Market classified as Level 1.

E. Prohibited Transactions – Delinquent Participant Contributions

U.S. Department of Labor Regulation 2510.3-102 requires employers to remit amounts paid by a participant or beneficiary to an employer and/or withheld by an employer for contribution to an employee benefit plan to the plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the "15th business day of the month following the month in which the participant contributions are withheld or received by the employer." During 2024 and 2023, no instances were noted that could classify as a prohibited transaction. In 2022, a total of \$268 in contributions, constituting 0.02% of total contributions, were posted with a fifteen-day delay, due to factors beyond the Company's full control. We are of the opinion that this effect is inconsequential for the participants.

F. Income Tax Status

The Plan obtained a favorable determination letter from the Department of the Treasury of the Commonwealth of Puerto Rico. The letter dated June 29, 2010, with effective date January 1, 2009, indicates that the Plan is designed in accordance with applicable income tax law and is, therefore, exempt from income taxes. The Plan administrator is of the opinion that the Plan is designed and is currently being operated in compliance with the applicable requirements of the income tax law. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted of the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the PR Treasury. As of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. Individual participant's accounts bear the risk of loss from fluctuations in investment values.

H. Related-Party Transactions

Certain Plan investments are shares of a money market fund that was managed by Banco Popular of Puerto Rico (\$2,193,145 in 2024), which is also the trustee of the Plan. These transactions qualify as party-in-interest transactions permitted under the provisions of ERISA.

I. Subsequent Events

The Plan has evaluated subsequent events through the filing date, the date the financial statements were available to be issued. The Plan has determined there are no events occurring in this period that require disclosure in or adjustment to the accompanying financial statements.
