**1. DESCRIPTION OF THE PLAN**

Providence Health Care, Inc. Retirement Savings Plan (the Plan) is a prototype defined contribution 403(b) plan and trust adopted by Providence Health Care, Inc. (the Plan Sponsor). The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 403(b) plan covering substantially all eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees become eligible to participate upon hire. There are no minimum age or service requirements to make any salary reduction contributions.

The Plan holds a group annuity investment contract that has a fixed interest annuity portion and a variable interest annuity portion. The fixed interest annuity earns a guaranteed rate of return established by American United Life Insurance Company (AUL) and is backed by AUL's general account fund. The variable interest annuity is divided into investment accounts that invest in shares of specific funds or fund portfolios through pooled separate accounts.

Contributions and Funding Policy

Each year, participants may contribute up to a maximum amount of their pre-tax or after-tax annual compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year may make additional catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified plans. Each plan year, the Board of Directors of the Plan Sponsor will determine the amount of employer matching contributions, if any, that will be made to the Plan on behalf of eligible participants. Participants must have completed 60 days of service to be eligible to receive employer matching contributions. The employer matching contribution was 50% of deferrals up to 10% of compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants may change their deferral amount at any time. Investment account options available include various funds. Each participant has the option of directing their contribution into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's deferral contribution, employer matching contributions, if any, allocations of plan earnings (losses) and is charged with an allocation of administrative expenses, including an annual charge deducted from each participant account. Allocations are based on participant account balances or earnings (losses), as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings (losses) thereon. Vesting in employer matching contributions, plus actual earnings (losses) thereon, is based on years of continuous service. A participant is 100% vested after 3 years of service based on a cliff schedule (0% for years 1 and 2 and 100% year 3). Participants also become fully vested in the event of death, disability, retirement, or Plan termination.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are first used to pay the Plan's administrative expenses and second used, to reduce future employer matching contributions. If a participant's account is forfeited due to termination and then is rehired, the forfeited account will be restored so long as the participant did not incur a break in service greater than five years. As of December 31, 2024 and 2023, forfeited non-vested balances were approximately \$-0-. No forfeitures were used to pay administrative expenses during 2024. Approximately \$12,500 of forfeitures were used to reduce employer contributions during 2024. There were approximately \$12,500 of forfeitures incurred on benefits paid to participants during 2024.

Notes Receivable from Participants

Participants are not permitted by the Plan to borrow from their fund accounts.

Upon termination of employment due to death, disability or retirement, a participant (or beneficiary) may receive benefits based on the participant's vested account balance. Benefits are paid in either a lump sum amount or installments. The Plan also has a mandatory lump sum distribution provision for terminated or retired participants with a vested account balance under \$5,000.

Plan Termination

Although the Plan Sponsor has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by its Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the plan document.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varied investment objectives. Participants should refer to the custodian for a more complete description of the investment objectives.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan Sponsor and generally include audit and legal fees. The expenses paid by the Plan Sponsor are excluded from these financial statements. Administrative expenses incurred by the Plan generally include certain administrative fees charged directly to the participants' accounts.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 15, 2025.

**3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company (AUL), the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Pooled separate accounts:* Valued at the net asset value of the units held by the Plan at year end. The net asset value as provided by the custodian is used as a practical expedient to estimate fair value. The pooled separate accounts do not have finite lives, unfunded commitments relating to those types of investments, or significant restrictions on redemptions.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following tables summarize investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment contract that is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a group annuity investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. Transactions with parties-in-interest included administrative fees for the Plan's custodian. Fees incurred and paid directly by the Plan for these services were approximately \$14,400 for 2024.

Certain Plan investments are pooled separate accounts managed by AUL, the custodian of the Plan assets. Therefore, any transactions with AUL qualify as party-in-interest transactions. Certain expenses of the Plan are paid by the Plan Sponsor. Blue & Co., LLC is the independent auditor for the Plan. The Retirement Advantage, Inc. is the advisor for the Plan and receives payments for those services.

The Plan Sponsor provides certain administrative services at no cost to the Plan including accounting fees. These expenses qualify as party-in-interest transactions.

**7. INCOME TAX STATUS**

The Plan has adopted a volume submitter plan document sponsored by The Retirement Advantage, Inc., which has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the volume submitter plan document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
