The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes.

Our valuation methodologies have been consistently applied from period to period. The fair value measurements reported or disclosed represent our best estimate of fair value as of the measurement date in accordance with the requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. In addition, our disclosures related to fair value measurements are consistent with the objectives outlined in FASB ASC 820.
- All related party relationships and transactions have been appropriately accounted for and disclosed in accordance with the requirements of U.S. GAAP.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event or events occurring is more than remote but less than likely.
- *Probable.* The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. A reportable finding is an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention. We did not note any deficiencies in the Plan's internal control that we consider to be significant deficiencies and reportable findings.

Additionally, as discussed below, we identified the below matter involving the internal control and other operational matters that is presented for your consideration.

***Loan Repayment Schedule***

While performing our audit procedures over loans we noted that the loan repayment terms for the loan selected for testing was over 60 months from the date of distribution.

IRS regulations require that loans be repaid within 60 months except when the employee uses the loan for the purchase of a primary residence. Loans that are not repaid timely are considered “deemed distributions”, are subject to income tax, and may be subject to the 10% early distribution tax.

We recommend that you review and amortize any loans outside the 60 month repayment timeline so that that they are repaid in accordance with IRS regulations
