We have performed audits of the financial statements of Titanium Industries, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Plan Description**

The following description of the Titanium Industries, Inc. 401(k) Profit Sharing Plan (Plan) provides general information only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan was established on February 1, 2002 and was amended and restated on April 15, 2022. The Plan is a defined contribution plan that covers substantially all employees of Titanium Industries, Inc. (Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

***Eligibility***

Employees of the Company are eligible to participate in the Plan after reaching the age of twenty-one. There is no service requirement to participate in the Plan. Eligible employees are automatically enrolled at a rate of 3%, unless the participant elects otherwise.

***Contributions***

Participants may elect to contribute pre-tax and Roth deferral contributions on up to 100% of eligible compensation. Total pre-tax and Roth deferrals are subject to the statutory limitations of the Internal Revenue Code. Participants may also make rollover contributions from other qualified plans.

Effective January 1, 2022, the Plan was amended and restated as a safe harbor plan. For the year ended December 31, 2024, the safe harbor employer contribution is 100% of an employees' elective contribution that are not over 3% of eligible compensation, as defined, plus 50% of an employees' elective contribution that are not over 5% of eligible compensation, as defined.

The Company may make discretionary non-elective employer contributions to the Plan. For the year ended December 31, 2024, there were no discretionary non-elective contributions made to the Plan.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature does not provide for an automatic annual increase in the percentage.

***Participant Accounts***

Each participant's account is credited with their contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may select from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

***Vesting***

Participants are immediately and fully vested in their own contributions and discretionary employer matching contributions, plus actual earnings thereon.

***Benefits Paid to Participants***

A participant's vested interest in his or her account balance is distributable upon normal retirement (65), termination, disability, or death, as described by the plan document. Participants can also make in-service withdrawals upon reaching age 59½. In certain other cases and subject to the approval of the plan administrator, participants may request a withdrawal of a portion of their pre-tax elective deferral balance in the case of financial hardship.

***Notes Receivable from Participants***

Participants are permitted to borrow a portion of their vested account balance. Loans are limited to a minimum of \$1,000 and a maximum of the lesser of 50% of the vested account balance or \$50,000. The terms of the loan cannot exceed five years except when the loan is used to acquire or construct a principal residence, which can be repaid over a longer period. Loans are repaid through payroll deductions and monitored by the plan administrator. The loans are collateralized by the balance in the participant's account and bear interest at rates as determined by the plan administrator. At December 31, 2024, the interest rates on the outstanding loans range from 4.25% to 10.25%.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is presented at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussions of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses consist of investment fees and plan maintenance fees, which are paid by the Plan, while all other administrative expenses on the Plan are paid by the Company.

**Note 3. Investment Information Certified by the Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Guaranteed Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive guaranteed investment contract (Principal Fixed Income Guaranteed Option (PFIGO)) with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings based on the specified crediting rate and charged with participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed minimum interest rate is determined by the average of 5-year constant maturity treasury rates 12 months prior to Principal Life announcing the composite credit rate(s), reducing this average by 1.25% and rounding the amount to the nearest 0.05%. In no case will the guaranteed minimum interest rate be less than 1% or greater than 3%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. As of December 31, 2024 and 2023, the guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value.

## **Note 5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled separate accounts:* The fair value of the pooled separate accounts are determined by the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities are based on quoted prices of similar assets.

*Mutual funds:* Stated at fair value based on unadjusted quoted prices in an active market at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Related-Party Transactions**

The custodian of the Plan is Principal Trust Company. Fees paid by the Plan amounted to \$72,181 for the year ended December 31, 2024. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These services qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions.

Direct and indirect fees and commissions are included in net appreciation in fair value of investments through revenue sharing rather than direct payment.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 9. Tax Status**

On June 30, 2020, the Internal Revenue Service (IRS) stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 01, 2025, which is the date the financial statements were available to be issued.
