## INDEPENDENT AUDITOR'S REPORT

To the Administrators of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of North Dakota Farmers Union Employee Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of North Dakota Farmers Union Employee Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of North Dakota Farmers Union Employee Salary Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about North Dakota Farmers Union Employee Salary Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Other Matters - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. **NOTE 1 PLAN DESCRIPTION**

The following description of the North Dakota Farmers Union Employee Salary Savings Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General**

The Plan is a multiple employer defined contribution plan covering all qualified employees of Agraria Insurance Company, Farmers Union Mutual Insurance Company of Arkansas, Farmers Union Service Association, Ltd., and Farmers Educational and Cooperative Union of America, North Dakota Division (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. A third-party administrator maintains the records of the participant data and a separate trustee holds the Plan assets.

**Eligibility**

Employees are eligible to participate in the Plan if they are 18 years of age or older. Temporary employees, such as camp staff, bus drivers and tour guides, are specifically excluded from participation in the Plan per the Plan document. There is no service requirement for employee contributions. Employees are eligible for employer matching contributions if they have completed 1 year of service. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service.

**Contributions**

Participants may contribute any percentage of their annual compensation, as defined by the plan, but are restricted by the annual IRS limits. The Plan has an automatic contribution arrangement, under which eligible participants are automatically enrolled into the Plan at 5% of compensation unless they specifically opt out.

The Company contributes a discretionary match each year. Effective for the years ended December 31, 2024 and 2023, the Company provided a matching contribution equal to 60% of employee deferrals up to and including 5% of compensation. The maximum employer matching contribution is 3%.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company discretionary matching contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting Empower.

**Vesting**

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Vesting for any discretionary employer matching contributions received from the Company is based on a graded schedule and after six years of completed service, the participant is 100 percent vested.

**Payment of benefits**

Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account, a series of equal payments over a set period of time that does not exceed the participant's life expectancy, or a combination of lump sum and installment payments. If the vested value of the account does not exceed \$7,000, the participant will be forced out of the Plan. If a mandatory distribution is being made because a participant's vested interest in the Plan exceeds \$1,000 but does not exceed \$7,000, then the Plan will roll over the distribution to an IRA. If the vested interest is less than \$1,000, the mandatory distributions will be paid in a lump sum. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 1/2 to qualify for in-service distributions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

**Forfeitures**

Forfeitures can be used to offset administrative expenses and future employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,200 and \$1,993, respectively. During the years ended December 31, 2024 and 2023, Plan expenses were reduced by \$3,227 and \$8,894, respectively, from forfeited non-vested accounts. No forfeitures were used to offset employer matching contributions during the years ended December 31, 2024 and 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully-benefit responsive contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Recordkeeping fees, investment advisory fees and audit fees related to the administration of the Plan are paid from Plan assets. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:  
                  Quoted prices for similar assets or liabilities in active markets;  
                  Quoted prices for identical or similar assets or liabilities in inactive markets;  
                  Inputs other than quoted prices that are observable for the asset or liability;  
                  Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to

temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 MASSMUTUAL GUARANTEED INTEREST ACCOUNT**

The Plan's investments include the MassMutual Guaranteed Interest Account. This is a stable value investment with a guaranteed rate of return and a guarantee of principal that is backed by Massachusetts Mutual Life Insurance Company ("MassMutual"). The guaranteed interest account is provided through a group annuity contract issued by MassMutual to a retirement plan. Under the contract, a credited rate is established for a six-month period of time and all assets invested in the guaranteed interest account are credited with that rate. At the expiration of each rate period, a new credited rate is declared. The guaranteed interest account credited rate was approximately 2.45% and 2.10% for the years ended December 31, 2024 and 2023, respectively.

Among the asset types included in the guaranteed interest account portfolio are long-term bonds, mortgage loans, short-term investments and cash, and small positions of common stock, partnership arrangements, and real estate.

All bona fide participant initiated withdrawals from the guaranteed interest account, including benefit payments at termination or retirement, loans, and transfers to other non-competing investment options, are paid at contract value. Transfers to competing fixed income investments are not allowed. Employer initiated events such as layoffs, a sale of business unit, a company merger, or change in the stable value option offered under a plan are considered market value events. Upon full or partial contract or plan termination and certain other sponsor-initiated events, distributions from the guaranteed interest account may be subject to a liquidation value (market value) adjustment pursuant to a formula specified in the contract. The market value formula may produce a value that is more or less than the contract value of the plan's investment in the guaranteed interest account.

The value of the guaranteed interest account is equal to the total of all amounts allocated under the contract plus all interest accrued thereon, minus the sum of any withdrawals, transfers and participant's administrative charges.

**NOTE 6 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan sponsored by Empower. The pre-approved plan has received an opinion letter dated November 14, 2022, from the Internal Revenue Service as to the Plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Empower serves as the recordkeeper and third-party administrator of the Plan. Empower provides certain administrative services to the Plan pursuant to the service agreement between the Company and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan. Fees paid to Empower for recordkeeping services amounted to \$32,185 and \$51,144 for the years ended December 31, 2024 and 2023, respectively. These fees were reduced by \$0 and \$7,412 of revenue sharing funds for the years ended December 31, 2024 and 2023, respectively.

RPM Advisors LLC serves as the investment advisor to the Plan and Brady Martz is the auditor of the Plan. Fees paid to RPM Advisors LLC and Brady Martz were \$13,084 and \$3,227, respectively, for the year ended December 31, 2024.

**NOTE 8 PLAN TERMINATION AND AMENDMENTS**

The Company has the right to amend the Plan if it determines it is necessary or desirable to do so. Further, although the Company intends to continue the Plan, it reserves the right to terminate it. Any termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts, regardless of the Participant's vested percentage.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through October 14, 2025, which is the date these financial statements were available to be issued.
