Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Combined Building & Housing Consultants, Inc. 1081.01 (d) Salary Deferral Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

(1) Description of Plan

The following brief description of Combined Building & Housing Consultants, Inc. 1081.01 (d) Salary Deferral Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan adopted effective April 1, 2015. It covers all full-time employees of Combined Building & Housing Consultants, Inc. (the Sponsor or Employer). Participants are eligible to participate in the Plan once the employee is hired as regular employee and is 21 years of age or older and resident of Puerto Rico. The Employer follows the labor laws in force regarding probation period as stipulated in the labor reform. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 1081.01 (a) and (d) of the Puerto Rico Internal Revenue Code of 2011 (the 2011 Code), as amended.

Effective May 31, 2023, Empower Trust Company, LLC was appointed as custodian and record-keeper of the Plan.

(b) Contributions

Each year, participants may contribute an amount not to exceed the maximum deferral amount specified in the Puerto Rico tax law. Participants can also make voluntary contributions to the Plan from 1% to 10% of their compensation. Annual deferral limit under the 2011 Code is \$15,000 for the tax years ended December 31, 2024 and 2023, respectively. The Sponsor contributes one dollar for each one dollar contributed by participants up to 4% percent of the participant's compensation.

Participants over age 50 are permitted to make an additional catch-up contribution of \$1,500 after contributing the Plan limit of \$15,000 of their pre-tax annual compensation.

The Sponsor may deposit a discretionary contribution to be allocated to all employees on a basis of percentage of compensation. The availability of this contribution will be determined in a year to year basis.

Participants are allowed to make rollover contributions from other qualified Plans.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and the Sponsor's matching contribution, as well as allocations of Plan's earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are 100 percent vested in their contributions and rollover contributions, plus actual earnings thereon. The percentage of vesting for Sponsor's contributions is based on the participant's years of service, in accordance with Plan's provisions.

The vesting percentages on Sponsor's contributions for the respective years of service are based on the following table:

(e) Payment of Benefits

Normal retirement pension benefits are payable upon the date a participant reaches 60 years of age. On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period or over the remaining life expectancy of the participant (or designated beneficiaries).

(f) Early Retirement

The Plan does not provide an early retirement age.

(g) Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Puerto Rico Internal Revenue Code are recoded as a liability with a corresponding reduction to contributions.

(h) Hardship Withdrawals

Under the provisions of the Plan, participants are permitted to make hardship withdrawals from the participant's pre-tax and additional pretax contributions. Such withdrawal is only permitted if: a) financial hardship is demonstrated, b) the withdrawal is approved by the Plan Administrator, and c) such withdrawal is allowable under the Puerto Rico Internal Revenue Code.

(i) Forfeited Accounts

Forfeitures under the Plan will be added to the employer contributions and allocated accordingly. At December 31, 2024 and 2023, available forfeitures amounted to \$1,980 and \$501, respectively.

(j) Rollover Contributions

Rollovers contributions to the Plan consist of monies received by a Participant from another plan qualified under the Puerto Rico Internal Revenue Code.

(k) Administrative Expenses

All administrative expenses to the extent not paid by the Sponsor are paid from Plan's assets. During the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan amounted to \$1,832 and \$244, respectively.

(l) Investments Options

Effective May 31, 2023, the Sponsor changed its plan record-keeper and custodian from Transamerica Life Insurance Company to Empower Trust Company, LLC. On July 3, 2023, the assets of the Plan were transferred to the new record-keeper and custodian. The investment options available to employees prior to July 3, 2023, also were replaced with the investment securities offered by the new record-keeper and custodian. The deposit administration contract with Cooperativa de Seguros de Vida de Puerto Rico (COSVI) was settled at contract value and no penalties were assessed.

Participants may direct their contributions to various mutual funds and a group annuity contract with Empower Annuity Insurance Company of America as described in Notes 4 and 5, respectively.

(2) Summary of Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for disclosure of Group Annuity Contract with Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(5) Group Annuity Contract with Empower Annuity Insurance Company of America

In 2023, the Plan entered into a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and the credited interest rate established and declared to the Plan. The guaranteed minimum interest rate will be equal to 0.00%.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,069,989 and \$1,097,867, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0% for EAIC contract. Such interest rate is reviewed on a quarterly basis for resetting.

The methodology for calculating the interest crediting rate of the contract with EAICA is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the

minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

Certain events might limit the Plan's ability to transact at contract value with EAICA. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal or state income taxes or any required prohibited transaction exemption under ERISA, (e) premature termination of the contract. Termination of contract may also occur by virtue of plan change in asset management. In any of these cases, the value of participants' interest in the funds is determined taking into consideration the end of the day value divided by the number of units then outstanding.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured violation of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of material obligation under the contract, or (d) a material misrepresentation.

(6) Plan Termination

Although the Sponsor has not expressed any intention to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, reduction, or suspension, no further contributions are required from the Sponsor and the accounts of all participants will become fully vested and nonforfeitable.

(7) Tax Status

The Puerto Rico Treasury Department has determined and informed the Sponsor by a letter dated December 15, 2016 that the Plan is designed in accordance with the applicable sections of the 2011 Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the 2011 code and, therefore, believe that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal, state and/or local taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in several investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in investment values.

(9) Prohibited Transactions – Participant's Contributions Remittances

Department of Labor's Regulation 2510.3-102, requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Sponsor's general assets but in no event later than the 15th business day following the end of the month in which amounts are contributed by employees or withheld from their wages. There were unintentional delays in the remittance of participant's contributions during the Plan year ended December 31, 2023. The Sponsor has agreed to absorb any costs incurred by the Plan including lost interest as a result of the untimely remittances of the participants' contributions. The accumulated loss earnings on such late remittances amounted to \$732 at December 31, 2023, which were paid by the Sponsor on September 18, 2024. In 2024, there were no delays in the remittance of participants contributions to the Plan.

(10) Party-in-Interest Transactions

As of December 31, 2024 and 2023, the Plan held a group annuity contract that is managed by Empower. Empower is the custodian and record-keeper for the Plan, therefore, this transaction qualifies as party in interest transaction permitted under the provisions of ERISA.

(11) Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date at which the financial statements were available to be issued. The Plan Administrator has determined that no events exist in that period that require disclosure in or any adjustments to the accompanying financial statements.
