## **Independent Auditor's Report**

To the Participants and Plan Administrator of  
the Profit Sharing Plan of Liggett Group Inc. for Bargaining Unit and Hourly Employees  
Mebane, North Carolina

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Profit Sharing Plan of Liggett Group Inc. for Bargaining Unit and Hourly Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND PLAN CHARACTERISTICS**

Basis of Presentation

The financial statements of the Profit Sharing Plan of Liggett Group Inc. for Bargaining Unit and Hourly Employees (the "Plan") are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

The Plan

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan was established as of January 1, 1976 as successor to a plan established on January 1, 1964. The Plan is administered by an Employee Benefits Committee consisting of persons appointed by Liggett Vector Brands LLC's ("Liggett," or the "Company") Board of Directors. Pursuant to Liggett's contract with the Tobacco Workers Union and other unions, effective January 1, 1992, the Company amended and restated the Plan. The amended and restated Plan includes a deferred arrangement under Section 401(k) of the Internal Revenue Code. Participants in the Plan will continue as participants of the amended and restated Plan. The Plan was amended and restated on January 5, 2016, effective January 1, 2016, and further amended on October 12, 2017. The Plan was most recently amended and restated effective January 1, 2022. See Note 4.

The Plan covers employees subject to various collective bargaining agreements, which expressly provide for participation of bargaining unit members in this Plan. These bargaining unit and hourly employees become participants in the Plan on the next January 1, April 1, July 1 or October 1 following or coincident with the date on which they complete their probationary employee period under the applicable collective bargaining agreement. They cease to be participants upon termination of employment with Liggett and after complete distribution of vested interests in the Plan.

Empower Plan Services, LLC ("Empower Plan Services"), marketed as Empower Retirement, provides certain administrative services to the Plan pursuant to an Amendment to Master Services Agreement among Empower Plan Services, Liggett Group LLC, and the Employee Benefits Committee of Liggett Vector Brands.

Empower Trust Company, LLC ("Empower Trust") is the trustee / custodian for the Plan pursuant to an Amendment to the Trust Agreement between Empower Trust and Liggett Group LLC.

Accordingly, Empower Trust is the trustee for the Plan and Empower Plan Services, doing business as Empower Retirement, is the recordkeeper for the Plan.

Contributions

Each participant of the Plan could elect to defer a portion of their covered compensation not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. The Plan provides for Company matching of the participant's deferral contributions not to exceed 5% of the participant's Covered Compensation. The Company may also (but is not required to) contribute a discretionary amount based on achievement of Company operating income targets established by the Company's Board of Directors. The Company contribution is limited to the maximum amount permitted by law or regulation as a deduction in the Company's federal income tax return.

The Plan permits additional participant voluntary after-tax contributions of up to 100% of Covered Compensation less the amount of pre-tax Deferral Contributions for the Plan year. Total contributions to a participant's account under the Plan are limited annually to the lesser of \$69,000 for 2024 and \$66,000 for 2023 or 100% of the participant's eligible earnings for the Plan year.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2022, the Plan was amended and restated to add a Roth 401(k) feature, add an automatic enrollment feature for new employees at a rate of 5% of pre-tax compensation, and permit rollovers for eligible employees who are not yet participants.

Notes Receivable From Participants

The Plan provides for loan arrangements for participants. Upon written application to Empower Retirement a participant may obtain a loan from their participant account that shall not exceed the lesser of one half of the value of the vested portion of the participant's account or \$50,000 reduced by the highest outstanding balance of any prior loan from the Plan during the previous one year period. Loan terms shall not exceed five years except for loans used to acquire a principal residence which shall not exceed a period of 15 years. The loans are collateralized by the related portions of the participants' accounts and bear interest at a rate of one percent above the prime rate, as published by the *Wall Street Journal*. Principal and interest is paid ratably through periodic payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Participant Accounts

Company contributions, other than matching contributions, and amounts forfeited by terminated participants are allocated to participants in the same ratio as each participant's compensation for the year, as defined in the Plan (limited to \$345,000 for 2024 and \$330,000 for 2023), bears to total compensation for the year for all participants. In addition to participants actively employed on the last day of the Plan year, participants whose employment was terminated during the Plan year by reason of retirement, disability, death, or transfer to an affiliated company or to a salaried position and still employed at year-end, are eligible for such allocation. Company matching contributions are allocated to participant accounts based on the participant's contribution. The participant's benefit is limited to the participant's vested balance in the Plan.

Vesting

Benefits from Company contributions vest at 20% per year and are fully vested after five (5) years of vesting service. Any nonvested portion of an active participant's Company contribution account becomes fully vested when the participant retires, dies, becomes 65 years of age, becomes disabled or terminates for the convenience of the Company. Generally, if an active participant otherwise voluntarily terminates employment with the Company, the nonvested portion of his Company contribution account may be used by the Company to restore forfeitures reinstated, to reduce employer matching contributions, or to correct any errors in the adjustment of participant accounts. Voluntary contributions by active participants are 100% vested.

Payment of Benefits

Upon termination of service, a participant generally may elect to receive a lump-sum amount equal to the value of his or her account, a partial lump-sum, deferred lump-sum, installment payments, or a direct rollover. Benefits are recorded when paid. Effective March 22, 2021, the Plan was amended to automatically distribute lump sum payments in the amount of \$5,000 or less. The Plan adopted the increased mandatory cash-out threshold of \$7,000 effective as of January 1, 2024.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,383 and \$8,585 respectively. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$9,021 from forfeited nonvested accounts.

Administrative Costs

Liggett personnel and facilities are used by the Plan for accounting and other activities at no charge to the Plan. The Plan pays for eligible trustee and other administrative expenses as permitted under ERISA guidelines. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses.

Statements of Changes in Net Assets Available for Plan Benefits

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

SECURE Act and CARES Act

On December 20, 2023, the IRS released Notice 2024-2, which extends the deadline for adopting any SECURE Act plan amendments until December 31, 2026, to provide relief for plan sponsors waiting for final IRS guidance on many of the SECURE Act's provisions. The Notice also extends the deadline for the 2020 waiver in the CARES Act of required minimum distributions until December 31, 2025. These amendments can be retroactively adopted; therefore, the Plan can implement the amendments prior to amending the plan instrument. Similarly, plans may have voluntarily adopted provisions under the CARES Act by placing them in operation without amending the plan as long as the plan management makes the required amendments to plan documents by December 31, 2026.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the SECURE 2.0 Act generally need not be made until the end of the first plan year beginning on or after January 1, 2025; however, plans must be operated in accordance with the effective date of each new provision. There is no current impact to the Plan and these provisions did not have an impact on the financial statements. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

2. INVESTMENTS

Investments are reported at fair value as determined by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. If available, quoted market prices are used to value investments. All investment transactions (purchases and sales of securities) are recorded by the Plan as of the trade date. Gains or losses on sale of investments were determined by the specific identification method. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date.

Effective September 30, 2022, the Plan's investments in the JPMorgan Mid-Cap Equity I Fund, and the JPMorgan Small Cap Equity R5 Fund were terminated and replaced with the iShares Russell Small Mid-Cap Index Fund. Also, effective September 30, 2022, the Plan's investment in the American Century Value R6 Fund was terminated and replaced with the Vanguard Large Cap Value Fund. Effective June 30, 2022, the Plan's investment in the T. Rowe Price Growth Stock Fund was terminated and replaced with the Vanguard Growth Index Fund.

During May 2023, the Plan's investments in the JPMorgan SmartRetirement Target Date Funds were terminated and replaced with the PIMCO Real Path Blend Target Date Funds. Participants of the Plan who had previously defaulted into the JPMorgan SmartRetirement Target Date Funds as the Qualified Default Investment Alternative ("QDIA") were re-enrolled in the PIMCO Real Path Blend Target Date Funds.

*Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INCOME TAXES**

Effective January 1, 2022, the Plan uses a Non-Standardized Pre-Approved Profit Sharing Plan With CODA plan document sponsored by Empower Retirement LLC. Empower Retirement LLC obtained an opinion letter on November 14, 2022 in which the IRS stated that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA plan document used by the Plan, as then designed, qualifies under Internal Revenue Code (“IRC”) Section 401. Prior to January 1, 2022, the Plan had received a Determination Letter specific to the Plan itself from the IRS on August 29, 2017. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Empower Trust Company, LLC is the trustee as defined by the Plan and Empower Plan Services, doing business as Empower Retirement, is the recordkeeper as defined by the Plan, and, therefore, plan assets used to pay Empower Retirement and Empower Trust Company, LLC fees qualify as exempt party in interest transactions. Fees incurred by the Plan for recordkeeping and trustee services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Effective January 1, 2022, the Plan was amended and restated to change the method of accounting for Plan recordkeeping fees. The Plan Sponsor pays directly any other fees related to the Plan’s operations except where otherwise indicated to Plan participants. Notes receivable from participants are also considered exempt party in interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**7. CONCENTRATION OF CREDIT RISK**

Financial instruments which potentially subject the Plan to concentrations of credit risk consist principally of investment contracts with insurance and other financial institutions. The Plan has no formal policy requiring collateral to support the financial instruments subject to credit risk. The Plan includes various investments in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statements of changes in net assets available for plan benefits.
