#### 1. Plan Description

The following description of the East Coast Lumber Company, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of East Coast Lumber Company, Inc. (the "Company") who have completed six months year of service and are age 21 or older. Eligible employee become a Participant in the Plan on the entry date (January 1 or July 1) following the date that the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Participant Contributions* - Each year participants may contribute to the Plan subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans.
- c) *Employer Contributions* – The Company makes a safe-harbor matching contribution to eligible employees. The Company contributes 100% of the first 3% of compensation that a participant contributes to the Plan and makes a contribution of 50% of compensation up to 5%. Participants contributing 5% or more of compensation receive an Company matching contribution of 4% of compensation.

Additional discretionary matching amounts may be contributed at the discretion of the Company. No additional contributions were made for the years ended December 31, 2024 and 2023.

- d) *Investment Options* – Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or internet. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.

- e) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- f) *Vesting* – Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are also immediately vested in all Employer contributions.
- g) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution or installment payment.
- i) *Forfeited accounts* – Forfeitures of nonvested balances may be used as additional employer discretionary contributions. At December 31, 2024 and 2023, there was \$4,256 and \$4,053, respectively of forfeited non-vested accounts. No forfeitures were used during 2024.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**3. Subsequent Events**

**5. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts – These investments are public investment securities valued using Net Asset Value ("NAV") provided by the investment custodian. The NAV is quoted on a private market that is not active; however, the unit price is based on the underlying investments which are publicly traded on active exchanges. Pooled separate accounts are included in Level 1 of the fair value hierarchy.

**6. Guaranteed Investment Contract (GIC) with Insurance Company**

The Plan holds a benefit-responsive investment contract with AXA Equitable Life Insurance Company (AXA), named the AXA Guaranteed Interest Option. The contract underlying this investment is considered to be fully-benefit responsive and therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract is a general account product. AXA is the owner of the assets in the account, and guarantees a minimum interest rate. The interest crediting rate can be changed monthly by AXA. The crediting rate as of December 31, 2024 and 2023 was 2%. The minimum interest per the contract is 1% as of December 31, 2024 and 2023.

**7. Risks and Uncertainties**

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**8. Related Party and Party in Interest Transactions**

Certain Plan investments are managed by AXA Equitable (AXA). AXA is the current custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to AXA in 2024 for recordkeeping services and participant transaction fees were \$53,829.

**9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**10. Tax Status**

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Equitable Financial Life Insurance Company ("Equitable"). Equitable obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
