Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Katy Trail Community Health 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Katy Trail Community Health 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Katy Trail Community Health 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution custodial account plan invested in mutual funds under Internal Revenue Service (IRS) Code Section 403(b)(7) and is subject to the Employees Retirement Income Security Act of 1974 (ERISA). The Plan sponsor is Regional Health Care Clinic, doing business as Katy Trail Community Health (the Organization).

Effective Date

The Plan was established January 1, 2007. The plan has been amended a number of times over the years and restated, with an effective date of November 1, 2021.

Eligibility Requirements

All employees are immediately eligible to participate in the Plan through elective deferrals.

Contributions

Each year a participant may elect to contribute an amount of pre-tax compensation and/or after-tax Roth deferrals as defined by the Plan, up to but not greater than the dollar amount set by the Internal Revenue Code (IRC). Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution allowed by the IRC was \$7,500 in 2024. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan, which currently offers twenty-one (21) mutual funds and one (1) guaranteed investment contract. The Plan includes an automatic enrollment provision whereby all newly hired employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their pre-tax contributions invested in a designated fund until changed by the participant.

The Organization may, at its discretion, make matching contributions to eligible participants' accounts. To be eligible for matching contributions the employee must have completed 1,000 hours of service during the Plan year. The matching contributions are applied based on the participants' elective deferrals, calculated at 50% of employee contributions up to a maximum of 2% of compensation.

NOTE 1 - DESCRIPTION OF THE PLAN – Cont'd

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Organization's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's contribution to their accounts (and earnings thereon) is based on years of continuous service. A participant is 100 percent (100%) vested after three years of continuous service. Participants are considered to have one year of service for vesting purposes if during a Plan year the participant is credited with 1,000 hours of service.

Payment of Benefits

Upon termination of service for any reason and at any age, including retirement, a participant with a vested account balance of \$1,000 or less will receive a lump-sum distribution for cash. A Participant with a vested account balance of between \$1,001 and \$5,000 will receive a lump-sum distribution of cash, if an election has been made to do so. Distributions will be made as soon as administratively possible. For a terminated participant whose vested account balance exceeds \$5,000, the participant may elect to receive a lump-sum amount equal to the value of his/her account or roll over the distribution into another qualified retirement plan or individual retirement account.

Hardship Withdrawals

The Plan allows for hardship withdrawals in the event of undue financial hardship subject to account balance limits and applicable laws.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are initially applied to Plan expenses. Any remainders are used to directly reduce employer contributions. At December 31, 2024 and 2023, the forfeited non-vested account totaled \$5,797 and \$2,836, respectively. Forfeitures of employer matching contributions resulting from participants withdrawing prior to becoming fully vested are allocated to offset employer matching contributions.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES – Cont'd

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments in mutual funds are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan’s valuation policies utilizing information provided by the investment advisor and trustee of the Plan. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Payments of benefits to participants are recorded when paid. At December 31, 2024, there were no participants who had terminated employment with the Organization who had requested distributions from the Plan that had not yet been paid.

Administrative Expenses

Certain expenses of maintaining the Plan, such as accounting and audit fees, fidelity bond and fiduciary liability insurance premiums, are paid by the Organization and are excluded from these financial statements. Fees related to the administration of benefits paid to participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments. The organization paid fees of \$8,750 at December 31, 2024.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 6, 2025 the date the financial statements were available to be issued. No subsequent events were identified that required adjustments to or disclosure in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The Plan held investments in mutual funds that were determined to be Level 1 investments as of December 31, 2024.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The Plan held no Level 2 investments as of December 31, 2024.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan held no Level 3 investments as of December 31, 2024.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive group annuity contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

**NOTE 5 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY -
CONTINUED**

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$457,982 and \$519,719, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. The crediting interest rate at December 31, 2024 and 2023 was 4.85% and 1.30%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants or the issuer is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - TAX STATUS

Effective November 1, 2021, the Plan was restated and an adoption agreement with Principal Life Insurance Company was executed establishing a non-standardized 403(b) retirement plan. The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in the draft *Listing of Required Modifications* issued April 4, 2009. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Internal Revenue Service has determined and informed Principal Life Insurance Company by letter dated March 31, 2017, that the form of the prototype non-standard 403(b) Plan is acceptable under section 403(b) of the Internal Revenue Code.

Accounting principles generally accepted in the United State of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator believes that there are no such tax positions at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent (100%) vested in their account balances and the Plan administrator would facilitate the distribution of account balances in lump sum payments.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS

Effective November 1, 2021, the Plan sponsor entered into an agreement with Principal Life Insurance Company to assume the responsibility as the contract administrator and recordkeeper of the Plan; and with Principal Trust Company to provide trustee and custodial services. Mutual funds are made available by Principal Funds, Inc. and Principal Securities, Inc. is the broker. Principal Life Insurance Company, Principal Trust Company, Principal Funds, Inc. and Principal Securities, Inc. are entities in the Principal Financial Group. Plan investment transactions in the Principal family of mutual funds qualify as party-in-interest transactions. All party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
