## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
the Justice Family Group 401(k) Retirement Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Justice Family Group 401(k) Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Justice Family Group 401(k) Retirement Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Qualified Opinion

In our opinion, except for the omission of the information described in the Basis for Qualified Opinion section of our report, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Qualified Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Justice Family

Group 401(k) Retirement Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Justice Family Group 401(k) Retirement Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



NOTES TO FINANCIAL STATEMENTS**

**NOTE 1. PLAN DESCRIPTION**

The following description of the Justice Family Group 401(k) Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:** The Justice Family Group 401(k) Retirement Plan and Trust, or the “Plan”, is a defined contribution plan covering all non-union employees who are age twenty-one or older with one year and 1,000 hours of service. The participating employers are Greenbrier Hotel Corporation, Greenbrier Sporting Club Development Co., LLC, Greenbrier Clinic, Inc., and Justice Family Group, LLC, which are closely related entities and collectively referred to as the “Employer.” The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions:** Each year, participants may contribute up to seventy five percent or up to \$23,000 in 2024 of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. While a participant, the automatic deferral amount will increase by ½% of compensation up to a maximum of 10% of compensation at the beginning of each subsequent Plan year. Only the Greenbrier Clinic, Inc. employees are excluded from this automatic provision. The Employer may contribute a discretionary match on the base compensation deferred by non-terminated participants at the Plan’s year-end. For the years ended December 31, 2024 and 2023, the Employer’s discretionary contribution was 25% of the first 8% of compensation deferred. Contributions are subject to certain statutory limitations.

**Participant accounts:** Each participant’s account is credited with the participant’s contribution and allocations of the Employer’s contribution and Plan earnings (losses) and charged with an allocation of administrative expenses (to the extent the Employer does not pay such expenses). Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer’s contribution is based on a vesting service period in which an employee has at least 1,000 hours of service. A participant is 100% vested after two years of credited service. The following schedule indicates the applicable vesting percentages:

Less than 1	0%
1, but less than 2	50%
2 or more	100%

**Participant loans:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The term of the loan is limited to five years.

**Payment of benefits:** Distributions can be made due to retirement, death, or disability and are subject to the applicable provisions of the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited accounts:** Forfeited non-vested accounts totaled \$6,329 and \$8,304, at December 31, 2024 and 2023, respectively. These amounts were applied to administrative fees for the year ended December 31, 2024.

**Termination of plan:** Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 1. PLAN DESCRIPTION, continued**

**Merger:** On December 18, 2014, an adopting resolution was signed to allow The Greenbrier Clinic, Inc., a company under common control with Justice Family Group, LLC, to adopt the Plan and transfer all assets into the Plan effective January 1, 2015.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Date of management's review:** Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**Use of Estimates:** The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Stable Value Fund is stated at contract value, as the investment contracts are fully benefit-responsive. Contract value, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits:** Benefits are recorded when paid.

**Operating expenses:** The Plan allows fees and expenses related to the Plan's administration and investments to be paid from Plan assets to the extent they are not paid by the Company.

**Transfer of plan assets:** During 2024, the Plan received a net transfer of assets in the amount of \$63,213 from another benefit plan controlled by the Company.

**NOTE 3. INCOME TAX STATUS**

The Plan operates under a nonstandardized adoption agreement in connection with the prototype retirement plan and trust/custodial documentation. This prototype plan document has been filed with the appropriate agency. The plan has not obtained a determination letter since adopting the new plan document, but the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**NOTE 5. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

**Level 1 Fair Value Measurements:** The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

**Level 2 Fair Value Measurements:** The fair value of common collective trust funds and pooled separate accounts are based on quoted net asset values of the shares held by the Plan at year-end.

**Level 3 Fair Value Measurements:** For those assets with fair value measured using Level 3 inputs, the Plan administrator determines the fair value measurement policies and procedures in consultation with the Company's chief executive officer and the Plan trustee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of instruments.

The plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers into or out of Level 3.

**NOTE 6. INVESTMENTS**

During 2024 and 2023, the Plan's investments appreciated in value by \$1,934,973 and \$2,336,780, respectively, all of which was attributable to the investments in common collective trust funds and mutual funds. All net assets and changes in net assets were related to nonparticipant directed investments.

**NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in common collective trusts funds managed by Transamerica. They are the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$107,571 and \$98,843 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
