Opinion

1. Description of Plan

The following description of the Philabundance Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The following brief description of the Philabundance Employee Benefit Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement, for a complete description of the Plan's provisions; copies of which may be obtained from Philabundance, the Plan Sponsor.

The Plan is a contributory health and welfare plan that provides health and other benefits to eligible members and dependents of the Philabundance (the "Company"), which represents members employed at the non-profit organization with the mission to fight hunger in local communities in Pennsylvania. A member will be eligible for coverage upon 30 days of continuous full-time employment with the Plan.

Certain Plan assets are held in a voluntary employees' beneficiary association ("VEBA") trust. The Plan is a single employer, welfare benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Benefits and Fund Policy

The Plan provides medical, hospital, prescription, and vision. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA"). During the years ended December 31, 2024 and 2023, total COBRA contributions were \$9,438 and \$757, respectively.

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only ("ASO") arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the general assets of the Plan Sponsor. Despite the Plan's utilization of the third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-to-the-max basis. The Company pays monthly amounts to fund up to the maximum liability of the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Interest Income Recognition

Interest income is recognized when earned and recorded on the accrual basis. Interest income includes earnings from interest-bearing cash accounts held by the Plan.

Benefits

Benefits are recognized when paid. Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processor that have not been reimbursed by the Plan are recorded as payable to the claims administrator in the accompanying statements of net assets available for benefits.

Prescription Rebates and Rebates Receivable

Prescription rebates due from the Plan's pharmacy benefit manager ("PBM") are recorded when earned. Rebates received subsequent to year-end for a coverage quarter during the year are recorded as a receivable on the accompanying statements of net assets available for benefits. Prescription rebates totaling \$69,186 and \$12,090 have been netted against claims paid for the years ended December 31, 2024 and 2023, respectively, on the accompanying statements of changes in net assets available for benefits. Prescription rebates receivables were \$40,831 and \$24,750 for the years ended December 31, 2024 and 2023, respectively.

Benefit Obligations

The Plan's third-party administrator estimates the obligation for claims incurred but not reported in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party administrator.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. For the years ended December 31, 2024 and 2023, total stop loss premiums, net reimbursements were \$260,377 and \$(478,707), respectively, have been netted with premiums paid in the accompanying statements of changes in net assets available for benefits.

Advanced Employer Contributions

Plan contributions to fund claims in excess of participant contributions that are recorded in advance will be recognized as advanced employer contributions.

3. Benefit Obligation

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. Meritain Health, Inc. Provider Agreement

Effective January 1, 2024, the Plan entered into an agreement with Meritain Health, Inc (the "Provider") as the claims administrator. Payments by the Plan to the Provider are based upon the amount of claims paid by the Provider during the preceding month plus a claims' administration charge.

Prior to January 1, 2024, the Plan entered into an agreement with Independence Administrators as the claims administrator.

The agreement specifies that in the event of termination of this agreement, the Company is liable for all claims incurred prior to the date of termination plus the claims' administration charge and other charges. The Provider will continue to administer payment for services incurred prior to termination, provided the request for benefits is received within eighteen months after the date the charges for services were effective.

5. Administrative Expenses

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company.

6. Tax Status

The Plan filed for tax exempt status for the VEBA trust as of the year ended December 31, 2024. The Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management of an entity to evaluate tax positions taken and recognize a tax liability if the entity has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

7. Priorities Upon Termination

It is the intent of the Finance Committee to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved by the Finance Committee. In the event of termination, the Finance Committee shall first satisfy the obligations of the Plan. Any remaining assets will be distributed in such manner as will in the opinion of the Finance Committee bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

8. Risks and Uncertainties

The benefit obligations are reported based on certain assumptions pertaining to unreported claims, reported but unprocessed claims, and processed but unpaid claims with a reserve factor applied. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.
