Opinion

We have audited the financial statements of The Sherwin-Williams Company Supplemental Unemployment Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Opinion

We have audited the financial statements of The Sherwin-Williams Company Supplemental Unemployment Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 – DESCRIPTION OF THE PLAN

Overview

The Sherwin-Williams Company Supplemental Unemployment Benefits Plan (the Plan) provides supplemental unemployment compensation benefits to assist the employment transition of eligible employees, as defined in the plan agreement, who suffer an involuntary qualifying termination from employment with The Sherwin-Williams Company (the Company) resulting from a workforce reduction, plant closing, job elimination or other similar condition.

The Plan's assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Administration Committee, as Plan Administrator, is responsible for the general administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides weekly supplemental unemployment benefits to participants who are involuntarily separated from current employment. Salaried participants receive a weekly benefit equal to 1/52 of their annual salary. Hourly participants receive a weekly benefit equal to the participant's base wage multiplied by the number of hours during a week for which the participant is regularly scheduled. The weekly benefit is reduced by amounts received by the participant in the form of state system unemployment. However, effective March 27, 2020, the state system unemployment shall not include the Emergency Increase in Unemployment Compensation to which a participant becomes entitled under Section 2104 of the "Coronavirus Aid, Relief, and Economic Security Act." This weekly benefit is payable to the participant until the participant loses eligibility, as defined in the plan agreement, but no longer than the maximum number of weeks allowable based on the participant's classification, as defined in the plan agreement. Eligible participants are required to verify their eligibility for the benefit each week in order for the benefit to be paid; as eligibility is determined weekly, the Plan records no liability related to this benefit. The maximum exposure to the Plan, is \$217,045 and \$197,521 at December 31, 2024 and 2023, respectively. The Plan's maximum exposure assumes that eligible individuals at December 31, 2024 and 2023 will remain eligible for the maximum number of weeks allowable under the plan agreement and be paid the corresponding maximum benefit.

Contributions

The Company makes contributions to the Plan as needed to fund the weekly supplemental unemployment benefits to participants. Any deficiency of the Plan's net assets available for benefits over the weekly supplemental unemployment benefits due to participants is funded by the Company on a pay-as-you-go basis.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Additional Information

Participants should refer to the plan agreement for a complete description of the Plan's provisions.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Due to the uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates in the near term could materially affect the amounts reported and disclosed in the financial statements.

Cash

The Plan maintains its cash account at a national financial institution. The balance, at times, may exceed federally insured limits.

Payment of Benefits

Benefits are recorded when distributed by the Plan to the Company. The Company distributes these amounts to participants via payroll.

Subsequent Events

Events occurring subsequent to December 31, 2024 have been evaluated through September 25, 2025, the date of the issuance of the financial statements, in accordance with the Subsequent Events Topic of the Accounting Standards Codification (ASC). During this period, there were no unrecognized subsequent events requiring recognition in the financial statements, and no non-unrecognized subsequent events requiring disclosure.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 4 – INCOME TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated July 30, 2018, stating that the trust is tax-exempt under the provisions of Section 501(c)(17) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Certain professional fees for the administration and audit of the Plan were paid by the Company.
