Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Jewish Federations of North America 403(b) DC Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Jewish Federations of North America 403(b) DC Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Jewish Federations of North America (the Sponsor or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan became effective beginning on August 1, 2013 for new and current employees of the Sponsor who are eligible to participate in the Plan on the date of employment. Teachers Insurance and Annuity Association and College Retirement Equities Fund (TIAA and CREF) are the custodian and recordkeeper of the Plan.

Contributions

The Employer made a discretionary matching contribution of 50% of an employee's contribution, limited to 3% of compensation for full-time employees and employees over the age of 21. Full-time employees over the age of 21, who worked 23 weeks or more from January 1, 2024 through December 31, 2024, were eligible for an additional Employer non-elective contribution of a discretionary amount based on compensation of 2%. For the year ended December 31, 2024, the Employer non-elective contributions was \$351,993.

Participants may contribute up to an elected percentage of their compensation, or a flat-dollar amount for the contribution period, subject to Internal Revenue Service (IRS) limitations (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to legal limits of \$7,500 for 2024. Participant contributions are recorded in the period during which the participant's salary is reduced under a salary reduction agreement with the Sponsor. Eligible participants are also permitted to make rollover contributions of amounts received from other tax-qualified Employer-sponsored retirement plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their participant contributions plus actual earnings thereon. A participant's vested interest in Employer contributions is based upon the participant's years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

On termination of service due to disability or retirement, a participant (or a designated beneficiary) may elect to receive the vested interest in his or her account in either a lump-sum amount or annual installments (including interest) for life. If the participant dies before distribution begins, the entire interest earned in the Plan will be distributed to the spouse or the named beneficiary by December 31 of the calendar year immediately following the calendar year of the participant's death. For termination of service resulting from other reasons, a participant may elect to receive the value of the account balance in his or her account as a lump-sum distribution or maintain his or her account balance within the Plan. If a participant terminates service and the value of the participant's vested account balance is not greater than \$1,000, the participant will receive a lump-sum distribution of the value of the entire account balance.

Notes Receivable from Participants

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance limited by the highest loan balance in the last 12 months. The Plan requires a minimum loan of \$1,000. Each note must be repaid within a period not to exceed five years, unless the note is for the purchase of a principal residence, for which it must be repaid within a period not to exceed ten years. The participant loans are secured by the balance in the participating account and bear interest at a fixed rate determined at the time of borrowing and is fixed for the life of the loan. Repayments are made directly to TIAA. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

Forfeited Accounts

Forfeitures from terminated non-vested Plan participants are used to pay all open expenses under the contract for the terminated participant. Any remaining funds are used as part of the non-elective discretionary Employer contribution of 2% of compensation. For the year ended December 31, 2024, forfeitures in the amount of \$55,991 were utilized to fund Employer contributions. At December 31, 2024 and 2023, the Plan had no forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date (the exit price). See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses

Certain administrative expenses are paid by the Sponsor and are excluded from these financial statements. Fees paid to TIAA and CREF for investment management fees and bookkeeping fees are paid by the Plan as a reduction of the investment returns (see Note 5).

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the overall fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies - Registered investment companies in the Plan are open-end mutual funds that are valued at unadjusted quoted market prices, which represent the net asset value (NAV) of shares owned by the Plan at year-end.

CREF Variable Annuity Contract - The CREF Variable Annuity Contract is valued using market quotations or prices obtained from independent-pricing services. The NAV is used as a practical expedient to estimate fair value. The fund determines its share price or NAV each day, calculated generally as of 4 p.m. (ET). The investment objective of the CREF Variable Annuity Contract is to have favorable long-term rate of return through capital appreciation and income from a broadly diversified portfolio. The CREF Variable Annuity Contract is managed using a combination of three different investment strategies—active management, quantitative and indexing, and investment in both domestic and foreign equities. There are no restrictions as to the redemptions of this investment and no unfunded commitments.

TIAA Real Estate Account - The TIAA Real Estate Account is valued at the accumulation unit value (AUV), which approximates fair value. The AUV is determined daily based on the NAV of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). There are no unfunded commitments. Transfers out of the TIAA Real Estate Account can be executed on any business day but are limited to once per every 90 days.

Insurance Company General Account - TIAA Traditional Non-Benefit Responsive Guaranteed Annuity Contract, or Retirement Annuity, is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by TIAA and valued at fair value, which approximates contract value. The contract value equals the accumulated cash contributions, interest credited, and transfers, less any withdrawals and transfers. TIAA Traditional Annuity provides a guarantee of principal; a guaranteed minimum rate of interest (generally 3%, but in some recent contracts, between 1% and 3%); and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year” that begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account are used to purchase a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional Annuity is annuitized based on available options, the present value of the stream of payments is

equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan. The portion of investments identified as TIAA Traditional Non-Benefit-Responsive Annuity are not benefit-responsive.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party Transactions and Party-in-Interest Transactions

The Plan's investments are products of TIAA and CREF. TIAA and CREF are the agents for JPMorgan Chase Bank N.A., the asset custodian of the Plan. For the year ended December 31, 2024, the Plan paid \$7,883 in administrative fees to TIAA and CREF, the recordkeeper of the Plan. Investment management and bookkeeping fees paid by the Plan to TIAA and CREF of \$99,703 during the year ended December 31, 2024 for services were included as a reduction of the investment return on each fund. These transactions qualify as party-in-interest transactions, which are deemed "exempt" from Prohibited Transaction Rules, as defined by the Department of Labor's (DOL) Rules and Regulations. Notes receivable from participants also qualify as exempt party-in-interest transactions.

6. Tax Status

The Plan has adopted the TIAA and CREF ERISA Volume Submitter 403(b) Plan, which has received an opinion letter from the IRS, dated August 7, 2017, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the IRC. In the opinion of the Plan's Sponsor, the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan qualifies for tax-exempt status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan that in general are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, employee and Employer contributions become 100% vested.

9. Subsequent Events

For the purpose of determining the effects of subsequent events on these financial statements, management has evaluated events through October 13, 2025, the date on which the financial statements were available to be issued.
