As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to audit procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Organization and Description of Plan

The following description of the Car Pros 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 401(k) plan covering all eligible employees of the Car Pros Automotive Group, Inc.; AMP Holding, Inc. dba Car Pros Kia Huntington Beach; Renton H, Inc. dba Car Pros Renton Hyundai; Renton K, Inc. dba Car Pros Renton Kia; Glendale K, Inc.; Car Pros El Monte, LLC dba Car Pros Honda El Monte; CPAG LA, Inc. dba BMW of Los Angeles, Mini of Los Angeles; and Moreno Valley K, Inc. (collectively referred to as "the Company") who have completed one year of service and have reached 18 years of age. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees the governance of the Plan, determines the appropriateness of the Plan's investment options with guidance from the Plan's investment advisor, and monitors Plan performance. The Company has contracted with a third party, Hidden Cove Wealth Management, to assist in determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan's investments are held by Reliance Trust Company (Reliance), the Plan's trustee.

Participant Contributions - Each year, participants may elect to defer and contribute a percentage of their compensation up to the Internal Revenue Service (IRS) maximum guidelines. Participants may elect to categorize any portion of their contribution under the Plan's Roth deferral feature. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at two percent of eligible compensation unless the participant selects otherwise. The automatic contribution rate is increased by 1% annually, not to exceed 10% unless otherwise directed by the participant.

Employer Contributions - The Company may make matching and profit-sharing contributions at its discretion. Any Company contributions will be allocated among all eligible employees who are employed on the last day of the plan year. For the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 25% of the first four percent of eligible compensation totaling \$173,053 and \$161,252, respectively. There were no discretionary nonelective contributions related to the 2024 plan year.

Participant Accounts - Individual participant accounts are maintained by Standard Retirement Services (The Standard), the Plan's recordkeeper. Each account is credited with the participant's contributions, the Company's contributions, investment earnings and losses, and administrative expenses, as applicable. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document.

Participants direct the investment of their account balances to any combination of the Plan's investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in benefits from company contributions plus actual earnings thereon is based on years of credited service, as defined in the Plan document, with 20% vesting after one year of service and 100% vesting after five years of service. Employees who die, become disabled, or reach the Plan's normal retirement age (65) become fully vested in their accounts.

Payment of Benefits - On termination of service, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, partial payments, or substantially equal installments. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (the Code). The Plan permits in-service distributions to participants meeting certain requirements, including distributions for financial hardship. A participant may also withdraw the portion of their vested account resulting from rollover contributions at any time.

Forfeited Accounts - Forfeitures by non-vested participants can be used to pay the Plan's administrative expenses, reduce future employer contributions, or allocated amongst eligible participant accounts, as defined in the plan agreement. During 2024, \$11,351 of forfeitures were used to reduce Plan expenses. Forfeited non-vested accounts totaled \$4,916 and \$2,169 at December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (if any) is recorded on the accrual basis. Dividends (if any) are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's investment fund options are subject to investment management fees and certain revenue sharing fees, as disclosed in each fund's prospectus. A majority of these fees are charged directly against each fund's investment performance and, therefore, are included in net appreciation/depreciation in the accompanying Statement of Changes in Net Assets Available for Benefits. Any remaining unpaid Plan administration expenses, including the annual audit fee, are paid by the Company and therefore excluded from these financial statements. Distribution transaction fees charged by Reliance, the Plan's custodian, are deducted from the accounts of the respective Plan participants and are recorded as expenses by the Plan.

Subsequent Events - The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 - Group Annuity Contract with Standard Insurance Company

Through a group annuity contract, the Plan offers a traditional fully benefit-responsive investment option (Stable Account). The objective of this fund is to provide a stable rate of return along with principal preservation for participants regardless of market fluctuations. The Stable Account is invested in the general asset account of Standard Insurance Company (Standard) and is guaranteed by their claims paying ability. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed quarterly for resetting. The Stable Account meets the fully benefit-responsive investment criteria, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan terminations or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 4 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 Fair Value Measurements - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing prices as reported by the Fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

The Plan's investments at fair value consist solely of mutual funds, which are valued as of December 31, 2024 and 2023 using level 1 measurement.

Note 5 - Information Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Standard, therefore, transactions with Standard qualify as party-in-interest transactions. In addition, expenses paid by the Plan are to parties-in-interest as defined by ERISA. Furthermore, as described in Note 8, the Plan has adopted a pre-approved plan.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8 - Tax Status

The Plan has adopted a pre-approved profit sharing plan that received an opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as designed, complied with the applicable requirements of the Code.

Note 8 - Tax Status (continued)

The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 10 - Delinquent Participant Contributions

As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, during the year ended December 31, 2024, participant contributions in the amount of \$28,991 were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt party-in-interest transactions between the Plan and the Employer. Plan management intends to self-correct for associated lost earnings on these contributions during the year ended December 31, 2025.
