## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of

### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

### (MODIFIED CASH BASIS)

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

**General**—The United Parcel Service Health and Welfare Plan Trust for Collectively Bargained Employees (“VEBA” or “Master Trust”) was established on December 30, 1992 and has been amended periodically. The VEBA is the funding vehicle for the UPS National LTD Plan, the UPS Health and Welfare Plan, the UPS Health Care Package, the UPS Health and Welfare Package (the “Plan”), the UPS Health and Welfare Package for Retired Employees, the UPS Crewmembers Benefit Package, the UPS Crewmembers Benefit Package for Retired Employees, the UPS Health and Welfare Package Select, the UPS National Health Plan for Part Time Employees, the UPS Health and Welfare Package Select—Hawaii and the UPS Health Program Plan (collectively, the “Plans”).

The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan’s Administrative Committee controls and manages the operation and administration of the Plan. Plan assets are held in the Master Trust for which the Bank of New York Mellon (“Mellon Trust”) serves as the trustee (“Trustee”).

**Contributions**—The VEBA receives and invests contributions from both United Parcel Service, Inc. (the “Plan Sponsor”, “employer” or “UPS”) and participants of the Plan. Participant contributions consist substantially of Consolidated Omnibus Budget Reconciliation Act (COBRA) of 1986 payments. In addition to deductibles and copayments, participants contribute specified amounts based on applicable premiums for their respective benefit elections. The amount to be contributed by participants is determined annually based on several factors. For the health savings accounts (HSA), employees contribute amounts to individual accounts through salary reductions; HSA contributions do not expire.

The majority of employer contributions to the Master Trust are allocated to each plan based upon the level of service provider payments (benefit payments, premiums (if any) plus administrative expenses, net of employee contributions) made on behalf of the applicable plan as compared to total service provider payments of the VEBA, net of employee contributions.

The cost of the Plan is shared by the participants and the employer on a basis determined by the employer and applicable collective bargaining agreements. Participants are charged a premium based on their election of coverage.

The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is expected to be funded by the Plan Sponsor on a pay-as-you-go basis.

**Benefits**—The Plan provides health and welfare benefits (including health, dental, vision, certain types of life insurance, and short-term disability benefits) to certain groups of full-time collective bargaining unit employees of UPS and employee dependents. The Plan also provides continuation of certain benefits upon termination of employment through COBRA.

**Changes to the Delivery of Health Care Benefits**—As of December 31, 2013, the majority of the participants of the Plan were employed by UPS under a national master agreement (NMA) and various supplemental agreements with local unions affiliated with the International Brotherhood of Teamsters (“Teamsters”). This national master agreement had expired on July 31, 2013 but had been indefinitely extended pending the ratification of a new agreement with the Teamsters. On April 24, 2014, the Teamsters ratified a new NMA with UPS that expired on July 31, 2018. A new master contract, effective April 29, 2019, was negotiated. This five-year contract ran through July 31, 2023. On July 25, 2023, a tentative new collective bargaining agreement was reached with the Teamsters representing employees in the U.S. Domestic Small Package business unit. On August 22, 2023, the UPS Teamster represented employees ratified this new agreement, which covers a five year period through July 31, 2028.

Effective June 1, 2014, the Plan Sponsor ceased providing health care benefits to the majority of the participants through this UPS-sponsored benefit plan, and the responsibility for providing health care benefits for those employees was assumed by three separate multiemployer health care funds (the “Funds”). The Plan Sponsor will make contributions to the Funds based on negotiated fixed hourly or monthly contribution rates for the duration of the NMA and other applicable collective bargaining agreements.

**Termination**—Although it has not expressed any intention to do so, UPS has the right under the Plan, subject to collective bargaining agreements, to modify the benefits provided to active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, UPS will contribute the necessary amounts to fund all applicable expenses incurred prior to the date of the termination.

**Amounts Due from the UPS Flexible Benefits Plan** —Claims payments of \$1,097,707 for the UPS Flexible Benefits Plan were paid from the UPS Health and Welfare Package Plan in 2024. A receivable has been recorded to reflect this amount as of December 31, 2024; the amount was settled in March 2025.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The Plan prepares its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Contributions are generally recorded when received and claims, premiums, and administrative expenses are generally recorded when paid. Benefit obligations are not recorded in the statements of net assets available for benefits; however, they are disclosed on an accrual basis in Note 5.

**Use of Estimates**—The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, disclosure of benefit obligations and changes therein, claims payable, claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**—The Plan’s and Master Trust’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Investment income allocated from the Master Trust includes the Plan's proportionate share in the Master Trust's gains and losses in investments bought and sold as well as held at year-end.

**Claims Incurred but Not Reported**—As reported in Note 5, the Plan's liability for active participant health claims incurred but unreported at year-end is estimated using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in the prior years.

**Claims and Premiums Paid**—Claims and premiums are recorded when paid.

**Postemployment Benefit Obligation**—The postemployment benefit obligation for disability and COBRA benefits for inactive participants, beneficiaries, and dependents is estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in Note 5 at present value based on several assumptions including a discount rate of 5.82% and 6.06% at December 31, 2024 and 2023, respectively.

For 2024 and 2023, the mortality assumptions used are based on the Pri-2012 healthy blue collar mortality table, with MP-2021 mortality improvements after 2012 assuming the long-term rate of mortality improvement phases down to 0.5% by 2029 and 2028, respectively.

For 2024 and 2023, the disabled life mortality rates based on Pri-2012 disabled mortality table, MP-2021 mortality improvements after 2012 assuming the long-term rate of mortality improvement phases down to 0.5% by 2029 and 2028, respectively.

For 2024 and 2023, the termination from disability rates are based on the 2012 Group Long Term Disability Basic table, reflecting the 2019 GLTD Experience Study Preliminary Report, with 6 month elimination period, excluding freight.

Other assumptions are as follows:

**Duration—Short-Term Disability**—If the number of actual elapsed weeks is less than 10, the assumed remaining duration is 10 weeks less the elapsed number of weeks. Otherwise, if the number of actual elapsed weeks is greater than or equal to 10, the assumed remaining duration is 20 weeks less the elapsed number of weeks.

**Duration—COBRA**—At December 31, 2024, survivors receiving a UPS subsidy are assumed to remain enrolled for as long as their subsidy is available. Other participants who have enrolled are assumed to remain enrolled for the duration of their COBRA eligibility. At December 31, 2023, participants who had taken more than half of the initial maximum benefit period were assumed to take one-half of the remaining maximum benefit period. Other participants were assumed to take one-half of the initial maximum benefit period less the number of months already taken.

For the December 31, 2024 valuation, the annual rate of increase in health care costs was assumed to be 7.5% in 2025, grading down by 0.25% in years 2026 through 2037 and remaining at 4.5% thereafter.

For the December 31, 2023 valuation, the annual rate of increase in health care costs was assumed to be 7.25% in 2024, grading down by 0.25% in years 2025 through 2035 and remaining at 4.5% thereafter.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postemployment benefit obligation.

**Administrative Expenses**—Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document.

**Refunds and Other Receivables**—Rebates due from the Plan’s pharmacy benefits manager are recorded when earned and estimatable. Pharmacy rebates totaling \$7,048,840 have been netted with claims disbursements to providers in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. \$2,524,611 has been recorded but not yet received as of year-end and is reported within other receivables in the statement of net assets available for benefits as of December 31, 2024.

**Risks and Uncertainties**—The Plan (through the Master Trust) utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of postemployment benefit obligation is reported based on certain assumptions including those pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**Subsequent Events**—Management has evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued. There are no subsequent events that require adjustment to or disclosure in the financial statements.

### 3. MASTER TRUST

The Master Trust investments are stated at fair value as determined and reported by the Trustee in accordance with the Master Trust Agreement established by the Plan Sponsor. The value of the assets held by the Master Trust is determined based on the fair value of the underlying assets. Use of the Master Trust permits commingling of the Plan’s assets with the assets of the other Plans in the Master Trust.

The Plan’s interest in the Master Trust represents 0.87% and 11.70% of the Master Trust’s net assets at December 31, 2024 and 2023, respectively.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual participant contributions, allocated employer contributions, allocated investment income, less actual claims netted against refunds, less premiums paid and administrative expenses, as applicable.

The investment income of the Master Trust during 2024 is \$127,730, which consisted of interest income.

Investment income is allocated annually from the Master Trust to each plan based upon the investment income for the year compared to each plan's relative expenses.

The assets of the UPS National LTD Plan, while residing within the Master Trust, are held in a separate account and are not permitted to be commingled with other plans within the Master Trust. The Plan Sponsor maintains supporting records for purposes of allocating assets, liabilities, income, and expenses based upon the relative benefit reimbursements of each plan.

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

As of December 31, 2024, the fair value of the Master Trust investment in the interest-bearing cash account is valued at cash plus interest earned (Level 2 inputs within the fair value hierarchy). As of December 31, 2023, the fair value of the Master Trust investment in the money market mutual fund is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs within the fair value hierarchy).

#### **4. FEDERAL INCOME TAX STATUS**

The Master Trust established under the Plan to hold the Plan's assets is intended to qualify as a VEBA trust under Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Master Trust's net investment income is exempt from income taxes. The Master Trust has obtained an exemption letter dated May 26, 1993, from the Internal Revenue Service (IRS). The Plan Sponsor believes that the Master Trust, as amended, continues to qualify and operate in accordance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes the Plan is no longer subject to income tax examinations for years prior to 2022.

Plan investments are managed by Mellon Trust. Mellon Trust is the trustee as defined by the Plan document. Transactions involving Mellon Trust investments qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on investments.

The Plan Sponsor provides certain accounting and other exempt administrative services for the Master Trust but receives no reimbursement from the Master Trust or Plan for these services. These transactions are exempt party-in-interest transactions under ERISA.
