Note 1 – Plan Description and Basis of Presentation

The following brief description of the ARGI Profit Sharing Plan, formerly ARGI Holdings, Inc. Employee Stock Ownership Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

ARGI Holdings, Inc. and its wholly-owned subsidiaries established the Plan effective January 1, 2015. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 6, 2023, ARGI Holdings, Inc. entered into an asset purchase agreement with an independent third party to sell 100 percent of its assets. All participants of the Plan became 100 percent vested in their account balances at that time. The Plan is eligible to receive additional consideration as part of the transaction through 2026. As a result of the transaction, the Plan was frozen to new participants, effective December 31, 2022. The ESOP notes were paid in full and all unallocated shares were allocated among the participants. Participants had the option to distribute to another qualified retirement plan, IRA, or take a taxable distribution. Any additional consideration received will be allocated pro-rata to participant accounts based on the number of shares held by each participant. In December 2023, the Plan entered into a contribution and exchange agreement with the Company to exchange all 303,577 shares of ARGI Holdings, Inc. for 100 percent of the units of ARGI ESOP Distribution, LLC. ARGI ESOP Distribution, LLC (Company) holds the rights to the Plan's share of any additional consideration from the January 6, 2023 transaction. Plan management and the Trustee determined the value of the ARGI ESOP Distribution, LLC was approximately \$0 at December 31, 2023. In January 2024, the Plan was amended to change the Plan name to ARGI Profit Sharing Plan and ARGI ESOP Distribution, LLC became the Plan Sponsor.

Contributions

The Company will make contributions as additional consideration is earned in accordance with the asset purchase agreement through 2026.

Payment of Benefits

Upon a participant's election to receive a distribution from the Plan, a minimum of 75 percent of the participant's account balance shall be distributed. Participants are no longer entitled to receive installment payments. The distributions are to be distributed in the form of one lump-sum, a direct rollover, or a transfer to another qualified retirement Plan maintained by the Company. All such distributions shall be paid in cash.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. As of December 31, 2024 and 2023, all participant accounts are credited with earnings and expenses of the Plan based on the participants' pro rata share of Plan assets when the Plan was frozen, effective December 31, 2022.

Vesting & Forfeitures

As a result of the sale transaction, all existing participants became fully vested in their accounts at December 31, 2022. There were no forfeitures for the years ended December 31, 2024 and 2023.

Reclassification

Certain items in the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 classifications.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Plan Amendment

Effective January 1, 2024, the Plan converted to a profit sharing plan, was renamed to ARGI Profit Sharing Plan, and the Plan Sponsor is ARGI ESOP Distribution, LLC.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Accounts consist of a money market account and a money market fund that are valued on the basis of readily determinable market prices.

Note 5 – Administration of Plan Assets

The Plan's assets, which consist primarily of interest-bearing cash, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income (if any) and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 6 – Related Party and Party-in-Interest Transactions

As described in Note 1, the Company or the Plan pays all Plan expenses. The Plan has a number of service providers and paid approximately \$29,942 to these service providers as of December 31, 2024. Such parties are parties-in-interest under ERISA.

Note 7 – Concentrations of Credit Risk

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of cash. At times, such cash in banks may be in excess of the Federal Deposit Insurance Corporation insurance limit.

Note 8 – Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the ARGI ESOP Distribution, LLC. Plan Committee directs the Trustee to pay all liabilities and expenses of the Plan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code (IRC).

Note 9 – Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated March 2, 2017 stating that the Plan is qualified under the IRC and; therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 10 – Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
