Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Wingate Management Company 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Wingate Management Company 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

NOTE 1: DESCRIPTION OF PLAN

The following description of the Wingate Management Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined-contribution plan established January 1, 2009, covering all employees of Wingate Management Company, LLC, Bluestone Management Services Limited Partnership, Rush Management Company, LLC, and certain affiliates and subsidiaries (collectively, referred to as the "Company") who complete 30 days of service and are of age 21 or older. Effective January 1, 2025, the required service was changed to 60 days. Employees who are leased employees, covered by a collective bargaining agreement, or nonresident aliens are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Participants may elect to make voluntary pre-tax contributions not to exceed the dollar limit which is set by law. Participants may designate a portion, or all, of their deferral contributions as Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their deferral percentage on the first day of each month.

For employees hired after September 1, 2024, unless instructed otherwise by the participant, upon becoming eligible to participate in the Plan, 3% of the participant's eligible compensation will be contributed to the Plan subject to annual limits set by the Internal Revenue Service ("IRS"). Unless the participant elects otherwise, the participant's deferral percentage will increase by 1% automatically on an annual basis up to a maximum of 10%.

Each year, the Company may make a discretionary matching contribution that is paid to the employee each pay period. The Company matched 65% of the participants' first 3% of compensation for participants with base earnings under \$70,000 and 50% of the participants' first 3% of compensation for participants with base earnings equal to or greater than \$70,000, with a maximum of \$1,500.

The Company can also make a non-elective contribution that is allocated to participants based on the ratio of their compensation to total compensation. For the year ended December 31, 2024, the Company did not make a non-elective contribution.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

WINGATE MANAGEMENT COMPANY 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. The loans are secured by the balance in the participants' account and bear interest at rates being charged by representative commercial banks in the local area for a similar loan (ranging from 4.25% to 9.50% at December 31, 2024). Principal and interest are paid ratably usually through payroll deductions.

Payment of Benefits: Benefits are payable in a lump sum payment upon the normal retirement age of 65, in service withdrawals after age 59½, death, permanent disability, separation of service, or reasons of proven hardships.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. The vesting period for employer discretionary matching and non-elective contributions is as follows:

Less than 2 years	0%
2 years or more	100%

Forfeited Accounts: Forfeitures may be used by the Plan to reduce the employer matching contribution or for the payment of Plan expenses. The balance in the forfeited non-vested account was \$297 and \$9 at December 31, 2024 and 2023, respectively. In 2024, employer contributions were reduced by \$3,929 from forfeited non-vested accounts.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements and supplemental schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

WINGATE MANAGEMENT COMPANY 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and other parties involved with the Plan. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contribution Refundable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits: Benefits paid to participants are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for doubtful credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Expense Account: As part of the recordkeeping and administrative service fee arrangement with Empower Retirement LLC, Empower Retirement LLC agrees to reimburse revenue to the Plan in excess of the agreed upon service fee structure. The Plan may use the credit to pay direct and necessary expenses of the Plan or allocate unused credit to eligible participants. During 2024, a revenue credit of \$41,537 was used to pay necessary expenses and is netted with administrative fees on the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the unused revenue credit program account totaled \$26,527 and \$36,182, respectively.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Uncertain Tax Positions: GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan engages in investment transactions with funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians as defined by the Plan. In addition, the Plan engages with an investment advisor, auditor and recordkeeper. These transactions qualify as party-in-interest transactions. Administrative expenses paid to these parties were \$76,651 for the year ended December 31, 2024.

NOTE 4: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment contract with insurance company: The Plan has a contract with Empower Annuity Insurance Company of America. Under the contract, which is considered non benefit-responsive, deposits of contributions received are invested in the contract. The contract is included in the financial statements at fair value using a discounted cash flow valuation methodology where the interest rate for the portfolio investment contract is reset at least as frequently as annually. Fair value of the investment contract, prior to contract termination, equals the contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6: TAX STATUS

On June 7, 2021, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended since the latest determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7: RISKS AND UNCERTAINTIES

Plan assets are invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
