### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Schaedler/Yesco Distribution, Inc. Flexible Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits and statement of benefit obligations as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As further discussed in Note 1 to the financial statements, during 2024, plan management approved the termination of the Plan, effective upon final payout of the remaining funds in the Plan, and determined liquidation was imminent. As a result, the Plan used the liquidation basis in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

#### **Note 1 - Description of Plan**

The following description of the Schaedler/Yesco Distribution, Inc. Flexible Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan was a defined benefit health and welfare plan that provided benefits to all regular full-time and part-time employees of Schaedler/Yesco Distribution, Inc. and Atlantic Energy Concepts, Inc. (the Company) who worked at least 30 hours per week and had completed 60 days of service as well as former employees who elected coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Benefits were also provided to dependents of these individuals who elected coverage on their behalf. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was a member of Keystone Benefits Partners, LLC (KBP) which was a member owned, member governed organization of employers. The members collectively negotiated and purchased employee benefits and participated in risk and cost management programs. The funds of the Plan were held in the Keystone Benefits Trust, through which expenses of the health plans are paid. The employees were required to pay for a portion of the cost of the benefit.

Effective April 1, 2024, the Company, while still a member of KBP, transitioned its medical coverage to a SelfPay medical program. Under this arrangement, the Company began paying claims and administrative expenses directly from its general assets, rather than through the Keystone Benefits Trust. As part of this transition, a new plan was established to account for the SelfPay medical program, and management elected to terminate the existing Plan. Beginning April 1, 2024, no new participants are eligible to join the Plan. Activity from April 1, 2024 through December 31, 2024 in the accompanying financial statements represents the runout of health claims that occurred prior to April 1, 2024. Effective December 31, 2024, the Plan terminated its membership with KBP.

##### **Contributions**

The Company would contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provided stop loss insurance over a specified amount as per agreement with the reinsurance carrier through March 31, 2025, with the premiums being paid by funds deposited in the Plan. The Company was required by the termination agreement to deposit \$513,267 to cover the runout of health claims. Any remaining deposit will be returned to the Company after one year from the termination date.

Employee contributions were determined on a fixed fee basis. The amount varied depending on the selection of individual or eligible dependent coverage.

##### **Benefits**

The Plan provided medical and prescription drug benefits to substantially all employees of the Company who met the age and service requirements of the Plan and to their covered dependents through March 31, 2024. Dependents were eligible if they were a covered employee's spouse or unmarried child (or someone to whom they are legal guardian) under the age of 26 (and children must be primarily dependent upon the employee). Children of any age could be covered if the child was disabled - meaning they could not maintain employment due to mental or physical handicap, etc. The Plan also provided continuation of certain benefits upon termination of employment through the COBRA as defined in the plan document.

##### **Benefits (continued)**

The Company provided most health insurance benefits and paid the administrative fees incurred. The employees paid a portion of their health coverage based upon the coverage chosen through payroll deferrals.

Health claims were processed through the Aetna network from January 1, 2023 through December 31, 2023 and through the Highmark network from January 1, 2024 through December 31, 2024.

#### **Note 2 - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan was imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The accompanying financial statements for 2023 were prepared as a going concern on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported (IBNR), claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

All investments in the 2024 statement of net assets available for benefits are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation. All investments on the 2023 statement of net assets available for benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income for the year ended December 31, 2024 was recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Interest income for the year ended December 31, 2023 was recorded on the accrual basis.

##### **Payment of Benefits**

Premiums paid by the Company or the trust were recorded as premium payments in the accompanying statement of changes in net assets available for benefits when paid.

Claim payments were recorded when paid by the third-party claims processor.

##### **Stop Loss Insurance**

The Plan has a stop loss insurance arrangement whereby the stop loss insurance would cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$90,000 per covered person for the years ended December 31, 2024 and 2023.

In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$107,274 and \$1,308,345 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

##### **Plan Benefit Obligations**

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's actuary. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. Due to the Plan termination, there was no benefit obligation at December 31, 2024. As of December 31, 2023, benefit obligations for claims that had been incurred but not paid totaled \$481,560. This amount was paid in the plan year ended December 31, 2024. It is the Plan's policy that deductions for claims are recorded when paid.

##### **Administrative Expenses**

The Plan's assets were administered under a contract with Wilmington Trust, the custodian of the Plan. The Plan paid administrative expenses that consisted primarily of administrative fees paid to third-party administrators, the custodian, and actuary. These expenses were reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, were paid by the Company on behalf of the Plan.

#### **Note 3 - Information Certified and Provided by Wilmington Trust**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and accrued interest at December 31, 2024 and 2023, and interest income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Wilmington Trust (the custodian of the Plan).

#### **Note 4 - Plan Administration**

Effective January 1, 2024, the Plan entered into a service agreement with Highmark (Aetna prior to January 1, 2024) to provide consulting and administrative services. Highmark was responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services, or to the employee in accordance with the terms of the Plan. Highmark charged a fee based on the number of employees participating in the Plan.

#### **Note 4 - Plan Administration (continued)**

During the year ended December 31, 2024, the Company experienced negative administrative fees associated with its medical plan. These negative fees resulted from rebates provided by the network. In accordance with accounting principles generally accepted in the United States of America, these negative fees were recorded as a reduction in administrative expenses rather than as revenue. This treatment ensured that the financial statements accurately reflect the net cost of administering the medical plan. This net amount is shown in the accompanying statement of changes in net assets available for benefits.

#### **Note 5 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Shares of the money market fund were valued at the quoted net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 6 - Tax Status

The Plan was funded through a non-qualified trust under Internal Revenue Code (IRC) 419(a). The trust filed Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believed that the Plan was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - Risks and Uncertainties

The Plan invested in a money market fund. Money market funds are exposed to various risks such as interest rate, market, and credit risks. Due to the minimal level of risk associated with money market funds, it was unlikely, but remotely possible, that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions, including level of past claims. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments were managed by Wilmington Trust, the custodian of the Plan and; therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management and custody services were immaterial.
