NOTE 1 – DESCRIPTION OF PLAN

Midwest Cardiovascular Institute 401(k) Profit Sharing Plan (the Plan) is a multiple-employer qualified retirement plan covering employees of Midwest Cardiovascular Institute S.C. (Midwest), Cardiovascular Institution of the South (Cardiovascular), Cardiovascular Logistics of Chicago, LLC (collectively, the Company), and any affiliate who has adopted the Plan. The Plan was effective July 1, 2021, to provide its employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Company.

Eligibility: All non-excluded employees of the Company are eligible to participate in the Plan once they have attained age 18 and completed 30 days of service for salary deferrals and one year of service for Company contributions. Participants may enter the Plan on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements for salary deferrals and on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date they satisfy the eligibility requirements for Company contributions.

Contributions: Participants can make salary deferrals to the Plan. Salary deferrals can be pre-tax contributions or Roth deferrals. The Internal Revenue Service (IRS) imposes limits on the amount of contributions a participant can make to the Plan each calendar year. Participants at least age 50 may make catch-up contributions to the Plan. Participants can change, modify, or revoke their contributions at any time. The Plan is also set up with an automatic deferral and automatic increase feature. Unless the participant elects otherwise, the Company will automatically withhold 3% of their compensation each payroll period and increase 1% each year thereafter up to maximum of 9% of their compensation.

The Company may make a discretionary matching contribution equal to a percentage of participants' salary deferrals. During 2024, the Company matched 20% of the participants' elective deferrals up to 6% of eligible compensation. During 2024, the Company made discretionary matching contributions in the amount of \$188,493.

The Company may also make a discretionary profit-sharing contribution to the Plan based on a discretionary formula that is determined each year. During 2024, the Company contributed an additional profit-sharing amount equal to 7.5% of compensation up to \$160,000 plus 13.2% of compensation from \$160,000 to \$330,000. A participant will be eligible to receive an allocation if they have completed at least 1,000 hours of service during the applicable period and are employed by the Company on the last day of the applicable period. During 2024, the Company made discretionary profit-sharing contributions in the amount of \$1,490,715.

Participants may be permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their contributions attributable to elective deferrals including Roth 401(k) deferrals, catch-up contributions, and rollover contributions. Vesting for Company contributions is based on a six-year vesting schedule, in which participants earn 20% vesting after two years of service and thereafter each subsequent year until they reach 100%.

Payment of Benefits: If a participant terminates employment for reasons other than retirement, disability, or death, and their vested account balance does not exceed \$5,000, a distribution of their vested account balance will be made as soon as administratively feasible in a single lump-sum payment in cash, regardless of their consent to receive it. If a participant's vested account balance does not exceed \$5,000, but the distribution amount exceeds \$1,000 and the participant does not elect to either receive or roll over the distribution, their distribution will be directly rolled over to an IRA. If a participant's vested account balance exceeds \$5,000, they may elect to receive a distribution of their vested account balance in a single lump-sum payment, installments, or ad-hoc distributions. They must consent to any distribution before it may be made.

Participants may be entitled to receive an in-service distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59 $\frac{1}{2}$.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the last 12 months. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions over a five-year period unless it is for the purchase of a principal residence, in which case the loan repayment period will be 30 years from the date of the loan. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay Plan expenses or to reduce any Company contributions. As of December 31, 2024 and 2023, the forfeiture account totaled \$32,953 and \$13,223, respectively. During 2024, \$32,985 of forfeitures were used to reduce employer contributions. In addition, during 2024, \$23,930 of forfeitures were used to pay Plan expenses.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will continue to be 100% vested. The Company will direct the distribution of participant accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025 (effective date), the Plan was merged into the Cardiology Management Holdings Retirement Plan (CMH Retirement Plan). As a result of the merger, all assets were transferred out of the Plan to the CMH Retirement Plan. As of the effective date, participants of the Plan became participants in the CMH Retirement Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company and Voya Retirement Insurance and Annuity Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values (NAV) per unit as reported by the fund managers. These funds permit daily redemptions at NAV with no advance notice requirement, and there are no redemption restrictions or unfunded commitments related to these investments.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract with VOYA Life Insurance and Annuity Company (VOYA Life). VOYA Life maintains the contributions in a general account that has a guaranteed minimum interest rate of 1%. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by VOYA Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Subsequent to year end, effective January 1, 2025, the Plan merged with another qualified plan. The merger did not impact the Plan's ability to transact at contract value with participants. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments managed by Voya Institutional Trust Company and Voya Retirement Insurance and Annuity Company reflect party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.


