### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the accompanying financial statements of Sutton Bank Employee Stock Ownership and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Significant accounting policies followed in preparing the financial statements of Sutton Bank Employee Stock Ownership and 401(k) Plan (the Plan) are presented below.

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor, Sutton Bank, and are excluded from these financial statements. Certain investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Management evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 2 DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was initially established as a profit sharing plan and trust effective January 1, 1986. Effective January 1, 2006, the Plan was converted to an employee stock ownership plan, as defined in Section 4975(e)(7) of the Internal Revenue Code (IRC), with a 401(k) feature. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective August 13, 2021. The Plan has been established for the purpose of providing benefits to the employees of Sutton Bank, a wholly owned subsidiary of Sutton Bancshares, Inc. (the Employer).

All employees of Sutton Bank who are expected to complete 1,000 hours of service during a 12-month period are eligible to participate in the Plan. Participants may enter the Plan upon completion of 90 days of service. Participants are eligible for the discretionary profit sharing contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year.

An officer of Sutton Bank and a member of outside legal counsel serve as trustees for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Plan participants may defer and contribute not less than 1%, but up to 100% of their compensation, as defined, as pre-tax 401(k) or Roth contributions, subject to certain limitations as specified in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer makes a safe harbor matching contribution and may, at its discretion, elect to make an additional matching and profit sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the Employer safe harbor matching contribution was 100% of the first 3% and 50% of the next 3% of eligible compensation that a participant contributed to the Plan, not to exceed a total safe harbor matching contribution of 4.5% of eligible compensation. For the years ended December 31, 2024 and 2023, the Employer discretionary profit sharing contribution was 3% of eligible participant compensation. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Investment Options**

Participants direct the investment of deferral and rollover contributions into various investment options offered by the Plan. Employer safe harbor and discretionary contributions are primarily invested in Sutton Bancshares, Inc. common stock.

In lieu of purchasing common shares, safe harbor matching and discretionary contributions may be used to pay the stock portion of the accounts of participants receiving benefits. The Plan recognizes Employer contributions receivable for the amount of Employer contributions that have not yet been used to purchase stock less the amount of Employer contributions that have been used to pay the stock portion of the accounts of participants receiving benefits.

**Participant Accounts**

A separate individual account has been established for each participant. The balance of each participant's account consists of participant deferral contributions, as well as any rollover contributions, and matching and profit sharing contributions made on behalf of the participant by Sutton Bank, including investment earnings or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Each participant's allocation of Sutton Bancshares, Inc. common stock and Employer contributions receivable is determined based on matching and profit sharing contributions made on their behalf by Sutton Bank, taking into consideration the average purchase price of the stock during the period. Dividends from Sutton Bancshares, Inc. common stock are invested at the direction of the participants in Sutton Bancshares, Inc. common stock or other investment options offered by the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Diversification Rights**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Employer common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify, transfer the diversified account balance into the other investment options offered by the Plan.

**Vesting**

Participants are immediately vested in any deferral, rollover, and safe harbor matching contributions made to the Plan, including earnings or losses thereon. Vesting in discretionary matching and profit sharing contributions made by Sutton Bank, plus earnings or losses thereon, is based on years of credited service. Participants vest at 20% per year upon completion of two years of credited service and are fully vested upon completion of six years of service. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeited Accounts**

In the event a participant terminates prior to becoming fully vested, the unvested portion of the participant's matching and profit sharing contributions represents forfeitures upon distribution of the vested portion of the participant's account or upon completion of five consecutive one-year breaks in service. Forfeitures are available to pay administrative expenses of the Plan or may be allocated to remaining participants at the discretion of the trustees of the Plan. There were \$10,363 and \$16,167 of forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures reallocated to remaining participants for the years ended December 31, 2024 and 2023. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$40,193 and \$57,291, respectively.

**Payment of Benefits**

The normal retirement date is the date a participant reaches age 62. When a participant reaches normal retirement date, terminates employment with Sutton Bank, becomes totally disabled, or dies while participating in the Plan, they are entitled to receive the vested amount in their individual account.

Distributions of Sutton Bancshares, Inc. common stock are determined at the time of request based on the preceding December 31 value of the stock. The trustees may elect for the Plan to pay over a five-year period, commencing five years subsequent to the separation date (as defined in the Plan), the stock portion of the account of participants receiving benefits. Participants in payout continue to receive dividends on shares allocated to their individual accounts. If a participant is age 62 or disabled, the trustees may elect for the Plan to pay the stock portion of the participant's account over a five-year period, commencing one year subsequent to the separation date.

If a participant dies before receiving all of the benefits in their account, the surviving spouse or designated beneficiary receives the remainder in the participant's account either as a lump sum or in the form of partial withdrawals provided the minimum withdrawal is \$1,000.

The Plan also provides for hardship withdrawals and in-service distributions at age 59-1/2 subject to Plan provisions.

**Voting Rights**

Voting rights attributable to the shares allocated to the Plan generally rest with the trustees except in the case of certain triggering events, such as a sale or merger, in which case participants may have the right to vote their allocated shares. The trustees are required to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

**Put Option**

Under federal income tax regulations, Sutton Bancshares, Inc. common stock held by the Plan and its participants and not readily tradable on an established market, or subject to trading limitations, must include a put option. The put option is a right to demand that the Employer repurchase any shares of the stock allocated to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

**NOTE 4 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants become fully vested in their account balance.

**NOTE 5 PLAN TAX STATUS**

The IRS has determined and informed the Employer by a letter dated August 15, 2016, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Sutton Bancshares, Inc. Common Stock:* Valued at the minority share value determined annually based on a valuation performed by an independent certified appraiser considering discounted cash flows, the market value of assets less market value of liabilities, price-to-earnings multiples, and price-to-tangible book value ratio for selected publicly traded companies.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 7 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g. divestitures or spin-offs of a subsidiary, etc.) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's assets include common stock of the Employer held by the Plan trustees. 825 and 2,797 shares were purchased in the years ended December 31, 2024 and 2023, respectively. Employer contributions and distributions to participants are managed by the trustees. The Plan is administered by the Employer and certain administrative functions are outsourced to a third-party administrator. A certain officer of the Employer and a member of outside legal counsel are Plan trustees. Certain administrative functions are performed by officers or employees of the Employer who do not receive compensation from the Plan.

Certain Plan investments represent shares of pooled separate accounts and a fully benefit-responsive investment contract managed by Voya. Voya is the insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with certain investment securities and to uncertainties inherent in the estimations and assumption process, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the participant accounts and the statements of net assets available for benefits.

The Separate Account D is a pooled separate account, as classified in the financial statements included herein. The pooled separate account did not file a Form 5500 for the direct filing entity, therefore, the underlying assets have been reported on the Form 5500, Schedule H.
