These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For

information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Marlins Teamco LLC 401(k) Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan was established by the Plan Sponsor, Marlins Teamco LLC (the “Company” and “Plan Sponsor”) on February 16, 2002. The Plan is a defined contribution plan covering employees of the Company and Marlins Stadium Operator, LLC, over the age of 21 with at least one year of service, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan was amended effective July 1, 2013, to allow the Company to make matching contributions. Effective July 1, 2018, the Plan was further amended to allow for the Company to make matching contributions at its discretion subject to certain limitations. These contributions are to be allocated to participants as specified in the Plan document. Company contributions will be contributed to the Plan each pay period based on participants’ eligible compensation. The Company will contribute an automatic 3% of participants’ eligible compensation (“Automatic Contributions”) and will match 50% of the first 6% of the participants’ eligible contribution that is contributed to the Plan (“Matching Contributions”).

Effective November 1, 2022, the Plan amended the eligibility requirements to include one year of service for all employees, in addition to the requirement of being 21 years or older.

***Plan Administration***

The Plan is administered by the Company and the Plan’s assets are maintained by Principal Trust Company, a member of the Principal Financial Group (the “Trustee” or “Principal”). The Plan’s recordkeeping services are also performed by Principal.

***Contributions***

Eligible participants are automatically enrolled in the Plan at 3% deferral percentage. Participants may elect to have the Company defer a percentage of their eligible wages with an annual limit of \$23,000 in 2024. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). Additionally, any employee who reaches age 50 during the 2024 calendar year is eligible to contribute an additional “catch-up” contribution up to an Internal Revenue Service (the “IRS”) maximum of \$7,500.

***Participant Accounts***

Each participant’s account is credited with the elective deferral contribution and an allocation of the Company’s contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations of the Plan’s earnings are based on participant’s account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately fully vested in their contributions and the earnings thereon as well as their Automatic Contributions. Participants vest in Matching Contributions as follows:

***Forfeitures***

Forfeitures of non-vested account balances of the Company's contributions are retained by the Plan and may be used to pay administrative expenses or company contributions. As of December 31, 2024, and 2023, there were \$59,365 and \$20,529 of unallocated forfeitures, respectively. During 2024, \$59,365 of forfeitures were used to offset the Company match.

***Investment Options***

Participants direct the investment of their contributions plus actual earnings thereon into various investment options offered by the Plan. Participants may change their investment options daily.

***Notes Receivable from Participants***

Under the terms of the Plan, a participant may borrow a minimum amount of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account. The loans bear interest at rates commensurate with local prevailing rates at the date of issuance, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. There is no restriction as to the number of participant loans that are allowed to be outstanding at any time. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. As of December 31, 2024 and 2023, interest rates on participant loans ranged from 3.25% to 8.50%.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant (or the participant's beneficiary) may elect to receive an amount equal to the value of the vested interest in a lump-sum payment. Participants may also withdraw funds from their account when they reach the age of 59½ or in the event of financial hardship.

Upon termination of service, vested amounts of \$5,000 or less are automatically distributed to the participant or rolled over to another qualified plan at the request of the participant. Vested amounts exceeding \$5,000 in such terminated participant's accounts are maintained until retirement, disability, or death unless the participant elects to receive the entire vested amount in a lump-sum payment or has a direct rollover to another qualified plan. Payment will occur within one year of such election. The Company allows participants, upon their retirement, to receive distributions of their vested amounts in a lump-sum payment. Benefits are recorded as deductions from net assets available for benefits when paid.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

***Risks and Uncertainties***

The Plan provides for investment options in a variety of investment securities. Investment securities in general are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the guaranteed investment contract, a fully benefit-responsive investment contract, which is stated at contract value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts held by Principal are valued at contract value, which represents contributions, reinvested income, less any withdrawals plus accrued interest. Contract value is a relevant measure for that portion of the net assets available for benefits for a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the Plan. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

***Net Appreciation in Fair Value of Investments***

Net realized and unrealized appreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

***Administrative Expenses***

The Company pays most administrative expenses associated with the Plan. Expenses relating to Plan investments are paid by the Plan and borne on a pro-rata basis by each participant. Expenses paid by the Plan were \$106,234 for the year ended December 31, 2024.

**NOTE C - FAIR VALUE MEASUREMENTS**

The Plan adopted Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures for Financial Assets and Liabilities (ASC 820)*, which defines fair value as an exit price, representing that amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability.

As a basis for considering such assumptions, ASC 820 established a three-level fair value hierarchy that prioritizes the inputs used to measure fair value.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. There are no redemption restrictions related to these accounts. At December 31, 2024, and 2023, the Plan had no unfunded commitments related to these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date. There have been no changes in the methodology from December 31, 2023 to December 31, 2024.

**NOTE D - INVESTMENT CONTRACTS WITH INSURANCE COMPANY (PRINCIPAL LIFE INSURANCE COMPANY)**

The Guaranteed Interest Account ("Guaranteed Interest Account") with Principal Life Insurance Company, a member of Principal, is a group annuity contract that provides for a book value record of the amounts deposited to and withdrawn from the Guaranteed Interest Account. The Guaranteed Interest Account is at all times equal to the contributions made to the contract plus interest credited, plus dividends minus expenses and withdrawals made in the account. Contributions to the Guaranteed Interest Account is currently invested in a broadly diversified fixed income portfolio within Principal's general account.

The Guaranteed Interest Account is fully benefit-responsive. Principal issues the Guaranteed Interest Account group annuity contract and guarantees the return of principal plus accrued interest. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) Plan amendment or change in administrative practices, which the issuer determines could adversely affect the contract's financial experience; (2) changes are made to the Plan's prohibition on competing investment options; or (3) another savings program, pension or profit sharing plan is established to which Plan participants are eligible to contribute by payroll deduction. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The Guaranteed Interest Account is included at contract value in the statements of net assets available for benefits at December 31, 2024 and 2023.

Principal is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Principal and is reviewed on a semi-annual basis for resetting. Transfers to competing funds must go through a non-competing investment option for at least 90 days.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan, subject to the provisions of ERISA. If the Plan should be terminated, the participants' rights to their accrued benefits are nonforfeitable.

**NOTE F - TAX STATUS**

The Company adopted a Prototype Non-Standardized Profit-Sharing Plan with a deferral arrangement, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the opinion letter. Plan management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, accordingly, is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Trustee or their affiliates and, therefore, these transactions qualify as party-in-interest transactions. Certain administrative expenses of the Plan are paid by the Company. Notes receivable from participants are considered party-in-interest transactions, because they are transacted with Plan participants.

**NOTE H - INFORMATION CERTIFIED BY PLAN'S TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and carrying value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Principal Trust Company.

**NOTE I - PROHIBITED TRANSACTIONS**

During the 2024 plan year, the Company failed to remit to the Plan certain employee contributions totaling \$13,492 within the period prescribed by the Department of Labor regulations. All such contributions were remitted to the plan in during 2024.

**NOTE J - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024, financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent event which would require recognition or disclosure in the financial statements.
