### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

#### **Note A – Description of Plan**

The following description of Purdy Enterprises 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The plan is a defined contribution plan covering all full-time employees of Purdy Enterprises. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”). The Plan was established effective April 1, 2013. Employees who have attained the age of 18 and completed one year of eligibility service are eligible to enter the Plan.

##### *Contributions*

Participants may elect to defer up to the maximum allowable under the Internal Revenue Code of eligible compensation and contribute these amounts to the Plan. In addition, participants over age 50 before the close of the calendar year are eligible to defer an additional catch-up contribution. Participants may also receive employer safe harbor matching contributions. Safe harbor matching contributions to the participants’ accounts will be equal to 100% of the participants’ deferral contribution, up to 3% of the participants’ qualified wages.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. In addition, the Company may elect to make qualified non-elective contributions (QNECs) at its discretion. For the year ended December 31, 2024, the Company made safe harbor matching contributions totaling \$301,930 and qualified non-elective profit sharing contributions totaling \$130,978.

##### *Vesting*

Participants are vested immediately in their contributions, safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company’s profit sharing contributions to their accounts is based on years of continuous service. Participants become vested in Company contributions according to a graded vesting schedule, beginning at 20% after two years of credited service and increasing by 20% each year thereafter, becoming 100% vested after six years of credited service.

#### **Note A – Description of Plan (Continued)**

##### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Payment of Benefits*

On termination of service due to death, disability, termination of employment or retirement, a participant shall receive a lump-sum benefit payment equal to the value of the participant's vested interest in their account.

##### *Administrative Expenses*

Expenses of administering the Plan are the responsibility of the Plan's management; however, most of the administration expenses are paid by the Company on behalf of the Plan and will not be reimbursed. Investment related expenses are deducted from the individual participant accounts.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, there were \$8,466 and \$69 of forfeited nonvested accounts. Forfeitures are used to reduce future employer contributions or pay plan administrative expenses. No amounts were used to reduce employer contributions in 2024.

#### **Note B – Summary of Accounting Policies**

##### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

##### *Use of Estimates*

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Payment of Benefits*

Benefits are recorded when paid

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions are included in the dividend income. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Subsequent Events*

The Plan has evaluated subsequent events through October 15, 2025 which is the date the financial statements were available to be issued.

#### Note C – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value instrument.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. At December 31, 2024, the Plan's investments are held in mutual funds and money market funds. All exchange traded mutual funds are valued at trade value. The exchange traded mutual funds have been determined to be Level 1 assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note D – Related Party Transactions**

The Plan invests in shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company acts as trustee for those investments as defined in the plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### **Note E – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account of each participant shall become 100% vested in their employer contributions. Any unallocated assets of the plan should be allocated to participant accounts and distributed in such a manner as the plan may determine.

#### **Note F – Income Tax Status**

The Plan is intended to be a qualified plan under Section 401(k) of the Internal Revenue Code, and the Plan is interpreted, applied and administered consistent with the intent to qualify. The Plan was established through a prototype plan of CCH Incorporated, DBA FTWilliam.com, who had received a letter from the Internal Revenue Service indicating the Plan is acceptable. The Plan has been subsequently amended, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (assets) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expectation to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note G – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
