I am writing to request penalty relief for the late filing of the Form 5500 for the Providence Medical Center Tax Deferred Annuity Plan. The delay in submission was unintentional and occurred despite our good-faith efforts to maintain full compliance with ERISA reporting requirements.

This filing was delayed due to a breakdown in communication and responsibility delegation within our various departmental functions. Specifically, the Form 5500 questionnaire was completed timely, however, the actual submission did not take place. The issue came to my attention when I received an automated alert from our 403(b) plan administrator indicating that the filing had not been received.

Upon discovery, we acted immediately to complete and submit the Form 5500, confirm all required information with our plan auditor, and review our internal controls to ensure this does not recur. We have since implemented a formalized internal tracking system and direct oversight protocols for all compliance filings to prevent future delays.

We take our fiduciary and compliance obligations seriously, and this situation was an isolated administrative oversight rather than willful neglect. Given our prompt corrective action and strong



historical record of timely filings, we respectfully request that any associated penalties be waived under reasonable cause provisions. Thank you for your consideration of this request.
