We respectfully request abatement of all penalties assessed under Notice CP-403 regarding the Form 5500 filing for the above-referenced plan and tax year. We believe the penalties were incurred due to circumstances that constitute reasonable cause under IRS guidelines.

Our company has consistently endeavored to comply with all IRS and Department of Labor requirements regarding retirement plan filings. Unfortunately, the Form 5500 for the referenced year was not filed due to our company shutting down, moving to a new address and no communication from the administrator. As a matter of fact we received the notice dated 06/16/2025 on 9/25/2025 from our accountant's office, this was the first we heard about this notice. This was not due to willful neglect, and we took immediate corrective action upon discovering the issue by calling the IRS which guided us to contact ADP our plan administrator.

The Form 5500 has now been properly filed, and all required information has been submitted.

We respectfully request that the IRS consider these facts and grant full abatement of the penalties under reasonable cause provisions. We appreciate your consideration and remain committed to full compliance.
