Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The Relevant Industrial 401(k) Plan (formerly, Relevant Solutions 401(k) Plan) (the Plan) is a qualified retirement plan adopted by Relevant Industrial LLC (formerly, Relevant Solutions LLC), and participating employers: ICS Distribution, LLC; Relevant Industrial, LLC; and Precision Fitting & Gauge, LLC (collectively, the Company). The Plan was effective October 1, 2012 to provide employees the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended and restated effective September 2, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: Eligible employees of the Company could enter the Plan as an active participant on the first day of the month coincident with or next following the date they attained age 21 and completed three consecutive months of service. Effective September 2, 2024, eligible employees of the Company could enter the Plan as an active participants at the age of 18.

Contributions: Participants may elect to reduce their compensation and make a contribution to the Plan. There are two types of elective deferrals: pre-tax contributions and Roth contributions. Federal law limits the amount a participant may elect to defer under the Plan. Participants aged 50 or over may defer additional amounts as catch-up contributions. Participants may start, increase, reduce, or suspend their elections to contribute to the Plan at any time during the year.

The Company may make a discretionary matching contribution on behalf of eligible Plan participants, as a percentage of salary deferrals participants' made during each payroll period or as a uniform dollar amount. During 2024, the Company elected to contribute 100% of the first 3% of a participant's elective deferrals to the Plan.

The Plan may accept a rollover contribution made on behalf of any eligible employee, regardless of whether such employee has met the age and service requirements of the Plan. In general, any eligible rollover distribution will be accepted by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) forfeitures of discretionary matching contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Prior to May 1, 2020, participants were always 100% vested in their contributions, employer contributions, rollovers, and actual plan earnings thereon. Effective May 1, 2020, for any participant who was employed after May 1, 2020, a participant's interest in their matching contribution account will vest based on vesting service. A participant receives a 20% vested percentage after one year of vesting service and an additional 20% for each additional year of vesting service. Participants become 100% vested after five years of credited service. Participants who previously participated in the Precision Fitting & Gauge Co., Inc 401(k) Plan will become 100% vested after six years of credited service. Participants are 100% vested in their safe harbor contributions.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment securities offered by the Plan. The Plan currently offers mutual funds held in pooled separate accounts as investment options.

Notes Receivable from Participants: Active employees may apply for a loan from the Plan. Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 minus the highest outstanding loan balance during the past 12 months or one-half of the present value of their vested account balance. The loans are adequately secured and charged a reasonable rate of interest. Loans are repaid over a period not extending beyond five years from the date of the loan unless such loan is used to acquire a principal residence.

Payment of Benefits: Participants are entitled to receive a distribution from their account after they terminate employment. Accounts will be distributed in a lump sum payment payable in cash. If the vested amount of the terminated participant's account exceeds \$5,000, the participant must consent to any distribution of their account. If the vested amount of the terminated participant's account does not exceed \$1,000, the vested account balance will be distributed directly to the participant in cash. If the vested amount of the terminated participant's account is more than \$1,000 but less than \$5,000, the vested account will be distributed as a rollover to an IRA or the qualified plan of the participant's new employer or to the participant. In-service distributions may be made upon attainment of normal retirement age or reaching age 59½. Participants may receive a hardship distribution if the Company finds that the participant has an immediate and heavy financial need where they lack other available resources. Participants may also receive a distribution from their rollover contribution account at any time.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will continue to be 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The Company determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, the net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) as of December 31, 2023 and for the period January 1, 2024 through September 2, 2024, and by Fidelity Management Trust Company for the period September 3, 2024 through December 31, 2024. Management has relied on the certifications provided by these custodians in preparing the accompanying financial statements and supplemental schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: The fair values of investments in money market funds are based on quoted market prices of the underlying instruments or the funds' reported net asset values, which approximate fair value due to the short-term nature of the underlying investments. These funds seek to maintain a stable net asset value and allow for daily purchases and redemptions by the Plan at NAV without restrictions or advance notice.

Mutual funds: The fair values of mutual fund investments are based on the quoted market prices of the underlying shares as reported on active markets at the financial statement dates. These funds are registered with the Securities and Exchange Commission and are valued at their respective net asset values (NAV) per share. The mutual funds provide for daily redemptions by the Plan at the stated NAV without restriction or advance notice requirements.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value per unit.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments managed by the trustee and notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
