## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees

### **Opinion**

We have audited the accompanying financial statements of California Association of Professional Employees Benefit Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**1. DESCRIPTION OF THE BENEFIT TRUST**

The following description of the California Association of Professional Employees Benefit Trust (the "Benefit Trust" or "Plan") provides only general information. Participants should refer to the Benefit Trust agreement and/or any amendments regarding specific provisions of the Benefit Trust.

General

The Benefit Trust was established in 1995 to provide life, disability, accident, dental, health and any other insurance deemed necessary for active participants and their dependents. No retired participants are covered under the Benefit Trust. The Benefit Trust is funded by employer contributions from the County of Los Angeles and the California Association of Professional Employees, and by participant self payments. The Benefit Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

Eligibility for benefits is based upon contributions from employers and employee self payments which generally are received in the month in which the employees/participants are eligible for benefits. Benefits reported on the statement of changes in net assets available for benefits are segregated by premiums paid and administrative expenses paid during the year.

Contributions

Employer contributions from the County of Los Angeles and from the California Association of Professional Employees are reported on the accrual basis. Employer contributions are made by employers on behalf of employees for the months worked during the year. Employer contributions receivable, if any, are estimated based on contributions received subsequent to the end of the year. Self payment contributions are recorded as income when earned.

Other

Although it has not expressed any intention to do so, the Benefit Trust has the right to modify the benefits provided to the employees, to discontinue its contributions at any time, and to terminate the Benefit Trust subject to the provisions set forth in ERISA.

**1. DESCRIPTION OF THE BENEFIT TRUST (CONTINUED)**

Termination

In the event of termination of the Benefit Trust, the trustees shall use the assets in the Benefit Trust to pay any and all obligations of the Benefit Trust. Should there be a surplus after payment of all obligations of the Benefit Trust, such surplus shall be applied toward continuation of benefits for those entitled thereto at the time of termination until the surplus is exhausted. Upon termination of the Benefit Trust, the trustees shall continue as trustee for the purpose of dissolution with full powers and may execute any and all instruments which may be required to effectuate such dissolution.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accounts of the Benefit Trust are maintained on a modified cash basis of accounting; however, for financial statement purposes, entries have been applied to the cash basis accounts to convert them to the accrual basis. The accrual basis of accounting recognizes revenues and contributions when earned and recognizes premiums and expenses when incurred.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair value of financial instruments

The carrying value of cash and cash equivalents, accounts payable and short-term borrowings approximate their fair values due to the short-term nature of these instruments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Concentration of credit risk

The Benefit Trust, from time to time, maintains cash balances that exceed the Federal Deposit Insurance Corporation coverage limits. As of December 31, 2024 and 2023, amounts in excess of these limits approximated \$13,861,000 and \$12,379,000, respectively. The Benefit Trust performs periodic reviews of the relative credit rating of its banks to lower its risk.

Investments

The Benefit Trust has adopted the FASB's authoritative guidance in connection with accounting for certain investments held and, accordingly, investments are stated at market values as of the balance sheet date. Fluctuations between the market value and the historical cost are reported as unrealized gains or losses in the statement of changes in net assets available for benefits. The Benefit Trust, from time to time, maintains certain concentrations that exceed the Securities Investor Protection Corporation limits.

Property and equipment

Property and equipment are stated at cost. Depreciation is determined for related groups of assets under the straight-line method based upon their estimated useful lives, ranging from 5 to 10 years. Minor renewals or replacements and maintenance and repairs are expensed. Major replacements and improvements are capitalized.

Other income and expenses

Other income and expenses are reported on the accrual basis, except for nominal amounts of recurring monthly expenses.

Tax-exempt status

The Benefit Trust has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the State of California under Revenue and Taxation Code Section 23701i. Accordingly, no provision for federal or state income taxes is made. However, the Benefit Trust is subject to Unrelated Business Income Tax (UBTI) for unrelated business income that is not related to the tax-exempt purpose of the trust.

Fair value measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are those that are observable, either directly or indirectly, for the asset or liability other than quoted prices included in Level 1; and Level 3 inputs, which are unobservable, are used when level 1 and 2 inputs are not available. The Benefit Trust uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Benefit Trust measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 and Level 2 inputs were not available.

Level 1 fair value measurements

Fair values of investments are measured using valuation techniques under a market, income or cost approach. The Benefit Trust uses a market approach for valuing its investments wherein prices or relevant information derived from market transactions for identical or comparable assets are used in determining the respective fair values.

Level 3 fair value measurements

For the years ended December 31, 2024 and 2023, the Benefit Trust determined the fair value of the real estate investment through a third-party appraisal or broker's opinion of value and estimated future rental receipts and residual values discounted at interest rates commensurate with the risk involved.

Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on the current market conditions and other third-party information.

**6. RELATED PARTY TRANSACTIONS**

The Benefit Trust is administered by the California Association of Professional Employees ("CAPE"), which established the Benefit Trust to provide health and welfare coverage for its members and other participants affiliated with the County of Los Angeles. The Benefit Trust's board of trustees is appointed by the officers of CAPE.

The Benefit Trust pays CAPE an administration fee based on a proration of expenses incurred for its administration. Administration fees for the years ended December 31, 2024 and 2023 were \$109,632 for both years.

The Benefit Trust also receives employer contributions from CAPE. These contributions totaled \$109,631 and \$97,118 for the years ended December 31, 2024 and 2023, respectively.

The Benefit Trust leases a portion of its investment in real estate to CAPE on a month-to-month basis. Total rents received from CAPE during the years ended December 31, 2024 and 2023 were \$128,151 for both years.

**7. RISKS AND UNCERTAINTIES**

The Benefit Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
