Note A – Description of Plan

The following description of the Sightlife 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on October 8, 2016 and last restated effective January 2, 2023. The Plan covers all employees of SightLife (the “Employer” or the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees covered by a collective bargaining agreement and nonresident aliens are excluded from the Plan. Employees may enter the Plan on the first day of each month following the date eligibility requirements are met.

Effective January 2, 2023, the Plan was amended to add an age requirement of 21 years for eligibility purposes.

Effective January 1, 2024, the Plan Committee authorized the merger of the Plan into Lions World Vision Institute Inc 401(k) Profit Sharing Plan and Trust.

Administration

The Plan is administered by the Company. The Plan’s assets are held and managed by Charles Schwab Trust Bank and Mid Atlantic Trust Company (the “Trustees”). The Plan utilizes Paychex, Inc. as its record keeper. Contributions are held by the Trustees, who invest cash received, interest and dividend income, as directed by the participant, and make distributions to participants. The Plan changed Trustee in January 2023 from Charles Schwab Trust Bank to Mid Atlantic Trust Company.

Contributions

Participants may contribute up to 100% of their pre-tax annual compensation, as defined, subject to limitations imposed by the Internal Revenue Code (“IRC”). The maximum participant deferral for the year ended December 31, 2023 was \$22,500. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$7,500 for the year ended December 31, 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participants may also contribute amounts representing rollover distributions from other qualified plans as well as Roth 401(k) deferrals.

For the year ended December 31, 2023, the Company made safe harbor matching contributions equal to 100% of the participants’ contributions up to 4% of the participant’s eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Employer’s profit sharing or matching contribution amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations are based on participant earnings or account balances, as defined in the Plan.

Vesting

Participants are immediately 100% vested in all participant contributions, safe harbor matching contributions, rollovers and actual earnings thereon.

Automatic 100% vesting occurs upon attainment of normal retirement age 65, retirement due to disability, death, or termination of the Plan.

Notes Receivable from Participants

Effective January 2, 2023, participants were allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans generally have initial terms of less than five years unless they are for the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions. Loans are secured by the balances in the participant accounts. Principal and interest are paid ratably through bi-weekly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution.

Distribution of Benefits

In the event of termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as defined in the Plan agreement, less any applicable taxes. If a participant's vested balance is \$5,000 or less, the plan Administrator will distribute the entire vested account balance to the participant regardless of their consent. Participants may also request in-service distributions upon attaining age 59 ½. The Plan allows for hardship withdrawals as well as distributions for participants performing military service as defined in the Plan agreement.

Plan Termination

Effective January 1, 2024, the Plan Committee authorized the merger of the Plan into Lions World Vision Institute Inc 401(k) Profit Sharing Plan and Trust.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds and common-collective trusts are valued at the net asset value ("NAV") of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at NAV provided by the Trustees. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2022. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank and Mid Atlantic Trust Company, a qualified institution. As of December 31, 2023 and 2022, and for the year ended December 31, 2023, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank and Mid Atlantic Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

Note D – Income Tax Status (continued)

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2020.

Note E – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments and the related transactions were in investments managed by the Trustees; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$27,000 during the year ended December 31, 2023.

Note F – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note G – Subsequent Amendment to Financial Statements

The financial statements of the Sightlife 401(k) Profit Sharing Plan and Trust as of and for the year ended December 31, 2023, originally issued on October 11, 2024, have been amended and superseded by these amended financial statements. This amendment reflects management's decision in December 2023 to merge the Plan into the Lions World Vision Institute Inc. 401(k) Profit Sharing Plan and Trust, effective January 1, 2024. Accordingly, the amended financial statements for the year ended December 31, 2023 include the transfer out of assets related to the merger.

Management determined that the amendment was necessary to ensure the financial statements are presented in conformity with accounting principles generally accepted in the United States of America.

Note H – Subsequent Events

Effective January 1, 2024, all active participants of the Plan began transacting under the Lions World Vision Institute Inc. 401(k) Profit Sharing Plan and Trust.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
