Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Amoskeag Health (formerly 403(b) Thrift Plan for Employees of Amoskeag Health), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the 403(b) Thrift Plan of Amoskeag Health provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established May 1, 1993 and most recently restated effective January 31, 2020, is a defined contribution plan covering all eligible employees of Amoskeag Health (Company).

Employees are eligible to participate in the employee deferral portion of the Plan immediately following their date of hire. Employees that are normally scheduled to work less than 20 hours per week are excluded from the Plan.

A participant must have at least one year of service (1,000 hours) to be eligible for the Company matching contribution. Participants enter the Plan on a monthly basis for the employer contribution once eligible.

Effective July 2, 2024, the Plan changed 403(b) service providers from Mutual of America to Empower and Empower Trust Company, LLC, the new Plan custodian. In addition, the Plan allows loans as of July 2, 2024, and the vesting schedule was modified.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute from 1% to 100% of their respective pretax annual compensation, subject to limitations established by the Internal Revenue Code (the Code). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan also permits Roth elective deferrals. Roth elective deferrals are treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Code.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions (continued)

The Company matching contribution is 100% up to 4% of eligible compensation after one year of service.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for the participants and a fixed account.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and a pro rata allocation of the investment gains or losses. The benefit to which a participant is entitled is the vested portion from the participant's account.

Vesting

Participants are immediately vested in their entire account plus actual earnings thereon for all employees hired before January 1, 2019.

Effective January 1, 2019, participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 50% vested after one year of credited service, 75% from two to four years of credit service and 100% vested after the completion of five years of credited service.

Effective July 2, 2024, vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after one year of credited service.

Forfeited Accounts

Participants who leave the employment of the Company forfeit the nonvested portion of their accounts. Forfeitures are used to offset future Company contributions to the Plan. At December 31, 2024 and 2023, forfeitures available totaled \$514 and \$-0-, respectively. Forfeitures used to reduce employer contributions during the years ended December 31, 2024 and 2023 amounted to \$-0- and \$-0-, respectively.

1. Description of Plan (continued)

Notes Receivable from Participants

Effective July 2, 2024, the Plan permits loans. Participants may borrow from their vested account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance and reduced by the highest loan balance over the previous twelve months. Participants must comply with loan provisions including: two loans can be outstanding at a time, level payments of principal and interest must be repaid, the term of the loan must not exceed five years unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%.

Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age. The form of payment is a lump sum.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 5 for discussion of fair value measurements.

2. Summary of Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid directly by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company as of December 31, 2023 and for the period January 1, 2023 through July 2, 2024 and Empower Trust Company, LLC as of December 31, 2024 and for the period July 2, 2024 through December 31, 2024, the custodians of the Plan.

4. Investment Contract

The Plan had an investment option in the *interest accumulation account*. Mutual of America (MofA) maintained these contributions in a general account. This contract/account met the fully benefit responsive investment contract criteria and therefore was reported at contract value. Contract value is the relative measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the contract. Contract value, as reported by MofA, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. MofA is contractually obligated to repay the principal and a specified MofA interest rate that is guaranteed to the Plan. There are no surrender charges or market value adjustments associated with this account at any time. The rate of interest, before expenses, cannot be less than 1%. The average rate of return allocated to participant accounts was 1.58%, after expenses, at December 31, 2023.

5. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

5. Fair Value Measurements (continued)

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

Mutual funds are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Fair Value Measurements (continued)

Pooled separate accounts through July 2, 2024, were valued at the fair value of the participation units owned by the Plan in the pooled separate accounts of MofA which were based on quoted redemption values. Such redemption values were established daily based on the quoted market prices of the underlying securities at the end of each business day and unitized by MofA. Participant transactions (purchased and sales) may occur daily. The net asset value was used as a practical expedient to estimate fair value. There were no unfunded commitments.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All mutual fund investments held at December 31, 2024 are Level 1 within the fair value hierarchy.

The Plan holds no investments that are required to be leveled within the fair value hierarchy as of December 31, 2023.

- (e) Growth and income pooled separate accounts seek capital growth and current income and invest in equity and debt securities of domestic and foreign companies.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Income Tax Status

The Plan had adopted the Mutual of America Prototype Non-Standardized 403(b) Plan, through July 2, 2024, the prototype has received an advisory letter from the Internal Revenue Service (IRS) dated March 31, 2017 stating that the form of the plan is acceptable under Section 403(b) of the Internal Revenue Code (Code), and therefore, the related trust is tax exempt. Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Effective July 2, 2024, the Plan has adopted the Empower Retirement LLC volume submitter 403(b) Plan. That Plan received an advisory letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the plan is acceptable under Section 403(b) of the Internal Revenue Code (Code), and therefore, the related trust is tax exempt. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Parties-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, the management of investments held by MofA are considered party-in-interest transactions through July 2, 2024. In addition, notes receivable from participants and the management of investments held by the trustee are considered party-in-interest transactions.
