No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. We have audited the critical estimates and judgments, as well as other estimates and judgments, utilized by management in the preparation of the December 31, 2024 financial statements. We have evaluated key factors and assumptions used to develop the accounting estimates and have determined that they are reasonable in relation to the financial statement taken as a whole. The most significant estimates affecting the financial statements were:

- The fair value of investments are reported to the Plan on the valuation methodologies deemed appropriate by the fund managers. The Plan reviews and evaluates the values provided by fund managers.

The disclosures in the financial statements are neutral, consistent, and clear. Certain financial statement disclosures may be particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

- Investments (Notes 3 and 4)

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management.

- The attached schedule of misstatements detected as a result of audit procedures were corrected by management.

Disagreements With Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreement arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan:

The following brief description of Engineering Partners, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes only. For additional information concerning the Plan’s provisions, participants should refer to the Plan Agreement and Summary Plan Description.

General

The Plan is a defined contribution plan covering eligible employees of Engineering Partners, Inc. (the “Company” and “Employer”) who elect to participate in the Plan. An employee can become a participant in the Plan and begin making elective deferrals and is eligible for employer matching or safe harbor contributions, after three consecutive months of eligibility service beginning on the employee’s date of hire. After completing one year of eligibility service, an employee who is 21 years of age or older is eligible for employer profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has appointed Mid Atlantic Trust Company as the Custodian of the Plan assets with authority over management and investment of Plan assets. The Company has appointed Paychex as the third-party administrator and record-keeper. The Employer amended and restated the Plan on October 6, 2022 which was originally adopted January 1, 2006.

Contributions

Each year participants may contribute up to the maximum dollar amount established by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan in the form of pre-tax elective deferrals. Participants age 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers). The Company has a qualified automatic contribution arrangement. If an eligible employee does not timely return a salary reduction agreement, 3% of each eligible employee’s compensation will be automatically withheld each payroll. The Company provides matching contributions equal to 100% of employee elective deferral contributions less-than-or-equal-to 1% and 50% of employee elective deferral contributions greater than 1 but less-than-or-equal-to 6%.

The Company may also make profit sharing contributions based on a discretionary formula to be determined from year to year to eligible participants.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocation of the participant’s share of the Company’s matching contributions and the participant’s share of profit sharing contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds.

Forfeitures

Forfeitures may be used to reduce employer contributions or pay administrative expenses of the Plan. Forfeitures totaling \$12,255 were used to reduce the Company's contribution for the year ended December 31, 2024. The forfeiture balance was \$3 and \$12,255 at December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately 100% vested in their contributions and employer matching contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contributions is based on years of service. One thousand (1,000) hours of service constitutes a year of service. A participant is 100% vested in the Company profit sharing portion of their accounts after six years of credited service as follows:

Years of Service (As Defined)	Percentage Vested
Less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 or more years	100%

Service prior to the initial effective date of the Plan or a predecessor plan is disregarded for vesting purposes.

Regardless of the vesting schedule, a participant will become fully vested upon death or total and permanent disability.

Notes Receivable From Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, subject to certain restrictions, in accordance with borrowing procedures established by the Company. The loans are secured by up to one-half of the vested account balance in the participant's account, and such other security as the Company may require under certain circumstances. The rates of interest on outstanding loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Loans are repaid through payroll withholding, generally over five years; however, the Plan provides for longer maturities if the loan is used to acquire the participant's principal residence.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with vested benefits of \$1,000 or less will receive a lump-sum distribution. Accounts of participants with vested benefits of more than \$1,000 but less than \$5,000, unless elected otherwise, will be directly rolled over into an IRA chosen by the Plan Administrator. Participants with vested benefits of greater than \$5,000 may elect to delay their distributions, but distributions are required to begin no later than April 1st following the end of the year in which the Participant reaches age 73.

Note 2 - Significant Accounting Policies:

Accounting Method

The financial statements of the Plan have been prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Employee and Employer contributions are recognized in the period that contributions are due.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits includes the following financial instruments that are required to be measured at fair value on a recurring basis:

- Investments in mutual funds are considered Level 1 assets, and are reported at fair value based on quoted net asset values of the shares held by the Plan at year-end.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Participant loans are reported at their unpaid principal balances plus any accrued and unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of the Plan, including legal, audit, administrative, and trustee expenses, are generally paid by the Company, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan incurred \$28,063 of administrative expenses for the year ended December 31, 2024. Participants with loan balances pay an origination fee for loan administration from their respective Plan accounts.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

Note 4 - Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and notes receivable for the year ended December 31, 2024 was obtained or derived from information certified as complete and accurate by Mid Atlantic Trust Company, the Custodian of the Plan.

Note 5 - Party-In-Interest Transaction:

Certain Plan investments are shares of mutual funds managed by Mid Atlantic Trust Company, the Custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair values of investments.

Note 6 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax Status:

The Company has adopted the Paychex Inc. Non-Standardized Pre-Approved Money Purchase Pension Plan. This Plan received a favorable opinion letter from the Internal Revenue Service dated August 31, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.
