We have audited the financial statements of the Retirement Plan of Waldo Community Action Partners (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit) for the year ended December 31, 2024, and we have issued our report thereon dated October 15, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Metropolitan Life Insurance Company, Brighthouse Life Insurance Company, Equitable Financial Life Insurance Company and Empower Annuity Insurance Company, the Custodians, which are banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (GAAP). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America (GAAS), as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated April 30, 2025, in addition to our email communications to Katie Bagley on September 15, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

The estimate of fair value of the Plan's investments. The use of different methodologies or assumptions could result in different fair values at the reporting date.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of investment balances in Note 3 to the financial statements provides a basis to determine the level of market risk inherent in the participants' accounts.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management.

No such known or likely misstatements were identified during our audit.

The attached schedule summarizes uncorrected misstatements of the financial statements. Management has determined that their effects are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. The uncorrected misstatements or the matters underlying them could potentially cause future period financial statements to be materially misstated, even though in our judgment, such uncorrected misstatements are immaterial to the financial statements under audit.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that has not been previously communicated to management by other parties and that we determined is sufficiently important to merit management's attention. We identified the following reportable findings:

Forfeiture Allocations

We noted forfeitures in the amount of \$13,899 and \$23,689 were held in the forfeiture/ asset holding account on December 31, 2024, and 2023, respectively. Not all of the 2023 forfeitures were reallocated to participants, used to reduce employer contributions, or pay plan expenses during 2024. The Internal Revenue Code generally does not allow plans to hold unallocated monies in forfeiture suspense accounts beyond the plan year in which they arise. Proposed regulations by the IRS noted that forfeitures will be used no later than 12 months after the close of the plan year in which the forfeitures are incurred. Failure to comply with the Plan's provisions and IRS regulations can result in loss of the Plan's tax qualification status. We recommend plan management establish procedures for reviewing annual forfeitures to ensure that amounts are appropriately used in a timely fashion.

Disagreements With Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 15, 2025, a copy of which accompanies this letter.

Management's Consultation With Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Retirement Plan of Waldo Community Action Partners (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) participant-directed defined contribution plan covering all employees of Waldo Community Action Partners (the "Organization") who normally work more than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

In December 2022, the Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE 2.0) was signed into law. Required amendments will be made to the Plan in accordance with applicable law and Internal Revenue Service (IRS) guidelines.

Eligibility

Employees are immediately eligible to contribute a pre-tax deferral into the Plan. To receive the Organization's matching contribution, employees must complete 720 hours of service within 12 consecutive months from the eligible employee's commencement date.

Contributions

Each year, participants may contribute a portion of their pretax annual compensation, up to the maximum allowed by the IRS, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, variable annuities, and a group annuity insurance contract.

The Organization will make a matching contribution amount equal to 100% of the amount of the participant's elective deferrals that do not exceed 6% of the participant's compensation. During the year ended December 31, 2024, the Organization made matching contributions of \$157,538. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Organization matching contributions, and allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Organization's matching contribution is based on years of service. Participants vest at a rate of 20% per year, after one year of service. Participants become fully vested after five years of service, as defined by the Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time of the note origin. Loans must be repaid within five years, unless the loan is used to acquire a dwelling to be used as the principal residence of the participant, in which case the loan must be paid within fifteen years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants may elect to receive the vested balance in their account either as a lump-sum distribution upon retirement, termination, or other qualifying event, or as substantially equal installments over a payment period not to exceed the life expectancy of the participant or their beneficiary. If the balance is less than \$5,000 (vested account balances, minus any rollover contributions, but including any outstanding note receivable balance), the plan administrator may automatically distribute the balance as a lump-sum distribution. Provided certain conditions are met, the participants may also be entitled to a distribution upon attaining age 59 1/2. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,899 and \$23,689, respectively. These accounts will be used to reduce future Organization contributions, be allocated to participant accounts, or pay plan expenses in accordance with the plan document. During the year ended December 31, 2024, \$22,505 of forfeited nonvested accounts were allocated to participant accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuities: Valued based on the initial input of the quoted price obtained for the underlying mutual funds, which is then adjusted to apply factors disclosed in the annuity contract.

Note 4: Fully Benefit-Responsive Investment Contracts

The Plan has a FBRIC with Metropolitan Life Insurance Company (MetLife). The GTS Fixed Account (Traditional) is a general account product. MetLife is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The entire general account assets of MetLife back these guarantees. The methodology for calculating the interest crediting rate is based on the value of the underlying assets on the immediately preceding date and the net interest factor. The net interest factor is the assured net interest rate of 3% plus any interest in excess of the assured net interest rate, plus 1.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to equity wash provisions.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$648,403 and \$606,535, respectively.

Note 4: Fully Benefit-Responsive Investment Contracts (Continued)

At December 31, 2024 and 2023, the Plan holds other FBICs at contract value, with Equitable Financial Life Insurance Company (Equitable) and Brighthouse Life Insurance Company (Brighthouse) totaling \$14,064 and \$13,934 respectively.

Certain events may limit the Plan's ability to transact at contract value, such as termination of the contract, corporate relocation, and partial or total termination of the Plan. In these situations, a market value adjustment or other withdrawal restrictions may apply. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Metlife, Brighthouse, Equitable, and Empower Annuity Insurance Company (Empower), the Custodians of the Plan.

Note 6: Party-in-Interest Transactions

Certain Plan investments are held under a guaranteed investment contract by MetLife. MetLife is defined as a Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments are held by Brighthouse, Equitable, and Empower. Brighthouse, Equitable, and Empower are also defined as Custodians by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Organization matching contributions.

Note 8: Income Tax Status

The Plan is designed after a volume submitter 403(b) Plan which received a favorable opinion letter from the IRS, dated March 31, 2017, which states that the volume submitter plan document is acceptable under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
