Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a complete description of the provisions of the Plan.

General

The Trinity Holdings Group, Inc. Employee Stock Ownership Plan (the "Plan") is a defined contribution plan established for the benefit of the eligible employees of Trinity Group Holdings, Inc. and its subsidiaries (the "Company" or "Employer"). The Company established the Plan and trust on January 1, 2019 and designed it to comply with the applicable provisions of the Internal Revenue Code (the "Code") and the Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors ("Board") of the Company has appointed Aegis Fiduciary Services as Plan Trustee ("Trustee") and the ESOP Plan Committee to administer the Plan.

The Plan purchased Company common stock using the proceeds of a loan with the Company (Note 5), and holds the stock in a trust established under the Plan. The borrowing is to be repaid by fully deductible Company contributions to the Plan. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible participants' accounts in accordance with the Code.

The loan is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the Plan. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the years then ended present separately the assets and liabilities and changes therein pertaining to:

1. the accounts of participants with vested rights in allocated stock ("Allocated") and
2. stock not yet allocated to participants ("Unallocated").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Eligibility

The Plan allows eligible employees to participate in the Plan on the first day of the month after which the employee has completed one hour of service, provided that they have attained the age of 18.

Participants who do not satisfy the service requirement during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

Company contributions to the Plan are determined by the Board; however, the Company is obligated to make contributions in cash to the Plan, which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Company contributions may be in cash, shares of Company stock, or a combination of both, provided that the amount of the contributions shall not exceed the maximum amounts deductible under section 404(a)(3) of the Code. Employee contributions are not permitted.

Payment of benefits

Distributions are not made from the Plan until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), becomes permanently disabled, or otherwise terminates employment with the Company. Distributions are made in the form of cash or rolled over to another qualified retirement plan or individual retirement account. The repurchase of Company shares will be made as a lump-sum payment for accounts with a total vested value of \$7,000 or less; or, in one to five substantially equal annual installment payments, as determined by the Plan document, for accounts with a total vested value exceeding \$7,000. The period over which distribution of a participant's account is to occur may be increased in one-year increments not to exceed five years, for each \$225,000 of the participant's account balance that exceeds \$1,130,000. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

In addition, the Plan provides for the mandatory transfer of terminated participants' account balances to the 401(k) Plan, unless otherwise elected by the participant.

Administrative expenses

The Plan requires the trust to pay the costs of administering the Plan and trust, unless such expenses are paid by the Company.

Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. In the event that the participant fails to give a timely voting direction, the Trustee shall have the right to vote for the participant's allocated shares. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Participant accounts

Under the Plan, a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocable share of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation, except in the case of retirement, disability, or death. Employer contributions and Plan forfeitures are allocated to each participant's account in proportion that each such participant's covered compensation bears to the total covered compensation of all such participants for that year. Dividends paid on the employer stock are allocated in proportion to the shares of stock allocated to participants' accounts as of the preceding anniversary date (less any distributed shares) but any earnings on cash investments are allocated in proportion to the participants' ESOP cash balances as of the preceding anniversary date (less any posted distributions to their cash accounts).

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on years of service with the Company. Participants with at least three years of service are 100% vested in their accounts.

Put option

Under federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock, for which there is no market, that have been distributed to participants. The put price is the fair market value of the stock as determined by an independent appraiser appointed by the ESOP Plan Committee. The Company has the option to pay the purchase price in a lump sum or in equal annual installments, with interest at a reasonable rate on the unpaid balance. The purpose of the put option is to ensure that the participant has the ability to convert the stock to cash.

Diversification

Participants who are at least 55 years of age with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify receive a cash distribution.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. The Plan is required to allocate all forfeitures to eligible participants at the end of each Plan year as part of its annual allocation. For the years ended December 31, 2024 and 2023, 595.8026 and 226.6717 shares, respectively, were forfeited and allocated back to active participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting standards generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The common shares of the Company are valued at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated all subsequent events through October 15, 2025, the date the financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish the framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quote prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. LOAN PAYABLE

In 2019, the Plan entered into a \$35,000,000 term loan agreement with the Company. The proceeds of the loan were used to purchase shares of the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 7,339.6241 and 7,439.0139 shares being released and allocated for the Plan years ended December 31, 2024 and 2023, respectively.

The loan agreement provides for the loan to be repaid over 30 years to be completed by December 31, 2049. The loan bears interest at an annual rate of 2.09%.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in Note 1, the Plan requires the trust to pay the costs of administering the Plan and trust, unless such expenses are paid by the Company. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

7. RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

8. PLAN TERMINATION

Although the Company has not expressed intent to do so, the Company has the right to terminate the Plan at any time, subject to provisions of the Plan and as set forth by ERISA. Upon termination of the Plan, the ESOP Plan Committee shall direct the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed under the provisions of the Plan and the Code.

9. TAX STATUS

The Internal Revenue Service has determined and informed the ESOP Plan Committee by a letter dated July 2, 2020, that the Plan and related trust are designed in accordance with the applicable regulations of the Code; therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. No amendments have been made since receiving the determination letter. Therefore, no provision for income taxes has been included in the Plan's financial statements.
