Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Veolia Water Resources Retiree Only Health and Welfare Benefit Program, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Suez Water Resources Inc. Retiree Only Health and Welfare Benefit Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

General

The following description of the Veolia Water Resources Inc. Retiree Only Health and Welfare Benefit Program (the “Plan”) is provided for general information purposes only. Reference should be made to the related Summary Plan Description, as updated, for more complete information.

The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan is a defined benefit health and welfare plan that provides for comprehensive medical and life insurance coverage to the retirees and certain eligible dependents either directly or indirectly through an annual payment to a Health Reimbursement Arrangement (“HRA”).

Veolia Utility Resources, LLC and its subsidiaries (or the “Company”) provide health and welfare benefits for certain retirees. These welfare benefits consist of group health programs for pre-65 retirees, as well as life insurance for all eligible retirees. Employees are eligible for coverage under the Plan upon retirement if they are age 60 with ten years of service at the retirement date or age 65 with five years of service. In addition, for those retiring on or after January 1, 2005, prior to age 60 and meeting age 55 with 10 years of service at retirement, these retirees will have an option to elect retiree medical coverage starting at age 60. Non-bargained and Idaho bargaining have an alternative retirement eligibility condition of age 55 with 35 years of service. Jersey City bargaining, Delaware bargaining, New Jersey bargaining and Toms River bargaining employees will become eligible upon attaining 40 years of service.

Effective January 1, 2024, the Plan was amended to change the name of the Plan from SUEZ Water Resources Inc. Retiree Only Health and Welfare Benefit Program to Veolia Water Resources Retiree Only Health and Welfare Benefit Program.

The Veolia Water Resources Retiree Only Health and Welfare Benefit Program makes fixed contributions to a HRA for each Medicare eligible retiree, which can be used to purchase medical and prescription drug coverage from insurance companies on a private exchange. Contributions to the HRA are increased annually by the lower of the Consumer Price Index or 3%. There was no change in benefits for those retirees who are not yet Medicare eligible. The HRA balance at December 31, 2024 and 2023 was \$72,645 and \$1,133,144, respectively.

Effective May 1, 2009, any non-bargained employee whose employment commencement date was on or after May 1, 2009, or who transferred from a business unit that is not pension-eligible is not eligible to become a participant in the Plan. Jersey City bargaining employees hired on or after February 1, 2011, and Delaware bargaining employees hired on or after April 1, 2011, are not eligible for postretirement medical benefits. The Plan is closed to new participants.

1. Description of the Plan (continued)

Funding Policy

The Company has funded the postretirement benefit obligations of this Plan through direct contributions into a Voluntary Employee Beneficiary Association (“VEBA”) trust. The VEBA trust holds and manages the investment assets of the Plan.

Medical Benefits and Insurance

The Plan entered into an administrative services only agreement with Cigna Health and Life Insurance Co. (CIGNA). The Plan is on a self-insured basis for the payment of medical, hospital and related services provided to members not eligible for Medicare. CIGNA provides administration for a retention fee. Express Scripts provides the Plan with a prescription drug program. Life insurance coverage is insured and provided by Sunlife. Effective January 1, 2024, the Plan was entered into an administrative services only agreement with United Healthcare.

Contributions

The Company has contributed amounts sufficient to fund the majority of benefits, insurance premiums and administrative expenses (to the extent that they are not covered by contributions paid by participants). The Plan maintains separate accounts for certain union and non-union participants. Contributions to the Plan were actuarially determined and were made by the Company pursuant to income tax and ERISA guidelines. The retirees not eligible for Medicare are required to contribute for the costs of the Plan which is dependent upon the coverage options selected and years of service at retirement; the monthly contribution for these retirees range from \$367 for a single non-Medicare eligible retiree with 20 or more years of service to \$1,603 for a non-Medicare eligible retiree with family coverage with less than 20 years of service at retirement. The cost is typically deducted automatically from the monthly pension benefit payments of defined benefit plans sponsored by the Company. In some cases a check is submitted by the participant to cover their cost.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue any contributions and to terminate the Plan at any time subject to the provisions set forth in ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States (“U.S. GAAP”).

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, the actuarial present value of accumulated plan benefits, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

The Plan considers all highly liquid investments with original maturities of three (3) months or less to be cash equivalents.

Investment Valuation and Income Recognition

The assets of the Plan are invested in mutual funds and a common collective trust funds (“CCT funds”). The investments are reported at fair value using quoted prices at active markets for the mutual funds and daily calculated value of units of participation for the CCT funds. The CCT funds invest mainly in bonds, the fair values of which are generally measured at the last available bid prices by an independent pricing service. The Plan does not have any unfunded commitments relating to its investment in the CCT funds, or any significant restrictions on redemptions.

Investment transactions are recorded on the trade date basis (the date the order to buy or sell is executed). Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis and includes amortization of premiums and accretions of discounts on the investments. Realized gains or losses on the sale of securities are recorded on an identified costs basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recognized in the statements of changes in net assets available for benefits when paid.

Administrative Expenses

Contributions paid by participants/retirees are used to pay administrative expenses of the Plan. If Plan expenses exceed participant contributions, the excess is paid for by the Plan.

3. Fair Value Measurements

Accounting Standards Codification topic (“ASC”) 820, Fair Value Measurements and Disclosures, defines fair value, and establishes a framework for measuring fair value in U.S. GAAP and disclosing fair value measurements. It also applies under other accounting pronouncements that require or permit fair value measurements. The fair value hierarchy for disclosure of fair value measurements under ASC 820 is as follows:

- Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.
 Level 2: Quoted prices, other than quoted prices included in Level 1, that are observable for the assets or liabilities, either directly or indirectly.
 Level 3: Valuation inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Postretirement Benefit Obligations

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered up to the date of valuation. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and covered dependents and (2) active employees and their beneficiaries and covered dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations has been determined by the Plan's consulting actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant as well as annual future payments for the posts-65 Medicare eligible participants, and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability or withdrawal) between the valuation date and the expected date of payment. The actuarial cost method used is the projected unit credit method.

The associated pre-65 health care cost trend rate used in measuring the postretirement benefit obligation at December 31, 2024 and 2023 for all purposes was set to 6.75 % in 2024, and then reducing linearly to 4.50% in 2033. The associated post-65 health care cost trend rate used in measuring the postretirement benefit obligation at December 31, 2024 and 2023 for all purposes was set to 3.0%.

The Plan has stop loss insurance coverage to insure against claims in excess of maximum limits.

If the assumed health care cost trend rate increased by one percentage point in each year, it would increase the obligations as of December 31, 2024 and 2023 by approximately \$8.5 million and \$9.3 million, respectively.

The estimated liability for claims incurred but not reported (“IBNR”) for those participants who are not Medicare eligible was actuarially determined. Liabilities for medical and prescription drug benefits were estimated based on the developmental method. The underlying principle of the developmental method is that the progression of claim payment follows runoff patterns that are assumed to remain stable over time. The actuary evaluates the claims experience each year and updates the IBNR as appropriate.

5. Investments

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Principal Bank, a qualified institution, has certified the following investment information included in the accompanying financials statements and ERISA-required supplemental schedule is complete and accurate.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

6. Related Party Transactions

The investments of the Plan were held by Principal Bank the trustee of the Plan and therefore, the administrative fees qualify as party-in-interest transactions. Fees incurred to Principal Bank for administrative services amounted to \$148,977 and \$134,987 for the years ended December 31, 2024 and 2023, respectively. Accrued expenses totaled \$11,233 and \$3,090 for December 31, 2024 and 2023, respectively.

Services rendered by the actuary, auditor, and investment advisors also qualify as party-in-interest transactions. The related administrative expenses amount to \$126,982 and \$47,867 in 2024 and 2023, respectively. Accrued expenses that were owed to the actuary, auditor, and investments advisors totaled

\$53,907 for December 31, 2024. As of December 31, 2023, there was no actuary, auditor and investment advisor fees included within accrued expenses

7. Income Tax Status

The trust funding the Plan received an exemption letter from the Internal Revenue Service, dated May 31, 1996, stating that the trust is tax-exempt under the provisions of Section 501c(9) of the Internal Revenue Code (the “Code”) as a Voluntary Employee Beneficiary Association. The Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan has amended its provisions since receiving the exemption letter. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust is tax-exempt.

Although the Plan is not generally subject to taxation when funding limits for arrangements include collectively bargained participants, certain activities of the Plan may be taxable. In general, unrelated business taxable income (“UBTI”), which includes the income from the Plan assets relating to the non-bargained participants, is subject to taxation at the applicable Trust’s tax rates which include reduced tax rates on capital gains and dividends. In addition, the Plan may be subject to UBTI on their investment income, if their assets exceed certain allowable reserves. For the years ended December 31, 2024 and December 31, 2023, the Plan recognized tax income on UBTI of \$244,130 and \$172,223 respectively.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that would not meet the more likely than not standard and be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

At December 31, 2024 and December 31, 2023, two and three investments accounted for approximately 78% and 83%, respectively, of the Plan's investments.

9. Subsequent Events

The Plan has evaluated subsequent events through October 16, 2025, which is the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
