Independent Auditor's Report

To the Plan Administrator and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about EVRAZ Inc. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 and 2023

(1) Description of the Plan

The following brief description of the EVRAZ Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan documents for more complete information.

(a) General

EVRAZ NA (“the Company”) established the Plan on March 3, 1993, as a defined contribution plan designed to provide retirement benefits to eligible employees of CF&I Steel, L.P. and other affiliates (collectively, “the Employer”), which may adopt the Plan with the approval of the Company. The Plan was designed under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. An administrative committee, appointed by the Company’s chief executive officer, administers the Plan.

(b) Eligibility and Contributions

Employees of the Employer covered by a collective bargaining agreement that provides for Plan participation are eligible to participate in the Plan upon employment except, non-resident aliens, leased employees, and interns, and any employee who is earning a pension benefit under another Employer sponsored plan. Participants are eligible to participate on the date of employment. There are no age or service requirements to participate in the Plan.

Participants are automatically enrolled at 2% of eligible compensation, unless the participant elects not to participate or chooses another deferral percentage. All participants may defer up to 75% of their eligible compensation, as defined by the Plan document, limited by requirements of the IRC. Participants’ contributions are automatically placed in a target retirement fund based on age at hire and may be transferred by the participant to other plan investments at any time. Participants may also contribute rollover distributions from other qualified defined benefit or defined contribution plans.

The Company makes a supplemental matching contribution of 50% of salary deferrals up to 4% of eligible compensation for all employees. Employer contributions under this provision totaled approximately \$1,240,000 and \$1,404,000 for the years ended December 31, 2024 and 2023, respectively.

(c) Participant Accounts

Each participant’s account is credited with the contributions of the participant and the Employer’s contributions to the Plan on behalf of the participant, earnings, or losses attributable to the participant’s account and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(d) Notes Receivable from Participants

Participants are eligible to borrow the lesser of \$50,000 or 50% of their vested account balances subject to specified limits as set forth in the Plan document. The interest rate is the prime rate plus 1% per annum. Loans are treated as a segregated investment of the participants’ accounts and are

for a fixed term not to exceed five years, except for loans made in conjunction with the acquisition of the participant's primary residence, which have a maximum term of ten years. At December 31, 2024, loans outstanding bear interest at rates ranging from 4.25% to 9.50% with maturity dates through 2034.

(e) Vesting

Participants are immediately vested in their elective deferrals and employer supplemental matching contributions and earnings thereon. Participants with balances in the Employer Nonelective contributions are fully vested upon completion of three years of service, death, or disability.

(f) Plan Termination

While the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to applicable collective bargaining requirements. In the event the Plan is terminated, participants will become 100% vested and the assets of the Plan will be distributed to the participants in accordance with Plan provisions. In no event shall any part of the Plan's assets be used for any purpose other than for the exclusive benefit of the participants or their beneficiaries, except to settle expenses or obligations of the Plan.

(g) Participant Benefits

Upon termination of employment, a participant may elect to leave their balance in the Plan if they meet the Plan requirements, roll all or a portion of their balance to an individual retirement account ("IRA"), or receive a lump-sum amount equal to the vested value of the participant's account. Under the provisions of the Plan, a participant who terminates employment with an account balance of less than \$1,000 may receive a mandatory cash-out of their vested account balance. Participants with account balances of \$1,000 to \$5,000 will be rolled over into an IRA. A participant who has attained age 59½ may elect a lump sum or partial payment of the account, even though the participant's employment continues.

(h) Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single lump-sum, a portion of their vested account as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

(i) Forfeited Accounts

Participants who terminate employment forfeit the nonvested portion of their contributions and the earnings thereon. At December 31, 2024 and 2023, there were no forfeitures available to reduce future employer contributions or pay Plan expenses. During 2024 and 2023, there were no forfeitures utilized to reduce employer contributions and to pay administrative expenses.

(j) Transfers

The transfers (to) from other plan included in the statements of changes in net assets available for benefits represent the net transfer for those employees who changed employment from bargaining to non-bargaining status or vice versa.

(k) Expenses

Certain administrative expenses of the Plan are paid by the Employer. Participants pay certain loan, distribution, and transaction fees related to their accounts. Direct expenses totaling approximately \$19,000 and \$20,000 were paid by the Plan during 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantified.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis.

(b) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

(c) Investment Valuation and Revenue Recognition

The Plan follows the fair value measurement and disclosure requirements of Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recognized as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments from one period to the next.

(d) Investment Risk

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(e) Notes Receivable from Participants

Notes receivable from participants are carried at their unpaid principal balance, plus any accrued but unpaid interest.

(f) Payment of Benefits

Benefit payments to participants are recorded upon distribution.

(g) Subsequent Events

Management has evaluated the potential recognition and disclosures in the financial statements of subsequent events that have occurred through October 15, 2025, which is the date the financial statements were available to be issued.

On July 31 2025, the Plan Sponsor was acquired by Altas Holding, resulting in the formation of a new entity, Orion Steel Group LLC. Effective August 1, 2025, Orion Steel Group LLC assumed sponsorship of the Plan and the Plan's name was changed to Orion Steel 401(k) Plan for Rocky Mountain Steel.

(3) Fair Value Measurements

FASB ASC 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable, inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – The mutual funds are valued at fair value based on quoted market prices and are considered Level 1 investments.

Common collective trust – The Plan's interest in the common collective trust is based on the net asset value ("NAV") practical expedient of the common collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trust at year-end. Participant transactions can occur daily.

Self-directed brokerage accounts – The investments held in the self-directed brokerage accounts consist primarily of common stocks, mutual funds and interest bearing cash (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common collective trusts include investments that are operated by a trust company that manages a pooled group of trust accounts. Common collective trusts combine the assets of various institutional investors to create a larger, well diversified portfolio. The objectives of a common collective trust are to lower the costs to investors through economies of scale available by combining assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in shares and represents its portion of the holdings of the fund.

There were no unfunded commitments at December 31, 2024 and 2023.

(4) Tax Status

Effective January 1, 2022, the Plan was restated utilizing Voya Retirement Insurance and Annuity Company (Voya Retirement) Non-standardized 401(k) Profit Sharing Plan Document. Voya Retirement received an opinion letter from the Internal Revenue Service (“IRS”) dated September 1, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Party-in-Interest

The Plan sponsor, EVRAZ NA., is a party-in-interest. However, there were no transactions with the Plan sponsor other than funding of contributions and payment of certain Plan expenses which are exempt transactions.

Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants’ accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

(6) Information Certified by the Trustees
