### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of RTS Packaging, LLC 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of September 24, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1 to September 24, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of September 24, 2024 and December 31, 2023, and for the period from January 1 to September 24, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Managing Board of Directors (the Board) of the Plan approved a plan of liquidation on September 7, 2023, and management determined liquidation is imminent. As a result, the Plan uses the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ### 1. Description of Plan

The following description of the RTS Packaging, LLC 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined contribution plan covering employees of RTS Packaging, LLC (the Company) who met the eligibility requirements. The Plan was effective on January 1, 1998, as amended. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversaw governance of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's Administrative Committee.

#### *Plan Termination*

Effective September 7, 2023, the Plan was terminated by the Managing Board of Directors (the Board) of RTS Packaging, LLC. The Company was a joint venture between WestRock Company (WestRock) and Sonoco Products Company (Sonoco). On September 7, 2023, WestRock sold its joint venture interest to Sonoco. As a result, Sonoco became the sole owner of the Company and Plan Sponsor. On September 8, 2023, eligible participants of the Plan began participating in the Sonoco Product Company 401(k) Plan. The Plan's assets were fully distributed on September 24, 2024.

#### *Administration*

Empower Trust Company, LLC (Empower Trust) was the trustee and custodian of the Plan, and Empower Retirement, LLC (Empower Retirement) was the Plan's recordkeeper who maintained individual accounts reflecting each participant's respective interest in the value of the Plan's net assets.

Certain administrative functions were performed by employees of the Company. These employees did not receive compensation from the Plan.

The WestRock Company 401(k) Retirement Savings Plan Trust (Master Trust) held investments on behalf of the Plan, the WestRock Company 401(k) Retirement Savings Plan, and the WestRock Company 401(k) Provisional Retirement Savings Plan (see Note 3).

#### *Eligibility*

Upon plan termination, the plan was frozen to new participants. Prior to plan termination, employees were eligible to participate in the Plan after completing a minimum service period of one month, and temporary employees are eligible to participate after one year of service. Collectively bargained employees, as defined by the Plan, were generally eligible to participate after having completed a minimum service period of 90 days, subject to certain exclusions stated in the Plan document. An employee's service with a predecessor employer acquired by or merged with the Company or service with WestRock was taken into account for the purposes of determining an employee's eligibility to participate in the Plan.

### ***Contributions***

Upon plan termination, the plan was frozen to new contributions. Prior to plan termination, once eligible, certain participants were automatically enrolled in the Plan with a deferral percentage of 3% of eligible compensation unless the participant 1) elected not to participate in the Plan or 2) elected a different deferral percentage. Subsequently, the deferral percentage for automatically enrolled participants was automatically increased 1% annually up to a maximum deferral percentage of 10%, unless the participant 1) elected not to participate in the automatic increase or 2) elected a different deferral percentage maximum.

Outside of the automatic enrollment process, participants were able to make pre-tax or Roth contributions between a minimum of 1% and a maximum of 75% of eligible compensation, as defined by the Plan, to the Plan, subject to certain maximum limitations under the Internal Revenue Code (IRC). Participants who had attained age 50 on or before the end of the year were eligible to make catch-up contributions to the Plan. Employees could request to make a rollover contribution to the Plan before meeting the participation requirement of the Plan. Participants directed the investment of their contributions into various investment options offered by the Plan through the Master Trust.

For each pay period that a participant makes contributions to the Plan, the Company made a matching contribution. Matching provisions for participants were 100% of the participant's contribution up to 5% of eligible compensation for such pay period. In addition, for all participants who were not collectively bargained participants and were employed on the last day of the Plan year, an additional company contribution was made in the amount of 2.5% of the participant's eligible compensation for the Plan year. Matching contributions for participants that were part of a collectively bargained agreement were in accordance with the respective contract with each bargaining unit. Company matching contributions ranged from 25% to 50% of the participant's contribution, based on the participant's union affiliation, for each pay period up to a maximum of 6% of eligible compensation.

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Participant Accounts***

Each participant's account was credited with (i) the participant's 401(k) contribution, (ii) the Company's contribution, and (iii) the participant's account earnings, thereon. Each participant's account was charged with (i) withdrawals and (ii) an allocation of administrative expenses. The benefit to which a participant is entitled is the participant's vested account balance.

### ***Investment Options***

All investments were held in the Master Trust as of December 31, 2023 and for the period from January 1 to September 24, 2024. All investments of the Plan were liquidated from the Master Trust as of September 24, 2025.

### ***Vesting***

Participants vested immediately in their voluntary contributions and actual earnings thereon. All participants who were not collectively bargained participants vested immediately in matching

contributions made by the Company for Plan years beginning on or after January 1, 2016. Vesting in the Company's matching contributions for collectively bargained participants, additional contributions, and earnings thereon was based on years of service. Generally, a participant's account is fully vested after three years of credited service or other events, as defined by the Plan. Upon Plan termination, participants became fully vested in all contributions.

### ***Forfeitures***

Forfeited non-vested amounts were used to pay general administrative expenses of the Plan, restore account balances for re-employed participants, and/or to offset Company matching contributions. Forfeitures of \$36,132 were used to offset Company contributions during the period from January 1 to September 24, 2024. Forfeitures of \$0 and \$39,990 were available for future use as of September 24, 2024 and December 31, 2023, respectively.

### ***Withdrawals and Payments of Benefits***

Participants could have elected to receive payment of their vested account balance as soon as practicable after employment was terminated, after becoming disabled, and upon termination of the Plan. Participants could have had their account paid directly to them net of appropriate taxes and penalties (as applicable) or transferred in a direct rollover to another qualified plan or individual retirement account without taxes or penalties. Participants who have attained the age of 70½ received distributions in accordance with the Internal Revenue Service (IRS) minimum required distribution rules.

In general, the Plan also provided for withdrawals by a participant from his or her contribution account prior to retirement either upon the attainment of age 59½, disability, a hardship withdrawal, or a rollover withdrawal.

### ***Notes Receivable from Participants***

Prior to Plan termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above the prime rate, as defined. Loans were repaid within five years, except principal residence loans which may not exceed 15 years, to the participant's account with interest. Principal and interest were paid ratably through monthly payroll deductions.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on September 7, 2023. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting,

including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by its investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are reflected as a reduction of investment return for such investments.

### ***Notes Receivable from Participants***

Loans to participants are reported at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### ***Administrative Expenses***

Certain administrative expenses are paid by the Plan, as allowed by the Plan document. Recordkeeping, investment advisory, and custodial fees are paid by plan participants and all other expenses are paid by the Company and excluded from these financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment and advisory management fees related to the stable value collective trust and the custom funds are paid from the assets of the Master Trust on a quarterly basis. Such fees are recorded as a deduction from the Master Trust's net assets.

### ***Payment of Benefits***

Benefit payments are recorded upon distribution.

### 3. Interest in WestRock Master Trust

Effective January 1, 2016, the Plan entered into the WestRock Company Master Trust agreement with Empower Trust, (formerly Great-West Trust Company, LLC) who became the custodian of the Master Trust's investments and the Plan's Trustee. The value of the Plan's share of net assets is presented as a single asset and the net investment experience in the Master Trust is presented as a single addition to or deduction from net assets in the accompanying financial statements.

The Master Trust's net assets are allocated among participating plans by assigning to each plan those transactions (primarily contributions, benefit payments, and certain administrative expenses) which can be specifically identified, and by allocating among participating plans, in proportion to the fair value of the net assets assigned to each plan, income and expenses resulting from the collective investment of the net assets of the Master Trust.

The Plan does not have an undivided interest in the investments held in the Master Trust since each plan's interest in the investments of the Master Trust is based on the account balances of the participants and their elected investment fund options.

The following table summarizes the net assets of the Plan and Master Trust as of December 31, 2023. There were no net assets of the Plan in the Master Trust as of September 24, 2024, due to the plan termination as described in Note 1.

### 4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) has established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement levels within the fair value hierarchy are based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the valuation methodologies used at September 24, 2024 and December 31, 2023.

- (c) Money market funds are valued using the net asset value (NAV) of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.
- (d) Valued using the NAV of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments on these funds as of December 31, 2023, and no liquidity restrictions. Further, these collective trust funds are direct filing entities (DFEs).

The Master Trust invests in a stable value collective trust fund (the stable value fund) managed by Galliard Capital Management (GCM). The stable value fund is comprised primarily of fully benefit-responsive synthetic investment contracts and is valued at NAV. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) are recorded at the NAV and may occur daily. If the Master Trust initiates a full redemption of the stable value fund, GCM reserves the right to acquire 12 months' notification to ensure the securities liquidations will be carried out in an orderly business manner. The balance of the stable value fund in the Master Trust was \$387,378,588 and \$409,623,561 at September 24, 2024 and December 31, 2023, respectively.

### 5. Information Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance for certain investment information as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust, the trustee, has certified that the following data included in the accompanying financial statements is complete and accurate:

### 6. Income Tax Status

The Plan received a determination letter from the IRS dated February 9, 2017, stating that the Plan was qualified under Section 401(a) of the IRC and, therefore, the related trust was exempt from taxation. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan administrator and Plan's tax counsel believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC and had no income subject

to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Related Party and Party-in-Interest Transactions**

Certain Plan investments were managed by the trustee. Transactions involving these investments qualify as party-in-interest transactions. In addition, the trustee received investment management fees related to these funds prior to any funds being allocated to investment earnings or losses. Party-in-interest transactions also included loans made to participants. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid to the party-in-interest were \$10,548 for the year ended September 24, 2024.

### **8. Plan Termination**

As described in Note 1, the Company has terminated the Plan effective September 7, 2023, subject to the provisions set forth in ERISA. Participants became 100% vested in their accounts as of the termination date.

### **9. Subsequent Events**

The Plan has evaluated subsequent events after the statement of net assets available for benefits date through October 15, 2025, the date that the financial statements were available to be issued.
