Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Lebanon Seaboard Corporation 401(k) Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Note 1 - Description of the Plan

The following description of the Lebanon Seaboard Corporation 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution pension plan covering all employees of Lebanon Seaboard Corporation (the Company) including those who are covered by the Lebanon, Pennsylvania and Danville, Illinois bargaining agreements. Employees covered by the Lebanon, Pennsylvania bargaining agreement are required to complete one year of service or work 1,000 hours to be eligible to participate, while employees not under the bargaining agreement and under the Danville, Illinois bargaining agreement are required to complete at least one hour of service to be eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

An employee becomes a participant in the Plan on the earlier of January 1 or July 1 following the date eligibility requirements are met. If the employee does not make an affirmative or negative election to participate, they will be automatically enrolled in the Plan.

Contributions

Each year, participants may contribute up to maximum limits under the Internal Revenue Code (IRC) of pre-tax annual compensation and post-tax (Roth) annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. If the participant fails to provide such direction, including those participants automatically enrolled in the Plan, contributions are invested in the appropriate Target Date Fund based on the participant's birth date and retirement age of 65. The Plan includes an auto-enrollment provision, whereby all employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Participants that are automatically enrolled in the Plan will be deemed to have elected a salary deferral contribution of 3% of eligible compensation, which increases yearly by 0.5% in subsequent years to a maximum of 6% for all participants not under the Lebanon, Pennsylvania bargaining agreement. For all active participants not under the Lebanon, Pennsylvania bargaining agreement, the Company makes a safe harbor nonelective contribution in the amount of 3% of the compensation. Additionally, for participants not under the Lebanon, Pennsylvania bargaining agreement, the Plan also allows for employer matching contributions, which in 2024 and 2023 was equal to 50% of total employee contributions up to 6% of eligible compensation, as defined by the plan document. For participants under the Lebanon, Pennsylvania bargaining agreement, the Company makes a qualified nonelective contribution for the greater of \$390 or 4.5% of eligible compensation. Effective October 1, 2024, the qualified nonelective contribution for the participants under the Lebanon, Pennsylvania bargaining agreement was amended to be in line with the safe harbor nonelective contribution and the employer matching contributions for participants not under the Lebanon, Pennsylvania bargaining agreement. The Plan allows a discretionary profit sharing contribution. There was no profit sharing contribution in 2024 and 2023. Contributions are subject to certain IRS limitations.

Note 1 - Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of (a) the Company's profit-sharing contribution, (b) plan earnings, and (c) forfeitures of terminated participant's nonvested accounts. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, qualified nonelective contributions, and safe harbor nonelective contributions. Employer matching and profit sharing contributions vest based on years of service and are fully vested after three years of service. Employees covered by the Lebanon, Pennsylvania bargaining agreement are immediately 100% vested in all contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan terms may be greater. Borrowings are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a distribution in the form of a lump-sum amount or as an annuity. In addition, the Plan allows for in-service and hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,961 and \$20,656, respectively. These accounts will be used to pay administrative expenses or to reduce future employer contributions. During 2024 and 2023, \$20,556 and \$-0-, respectively, of forfeited nonvested accounts were used to reduce employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Investments

Effective June 10, 2023, the Plan's assets and liabilities, including cash, investments, accrued income, and notes receivable from participants, previously held by Fulton Bank, N.A. (the trustee of the Plan), were transferred to Matrix Trust Company (the custodian of the Plan). This information held at December 31, 2024 and 2023, as well as net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified and complete by Fulton Bank, N.A for the period January 1, 2023 through June 9, 2023 and by Matrix Trust Company for the period June 10, 2023 through December 31, 2024.

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds: Reported at cost, which approximates fair value.

Common Stocks: Valued at closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company has adopted a nonstandardized pre-approved profit sharing plan that was sponsored by Fulton Bank, N.A. The nonstandardized pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the prototype plan was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Fulton Bank, N.A., the trustee of the Plan, and Matrix Trust Company, the custodian of the Plan, provide recordkeeping services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping, investment management, and custody services are immaterial.

Note 9 - Delinquent Participant Contributions

During 2024, the plan sponsor inadvertently failed to deposit \$590,993 of participant deferrals and loan repayments within the required time frame as stated by the United States Department of Labor regulations. The plan sponsor made the corrective deposit in 2024 and reimbursed the Plan for lost interest in 2025. The plan sponsor plans to file Form 5330 and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

During 2023, the plan sponsor inadvertently failed to deposit \$526,058 of participant deferrals and loan repayments within the required time frame as stated by the United States Department of Labor regulations. The plan sponsor made the corrective deposit in 2023 and reimbursed the Plan for lost interest in 2024. The plan sponsor plans to file Form 5330 and pay the applicable excise tax in 2024. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

Note 10 - Subsequent Events

Plan management has evaluated subsequent events through October 15, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
