## INDEPENDENT AUDITOR'S REPORT

#### DESCRIPTION OF PLAN

The following description of the Unity Hospice 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan for the benefit of eligible employees of Unity Hospice and Palliative Care Foundation, Inc., Unity Hospice Management, Inc., Unity Hospice LP, Unity Hospice of Chicagoland, LLC, Unity Hospice of Greater St. Louis, LLC, Unity Hospice of Western Illinois, LLC, Unity Hospice of Northwest Indiana, LLC, Unity Hospice GSL, LLC, Trilogy Hospice LLC (d/b/a Unity Hospice), Hospice Tools, H.T. Professional Services, LLC; and Unity Hospice of Greater Madison, LLC (collectively the "Company") who have one year of service and are 21 years or older. The Plan was formed in 2024, and it was funded by a transfer of assets from the multiple-employer Tandem HR, LLC 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustee is responsible for oversight of the Plan.
2. Contributions - Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

The Company makes a safe harbor matching contribution equal to 100% of employee salary deferrals that do not exceed 3% of the participant's compensation plus 50% of their salary deferrals between 3% and 5% of the participant's compensation. The Company also has the right to make additional contributions to be allocated to participants pro-rata based on compensation. No additional matching or discretionary profit-sharing contributions were made for 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Code (IRC).

3. Participants' Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting - Participants are immediately vested in their employee directed, rollover, and employer safe harbor accounts plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.
5. Investment Options - Upon enrollment in the Plan, each participant directs the investment of all amounts allocated to their account based on the list of investment alternatives available under the Plan.
6. Notes Receivable from Participants - Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested portion of their account balance or \$50,000. Loans provide for periodic repayment over a period of five years or less unless the loan is in connection with the participant's principal residence. The interest rates and types of collateral required are contained in the Plan document. Principal and interest is paid ratably through periodic payroll deductions or by check. All interest paid with respect to these loans is credited to the participant's individual account. Any loss or expense associated with the loan is borne by the participant.
7. Payment of Benefits - Upon eligibility for benefits, the participant may elect one of several methods to distribute the value of a participant's vested account balance, as defined by the Plan. Benefits are recorded when paid. As of December 31, 2024, the vested but unpaid balances of terminated participants amounted to \$677,896.
8. Forfeited Accounts - At the Plan Administrator's discretion, forfeitures may be used to offset Plan administration expenses or to reduce the employer's contributions to the Plan. There were no forfeited funds at December 31, 2024.
9. Administrative Expenses - Investment management services and expenses related to the administration of the Plan are substantially paid by the Plan. The Company absorbs a portion of these expenses.

**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of Accounting:**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

**Cash:**

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed the federally insured limit of \$250,000. The Plan has not experienced any losses in such accounts. The Plan Administrator believes it is not exposed to any significant credit risk on cash

**Investment Valuation and Income Recognition:**

Shares of mutual funds are valued at the daily closing price as reported by those funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis and dividends are recorded on the ex-dividend date.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized gains or losses of those investments. Investment related expenses are included in net appreciation of fair value of investments.

**Notes Receivable from Participants:**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America have established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. See the *Summary of Significant Accounting Policies* note for a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024.

The valuation methods described in the *Summary of Significant Accounting Policies* note may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could

materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**RELATED PARTY TRANSACTIONS**

Certain employees of the Company provide accounting and administrative services to the Plan. These employees do not receive any compensation from the Plan for their services. Also certain administrative expenses were paid by the Company on behalf of the Plan and were excluded from these financial statements.

**INCOME TAX STATUS**

The Company adopted the FIS Capital Markets US LLC Non-Standardized Pre-Approved Profit-Sharing Plan and obtained its latest opinion letter dated December 31, 2018 in which the Internal Revenue Service stated the prototype plan, as then designed, was acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and believes the Plan was qualified and related trust was tax-exempt as of the financial statements date.

Generally accepted accounting principles in the United States of America requires that Plan management evaluate each tax position taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not (i.e., a likelihood of more than 50%), based on the technical merits, would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. Accordingly, the Plan has recognized no interest and penalties associated with any liability for unrecognized tax benefits. The Plan's policy is to record such amounts, if any, as income tax expense. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
