NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Gravity IT Resources 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Gravity IT Resources 401(k) Plan (the “Company” or the “Employer”), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Benefit Trust Company (the “qualified institution”). Effective January 1, 2022, the Plan was amended and restated to comply with laws and regulations.

Participant Contributions – The Plan has adopted automatic enrollment for all employees. Employees are automatically enrolled in the Plan at a deferral rate of 2% with contributions being directed into an age appropriate fund if they have not opted out or made alternative elections. Participants may contribute up to 100% of their annual eligible compensation, as defined by the Plan, and may designate a portion of their contributions as Roth 401(k) contributions. The Plan allows participants who have attained the age of 50 before the end of the Plan year to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and contribution plans.

Employer Contributions – The Plan allows for employer nonelective contributions. Employees become eligible once they are eligible to participant in the Plan. There was no employer contributions for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of the Company’s contributions and Plan earnings and charged with participant distributions and an allocation of administrative expenses. Allocations are based on participant earnings, deferrals, or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time, subject to such restrictions and procedures as established by the recordkeeper, the Plan, and the Company.

Vesting – Participants are immediately vested in their deferral contributions, employer nonelective contributions and rollovers, plus or minus any earnings or losses thereon.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Notes shall be repaid within five years unless the note is for the purchase of a primary residence in which case the repayment period may not extend beyond 10 years. Borrowings are secured by the balance in the participant’s account and bear a reasonable rate of interest as determined by the administrator based on prevailing interest rates, fixed at the inception of the loan. The notes are collateralized by the participants’ vested interest in their account balance. As of December 31, 2024, the interest rate on outstanding loans ranges from 9.25% to 9.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Note 1—Description of the Plan (continued)

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount, equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are allowed in-service withdrawals of their participants' vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. Upon termination of employment, a participant is entitled to the entire participant's account balance, which includes all of the vested Employer's contributions allocated to the participant's account and all gains or losses attributable thereto. In the event a participant terminates or retires, and the participant's vested account balance is less than \$1,000, the balance will be paid out as a lump-sum distribution at the discretion of the Company. Participants should refer to the Plan documents for a full description of the distribution methods offered by the Plan.

Hardship Distribution – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the Internal Revenue Code ("IRC") Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the Internal Revenue Service ("IRS") deems an immediate and financial need of the participant.

Note 2—Summary of significant accounting policies

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition – Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs that may be used to measure fair value are:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for Plan instruments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These investments are classified as Level 1 in the valuation hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date, and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when they have been processed and paid by the Plan.

Administrative Expenses – Administrative expenses paid directly by the Company on behalf of the Plan include legal fees and accounting fees and are excluded from these financial statements. Expenses paid by the Plan include third party administration fees and investment fees.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution, has certified to the completeness and accuracy of the following information included in the accompanying financial statements and supplemental schedule:

Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

Note 5—Party-in-interest transactions

Certain Plan investments are managed by the qualified institution and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment expenses to third party administration, as well as participant loan fees totaling approximately \$9,086 for the year ended December 31, 2024. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7—Income tax status

The Plan is a Non-Standardized Prototype Plan ("Prototype Plan") adopted by the Company. The Company received an opinion letter from the IRS dated November 18, 2020, which states the Prototype Plan satisfies the applicable provisions of the IRC. The Company and the Plan administrator believe the Plan is designed and operated in compliance with the applicable requirements of the IRC, the Plan and related trust continue to be tax-exempt, and the Plan has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events through October 13, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.

Note 1—Description of the Plan

The following description of the Gravity IT Resources 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Gravity IT Resources 401(k) Plan (the “Company” or the “Employer”), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Benefit Trust Company (the “qualified institution”). Effective January 1, 2022, the Plan was amended and restated to comply with laws and regulations.

Participant Contributions – The Plan has adopted automatic enrollment for all employees. Employees are automatically enrolled in the Plan at a deferral rate of 2% with contributions being directed into an age appropriate fund if they have not opted out or made alternative elections. Participants may contribute up to 100% of their annual eligible compensation, as defined by the Plan, and may designate a portion of their contributions as Roth 401(k) contributions. The Plan allows participants who have attained the age of 50 before the end of the Plan year to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and contribution plans.

Employer Contributions – The Plan allows for employer nonelective contributions. Employees become eligible once they are eligible to participant in the Plan. There was no employer contributions for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of the Company’s contributions and Plan earnings and charged with participant distributions and an allocation of administrative expenses. Allocations are based on participant earnings, deferrals, or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time, subject to such restrictions and procedures as established by the recordkeeper, the Plan, and the Company.

Vesting – Participants are immediately vested in their deferral contributions, employer nonelective contributions and rollovers, plus or minus any earnings or losses thereon.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Notes shall be repaid within five years unless the note is for the purchase of a primary residence in which case the repayment period may not extend beyond 10 years. Borrowings are secured by the balance in the participant’s account and bear a reasonable rate of interest as determined by the administrator based on prevailing interest rates, fixed at the inception of the loan. The notes are collateralized by the participants’ vested interest in their account balance. As of December 31, 2024, the interest rate on outstanding loans ranges from 9.25% to 9.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Note 1—Description of the Plan (continued)

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount, equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are allowed in-service withdrawals of their participants' vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. Upon termination of employment, a participant is entitled to the entire participant's account balance, which includes all of the vested Employer's contributions allocated to the participant's account and all gains or losses attributable thereto. In the event a participant terminates or retires, and the participant's vested account balance is less than \$1,000, the balance will be paid out as a lump-sum distribution at the discretion of the Company. Participants should refer to the Plan documents for a full description of the distribution methods offered by the Plan.

Hardship Distribution – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the Internal Revenue Code ("IRC") Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the Internal Revenue Service ("IRS") deems an immediate and financial need of the participant.

Note 2—Summary of significant accounting policies

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition – Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs that may be used to measure fair value are:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for Plan instruments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These investments are classified as Level 1 in the valuation hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date, and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when they have been processed and paid by the Plan.

Administrative Expenses – Administrative expenses paid directly by the Company on behalf of the Plan include legal fees and accounting fees and are excluded from these financial statements. Expenses paid by the Plan include third party administration fees and investment fees.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution, has certified to the completeness and accuracy of the following information included in the accompanying financial statements and supplemental schedule:

Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Party-in-interest transactions

Certain Plan investments are managed by the qualified institution and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment expenses to third party administration, as well as participant loan fees totaling approximately \$9,086 for the year ended December 31, 2024. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7—Income tax status

The Plan is a Non-Standardized Prototype Plan ("Prototype Plan") adopted by the Company. The Company received an opinion letter from the IRS dated November 18, 2020, which states the Prototype Plan satisfies the applicable provisions of the IRC. The Company and the Plan administrator believe the Plan is designed and operated in compliance with the applicable requirements of the IRC, the Plan and related trust continue to be tax-exempt, and the Plan has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events through October 13, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
