For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the Hunt Forest Products, L.L.C. Salary Investment Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by Hunt Forest Products, L.L.C. (the Company). All employees of the Company and its subsidiaries, Bienville Lumber Company, L.L.C. and Lasalle Lumber Company, L.L.C. who have at least three consecutive months of employment may elect to participate, as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by Hunt Forest Products, L.L.C. (the Plan Administrator and Plan Sponsor). The Plan Administrator determines eligibility for participation and for benefits under the Plan.

#### **Contributions**

Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the plan agreement, subject to certain limitations provided by federal income tax regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect the funds into which their contributions will be invested. All funds in the Plan were held by the Trustee.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. The Company contributes a percentage (Company match) that ranges from 2 percent to 6 percent (based on participant's deferral rate, as defined in the plan agreement) of each participant's compensation. The Company also matches up to 60 percent of catch-up contributions, not to exceed 60 percent of the IRS catch-up contribution limit. These contributions are matched on each respective pay period.

Participants may also contribute roll over contribution amounts representing distributions from other qualified plans.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In accordance with the provisions of the Plan, a participant is 100 percent vested after three years of credited service. Participants are vested immediately in their contributions plus actual earnings thereon.

## Notes to Financial Statements

### Notes Receivable from Participants

Participant notes receivable consist of loans made to participants subject to certain terms and conditions provided in the plan agreement. Under these terms and conditions, participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000, as adjusted under the provisions of the plan agreement, or (2) the greater of \$10,000 or one half of the participant's vested account balance under the Plan. The loans are secured by 50 percent of the participant's account balance and bear interest at the prime rate listed in The Wall Street Journal on the date of the loan plus 1 percent, unless such rate is adjusted by the Plan Administrator under the conditions provided in the plan agreement. The Plan Administrator may at his discretion require additional collateral to adequately secure the loan. Principal and interest are paid not less frequently than quarterly through payroll deductions.

### Payment of Benefits

On termination of service for any reason, employees can elect to receive the balance in their accounts based on the values as of the most recent accounting date that is on or after the date of termination of service. Subject to certain terms and conditions, if no election is made, the balance in the accounts may be held by the Trustee until the earlier of the participant's retirement age, disability, or death. If a terminated participant's balance is less than \$1,000 and they do not request a withdrawal, an automatic payout is made after one year.

### Forfeited Accounts

At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$80,734 and \$17,200, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During 2024 and 2023, Company contributions were not reduced by any amount from forfeited non-vested accounts. During 2024 and 2023, Plan expenses were reduced by \$31,550 and \$9,657, respectively from forfeited non-vested accounts.

### The Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

## Note 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

## Notes to Financial Statements

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in the notes receivable. Fees related to plan distributions are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. All other fees related to the administration of the Plan are paid by the Company.

### **Note 3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, investment income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to Plan management and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees of the Plan.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuities: Valued daily based on the valuation method disclosed in the annuity contract as calculated by the annuity provider.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are provided through Empower Trust Company, LLC, and Empower Annuity Insurance Company of America. Empower Trust Company, LLC, and Empower Annuity Insurance Company of America are the Trustees for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan. Empower is the record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

### **Note 7. Tax Status**

Effective October 1, 2020, the Plan adopted a non-standardized prototype defined contribution profit sharing plan with Internal Revenue Code Section (IRC) 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated October 31, 2017. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Effective January 1, 2024, the Plan adopted a non-standardized prototype defined contribution profit sharing plan with Internal Revenue Code Section (IRC) 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2024. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
