Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Orora Packaging Solutions 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and October 31, 2024, and the related statement of changes in net assets available for benefits for the short year November 1, 2024 to December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and October 31, 2024, and for the short year November 1, 2024 to December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to

be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess

whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Orora Packaging Solutions 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and any amendments for more specific provisions.

A. General

The Plan is a defined contribution plan, most recently restated effective April 1, 2020, adopted by Orora Packaging Solutions and its subsidiaries (the “Company”) to provide benefits to eligible employees as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration and Expenses

Orora Packaging Solutions is the plan administrator. The plan administrator has sole responsibility for the administration of the Plan.

Most administrative expenses are paid by the Plan from forfeitures or participant accounts. There were no forfeitures used to offset expenses in the short year November 1, 2024 to December 31, 2024. Investment expenses are netted against investment income.

C. Eligibility

The Company’s non-union employees are eligible to participate in the Plan on the date of hire.

D. Participant Contributions

Participants may contribute up to 60% of their eligible wages on a pre-tax basis, subject to the Internal Revenue Code (the “Code”) limitations. The Plan allows after-tax Roth contributions. In addition, the Plan allows participants over the age of 50 to make catch-up contributions. Upon completion of 60 days of employment, participants who haven’t affirmatively elected deferral contributions or elected not to make deferral contributions are automatically enrolled at a deferral rate of 6% of compensation. Automatic compensation deferral contributions are invested in the default investment fund until the participant elects otherwise.

The Plan permits participants to make rollover contributions, excluding after-tax contributions, from other qualified plans.

E. Company Contributions

The Company may make discretionary profit sharing contributions, as defined in the Plan. For the short year November 1, 2024 to December 31, 2024, the Company did not make profit sharing contributions.

From November 1, 2024 to December 31, 2024, the Company made matching contributions of 50% of each employee's deferrals limited to 6%, of the employee’s eligible compensation.

F. Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers, Company profit sharing contributions and an allocation of Plan earnings. Earnings or losses are allocated to the participants’ accounts based on the proportion each account bears to the total of all account balances within each investment fund. Plan assets are invested among Plan investment options based on participant instructions.

G. Vesting

Participants are always 100% vested in their deferral contributions, rollover contributions, and earnings thereon. Participants are vested in the Company's profit-sharing contributions based upon their years of credited service, through March 31, 2020, according to the following schedule:

Effective April 1, 2020, participants are vested in the Company's profit-sharing and non-safe harbor matching contributions based upon their years of credited service according to the following schedule:

H. Forfeitures

Forfeitures of non-vested accounts may be used to reduce future profit sharing contributions or to pay administrative expenses. As of December 31, 2024 and October 31, 2024, respectively, \$142,091 and \$120,472 were included in Plan assets; \$0 was used to offset Company contributions for the short year November 1, 2024 to December 31, 2024.

I. Payment of Benefits

Upon termination of service, death, disability, retirement or attainment of age 59½, a participant may elect to receive benefits equal to the value of the vested interest in his or her account. Normal retirement age is 65. Participants elect to receive benefits from among one of the payment options offered under the Plan including lump sum payments. Hardship distributions are permitted from participants' elective deferral accounts under limited circumstances, as defined in the Plan. Benefits are recorded when paid.

J. Notes Receivable from Participants

The Plan allows participants to borrow up to 50% of their vested account balances, but not less than \$1,000 or more than \$50,000. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless a loan is used for the purchase of a principal residence, in which case the maximum repayment period is 20 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

C. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Common/collective trusts are valued at net asset value. Shares may be redeemed any time. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trusts. Purchases and sales of investments are recorded on the trade-date basis. Interest and dividends are recorded on the accrual basis.

D. Risks and Uncertainties

The Plan holds a variety of investments that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Plan is a Schwab Retirement Plan Services, Inc. non-standardized 401(k)/profit sharing plan prototype plan adopted by the Company effective November 1, 2016. The underlying prototype plan document has received an opinion letter from the Internal Revenue Service stating that it is qualified under Section 401(a) of the Code. The Plan has since been amended. However, the Company believes the Plan is designed and currently being operated in compliance with the Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. Upon termination of the Plan, participants will become 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investment manager, Russell Investments, or related entities, manage certain investment options offered under the Plan. Transactions in these funds, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 7 - PLAN AMENDMENT

The Plan was amended and restated as of November 1, 2024 to change the Plan's year end to December 31.

NOTE 8 - SUBSEQUENT EVENTS

On January 1, 2025, Orora Packaging Solutions was bought out by Veritiv Operating Company, adding additional participating employers.

Management has evaluated subsequent events through October 14, 2025, the date on which these financial statements were available to be issued. Other than noted above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
